1 LOMBARDO: Morris, the reason why I'm here, you  
2 don't know who I am.  
3  
4 SHENKER: I'm...  
5  
6 LOMBARDO: My name is Joey.  
7  
8 SHENKER: I'm, I'm assuming you're all right, if  
9 you're with Allen.  
10  
11 LOMBARDO: That's right. That's right. Okay. Here's  
12 the reason why.  
13  
14 SHENKER: (UI)  
15  
16 LOMBARDO: Allen belongs to Chicago. Now you know  
17 what I mean when he belongs to Chicago?  
18 I was sent here to find out what the  
19 story is. When they talk to Allen, he  
20 says he don't get this, he don't get  
21 this, he got this, he got this coming.  
22 It's 12 years - they're tired of  
23 listening to this bullshit, that he  
24 don't have this and Morris is this and  
25 Morris is that.  
26  
27 SHENKER: Okay, you...  
28  
29 LOMBARDO: You know where you belong, I mean,  
30 excuse me, you know where you belong,  
31 and he knows where he belongs and the  
32 other guy knows where he belongs - we  
33 all belong to certain people, to account  
34 to - it's a big world. And that's what  
35 I'm here for is to listen. And the word  
36 is that Morris says this and Morris says



1 that, Morris says...and that's why I  
2 say, now what you say you got coming,  
3 you don't got coming...now' you're here.  
4 According to what I se...hear you say.  
5  
6 SHENKER: Never did to IJK, Nevada?  
7  
8 LOMBARDO: Now, it's getting to the point now where  
9 you either gonna shit or get off the  
10 pot, ya know what I mean? We either get  
11 what we got coming or we don't get what  
12 we got coming.  
13  
14 SHENKER: Well.  
15  
16 LOMBARDO: If we got something coming we want it.  
17 If we don't have it coming, we don't  
18 want it.  
19  
20 SHENKER: Well, I, I can only tell you what he has  
21 coming (UI).  
22  
23 LOMBARDO: Good, well, I, what he's got coming, the  
24 people in Chicago got coming.  
25  
26 SHENKER: Well, that's between you fellas.  
27  
28 LOMBARDO: I know that, dick.  
29  
30 SHENKER: You know what I mean, but, I can tell  
31 you what, what ah, what, what happened  
32 is that IJK, Nevada was never involved  
33 in any of this. If you'd recall that  
34 came way later. IJK, Nevada didn't come  
35 until 1972, 73, and I can tell you who  
36 had the money, who put the money up, how  
37 the money was put up. It has absolutely  
38 nothing to do with Penasquitos. Not this  
39 much.

2 LOMBARDO: Well, that's up to the people here to  
3 decide. Ya know what I mean? You have to  
4 find a way to pay it. They'll decide  
5 what to do. I'm just go back with the  
6 message. I just...  
7  
8 SHENKER: No one is telling me what to do. I never  
9 did business with them. Let me tell you  
10 something.  
11  
12 LOMBARDO: What?  
13  
14 SHENKER: You know, I'm the nicest guy in the  
15 world, but on the other hand, nobody is  
16 going to make me do anything. I never  
17 did business with them.  
18  
19 LOMBARDO: That's true.  
20  
21 SHENKER: I did business with Hoffa...(UI)  
22  
23 LOMBARDO: That's true.  
24  
25 SHENKER: I did business with Hoffa and Hoffa said  
26 you and they know? And that's it.  
27  
28 LOMBARDO: But, Morris, I'm just, I'm just here to  
29 listen to it and bring back...  
30  
31 SHENKER: ...(UI)  
32  
33 LOMBARDO: Excuse me. I'm just here to bring a  
34 message back. And what I think is what  
35 and what's, what and let me tell you  
36 something. If they make a decision and  
37 they tell me to come back and bring you  
38 a message to pay, you can fight the  
39 system if you wanna, but, I'll tell you  
40 one thing. You say you're 72, and you  
41 defy it, all you can do is send a guy  
42 like me to jail, one guy.  
43  
44 SHENKER: I'm not going to send anybody to jail.  
45  
46 LOMBARDO: But, excuse me, but you ain't gonna send  
47 the system to jail.

2 SHENKER: I'm not going to send anybody to jail.  
3  
4 LOMBARDO: I'm just tellin' ya, I'm just tellin' ya  
5 (raising his voice). If they come back  
6 and tell me to give you a message and if  
7 you want to defy it, I assure you that  
8 you will never reach 73.  
9  
10 SHENKER: So what?  
11  
12 LOMBARDO: Ah...ah...  
13  
14 SHENKER: So what?  
15  
16 LOMBARDO: I mean, it's your perogative.  
17  
18 SHENKER: I'm not going to go out and steal to  
19 give 'em, give anybody the money.  
20  
21 LOMBARDO: No, but, 'all they're asking for is what  
22 is coming to them.  
23  
24 SHENKER: Well, ... (UI) ... coming.  
25  
26 LOMBARDO: Better to wait... true. This is true. And  
27 if they got something coming, they'll  
28 tell it to you. Is that right? There's  
29 no argument there.  
30  
31 SHENKER: From me, they've got nothing coming.  
32  
33 LOMBARDO: True.  
34  
35 SHENKER: I did no business with them.  
36  
37 LOMBARDO: We're speaking about Allen having  
38 something coming.  
39  
40 SHENKER: Well, then it's his business, you see?  
41 ... (UI) ...  
42  
43 LOMBARDO: Well, well we got a piece of, they got a  
44 piece of Allen. If Allen can't get it,  
45 they'll reach out and get it for him.

47 SHENKER: (UI).

1 LOMBARDO: Allen's not that type of guy. But the  
2 people that got a piece of him are that  
3 type of guy. Allen is meek and Allen is  
4 harmless. But the people behind him are  
5 not meek and harmless. Do you know what  
6 I mean?  
7  
8 SHENKER: Sure.  
9  
10 LOMBARDO: And if they got, and if he's got  
11 something coming, they got a piece of  
12 him and they're gonna fight to get it.  
13 And you can not blame them.  
14  
15 SHENKER: Well, I'm not going to make a comment on  
16 that... (UI).  
17  
18 LOMBARDO: You know, you're a lawyer, you've been  
19 around St. Louis a long time.  
20  
21 SHENKER: Yeah, a long time.  
22  
23 LOMBARDO: You got a place to go for help, ya know  
24 what I mean?  
25  
26 SHENKER: Well, I don't think I, I need any help.  
27  
28 LOMBARDO: Well, if you don't need it, listen, if  
29 you don't owe nothing, you got nothing  
30 to worry about.  
31  
32 SHENKER: When I owe, I pay.  
33  
34 LOMBARDO: There's, there's no problem, you have no  
35 problem.  
36  
37 SHENKER: When I owe, I pay.  
38  
39 LOMBARDO: You will reach 73 then, there's no  
40 problem. Listen.
