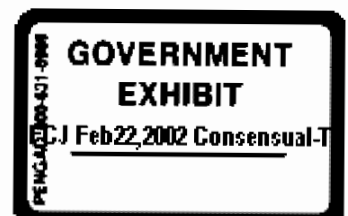

1 FRANK, JR.: You look like a cowboy.

3 DIFAZIO: Yeah. What's up?
4
5 FRANK, JR.: Not too much. I was suppose to get a
6 hold of ya a couple weeks ago. Ah, I

35 DIFAZIO: ...you know, I, I that's, that I'm in
36 the fuckin' middle here doing the, the
37 fuckin' stuff.

39 FRANK, JR.: Like me, I know.

1 DIFAZIO: You know what I mean. And I don't mind
2 doin' it because I knew both parties.
3
4 FRANK, JR.: Right. It doesn't...
5
6 DIFAZIO: It, it never worried me, but when you
7 add somebody to the mix.
8
9 FRANK, JR.: ...yes definitely...
10
11 DIFAZIO: ...to your family, you add somebody to
12 the mix, I can't get to feel comfortable
13 and (UI). All I can say is that what
14 Jimmy told me is that, he made a promise
15 to him, I guess.
16
17 FRANK, JR.: Right.
18
19 DIFAZIO: In that he would fulfill it, but I'm not
20 gonna see anybody so I don't know if he
21 wants to do it once a year.
22
23 FRANK, JR.: Well, I mentioned to him, why don't you
24 just keep track until you get home.

26 DIFAZIO: Right.
27
28 FRANK, JR.: And then...

30 DIFAZIO: And then...

32 FRANK, JR.: ...and (UI)...
33
34 DIFAZIO: ...right, that's it. Just, just you
35 know, if (UI).

37 FRANK, JR.: So, I'll tell him that again, you don't
38 have a problem with that either.

40 DIFAZIO: No. Jimmy made, Jimmy says you just
41 tell the (UI) that I made a promise to
42 him and that he's gonna fulfill that
43 there 'cause he's gonna do it on his
44 own. You know what I mean?

48 DIFAZIO: The other way you can't do it, 'cause

1 FRANK, JR.: Right.
2
3 DIFAZIO: ...kids, kids are takin' over. His son
4 is taking over and they sold part of the
5 company to ah, to ah, some other people,
6 some investors...
7
8 FRANK, JR.: Right.
9
10 DIFAZIO: ...you know Jimmy's not even gonna be
11 there.
12
13 FRANK, JR.: Right.
14
15 DIFAZIO: You know, so he has, I mean things
16 change (UI). It's been a long time and
17 things change, you know, so...
18
19 FRANK, JR.: Oh, yeah. Sure. Okay. You know I'll
20 tell him that.
21
22 DIFAZIO: ...he knows, he knows Jimmy's a man of
23 his fuckin' word, so...
24
25 FRANK, JR.: Right.
26
27 DIFAZIO: ...he's that, you know.
28
29 FRANK, JR.: He don't wanna put you in the middle
30 either, you know. But I'll tell him.
31
32 DIFAZIO: It's not me.
33
34 FRANK, JR.: I know. I understand what your (UI)...
35
36 DIFAZIO: It, it, doesn't really matter to me too
37 much, but I don't wanna see another guy.

39 FRANK, JR.: I, I, I, that's, I told him I don't
40 wanna see, I don't even wanna come down
41 in this neighborhood. Okay.
42
43 DIFAZIO: Right. You know, I don't wanna see
44 anybody else. I mean, it's been quiet
45 for fuckin' forever.
46
47 FRANK, JR.: So that's what he wanted to know. He
48 wanted to make sure, he wanted to know
49 who was bothering you because he put
50 word out here. But he wanted to know

1 who was bothering you to make sure that
2 he put words to the right people.
3
4 DIFAZIO: Well it was the same fuckin' crew that
5 they just, you know, that the same crew
6 the one that got...the guy that got hurt
7 in Lyons or somethin'.
8
9 FRANK, JR.: Oh, okay.
10
11 DIFAZIO: You know...
12
13 FRANK, JR.: Oh, it's okay. So then, he's in the

17 right spot. Nobody's bothering me
18 personally, they just, because I'm
19 associated with the gov...they fuckin'

40 DIFAZIO: You know everybody thinks I own the
41 fuckin' company.
42
43 FRANK, JR.: Well, he had said when I seen him that
44 day when you were there. He said it was
45 being taken care of, but find out just
46 to make sure, so...and then he was in
47 the right area.

1 DIFAZIO: You know when I go see the other guy and
2 I never tell him anything.
3
4 FRANK, JR.: Right, right.
5
6 DIFAZIO: I never tell him everything.
7
8 FRANK, JR.: Well, I mentioned to him that...
9
10 DIFAZIO: I never tell the other guy, hey. The
11 other guy's my friend. He's a relative.
12 I fuckin' grew up with him. You know
13 what I mean?
14
15 FRANK, JR.: Oh, definitely.
16
17 DIFAZIO: So I go, I've been goin' by him for
18 years, you know.
19
20 FRANK, JR.: Right.
21
22 DIFAZIO: It's got nothin' to do with one thing.
23 He got nothin' to do with it, and I
24 never fuckin' ask ya for nothin'.

26 FRANK, JR.: Right.
27
28 DIFAZIO: I never asked him for nothin', you know,
29 since I've known him.

31 FRANK, JR.: Right.
32
33 DIFAZIO: You know. So...
34
35 FRANK, JR.: Alright. Well I just wanted you to know
36 that.
37
38 DIFAZIO: ...but anyway, just ah...let me know
39 what the sch...try to get it 'cause
40 before somebody comes to me and I can't
41 tell them no. You know what I mean?

43 FRANK, JR.: Yeah. Yeah. I'll get a message back to
44 'em (UI) right now.

46 DIFAZIO: Right. Right.
47
48 FRANK, JR.: And, ah...

2 DIFAZIO: Just tell him that the promise is gonna
3 be kept. You know.
4
5 FRANK, JR.: I mentioned the same thing to him. So,
6 you know, he...and it sounded like he
7 was, it didn't sound like a bad idea to
8 him knowing that the way he knows Jimmy.
