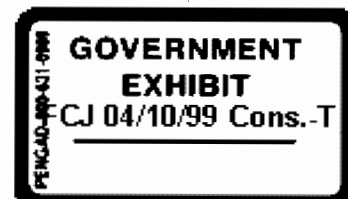

15

19
20 CALABRESE, SR.: Oh yeah, I drink that tea.
21
22 FRANK, JR.: I use two of 'em out of there when I
23 have a sore throat, so and then the
24 blanket...

26 CALABRESE, SR.: Yeah, you don't drink tea.
27
28 FRANK, JR.: I was, but ahm, you know if I'm going
29 soon, I don't want to carry that much
30 and it's open and they might not let me
31 take it because it's open, you know, so
32 I figured you could take it.
33
34 CALABRESE, SR.: Yeah, I...
35



1 FRANK, JR.: I only drink it when I don't feel good,
2 that's all.
3
4 CALABRESE, SR.: Well sometimes I drink it ah, I'll have
5 a couple of glasses during the week, and
6 ah, I enjoy it, I really do. There was
7 nothing new Frankie, they, he hasn't
8 heard nothing, there's nothing been
9 going around.
10
11 FRANK, JR.: Well that's good.
12
13 CALABRESE, SR.: He don't like Uncle Nicky.
14
15 FRANK, JR.: Oh no?
16
17 CALABRESE, SR.: No, 'cause, because of him hearing what
18 he heard, he says, if I hear him say
19 that again Frank, I'm going to lay it on
20 him. I said, you don't, touch him Twan.
21 I says listen to what I tell you, just
22 let him shoot his mouth off and you let
23 me know, that's all, I says, don't touch
24 him. He says, I can't stand him and I
25 don't like Jimmy. He says I...

27 FRANK, JR.: Does he know him?
28
29 CALABRESE, SR.: Sure, he met him by Toots' house.

31 FRANK, JR.: Oh, okay.

19 FRANK, JR.: Right.
20
21 CALABRESE, SR.: Uh, he gave, uh, Ronny the message about
22 Jimmy. He says, don't do nothing.
23 Don't, don't send nobody to see Sister.
24 Sister.
25
26 FRANK, JR.: Oh.
27
28 CALABRESE, SR.: You know, Brother, Sister.
29
30 FRANK, JR.: Yeah.
31
32 CALABRESE, SR.: Don't send nobody to go see the sister
33 that's sick. Don't have nobody see her.
34 Just leave it go till...
35
36 FRANK, JR.: I'm lost.
37
38 CALABRESE, SR.: ...we find out some more of what's goin'
39 on.
40
41 FRANK, JR.: I'm...
42
43 CALABRESE, SR.: My brother.
44
45 FRANK, JR.: Oh Uncle Nicky.
46

1 CALABRESE, SR.: Yeah.
2
3 FRANK, JR.: Oh, okay.
4
5 CALABRESE, SR.: Yeah. 'Cause he was gonna go see
6 Mickey.
7
8 FRANK, JR.: Okay.
9
10 CALABRESE, SR.: Jimmy's brother.
11
12 FRANK, JR.: Okay. So, it was gonna go all the way?
13
14 CALABRESE, SR.: Yeah. So he, so he stopped it. I
15 stopped it on the phone that day. I
16 says leave it go right now. That girl,
17 just leave it go, that girl, don't,
18 don't have her go to that doctor. Just
19 hold off until, see if she's feeling
20 better. So, then he stopped it. He
21 knew what I meant. So he didn't go and
22 then he told Ronny just what I said. He
23 says, he don't want nothing done right
24 now. He wants to wait to see what the
25 outcome is more. 'Cause we may, what we

9
10 FRANK, JR.: Joy? He don't know nothin'.
11
12 CALABRESE, SR.: No. We haven't, nobody's told him (UI).
13 Not that we know of.
14
15 FRANK, JR.: Yeah, we know of.
16
17 CALABRESE, SR.: That we know if we don't know. You
18 know? We don't know what's been said.
19 We don't know if Poker said anything.
20 You know? Sent word to him or anything.
21 Poker. Like, you know, that they may
22 be investigatin' you or somethin'. You
23 don't know that. But if you did, he, if
24 he did, he's got Uncle Nicky's ass
25 twitchin', you could bet.
26
27 FRANK, JR.: Not if he didn't hear nothin'. Then.
28
29 CALABRESE, SR.: No. Nothing. I'm, I'm (PAUSE) (UI)...
30
31 FRANK, JR.: ...What message went to ah Apes about
32 Poker, right? So he knows. Or no.
33
34 CALABRESE, SR.: No. We're holdin' back on that.
35
36 FRANK, JR.: Oh.
37
38 CALABRESE, SR.: We're holdin' back on that because Poker
39 has got his ear.
40
41 FRANK, JR.: What about it? So Tootsie Babe so
42 nobody knows.
43
44 CALABRESE, SR.: Oh, yeah.
45
46 FRANK, JR.: Well Tootsie Babe...
47

1 CALABRESE, SR.: Oh, yeah.
2
3 FRANK, JR.: ...knows.
4
5 CALABRESE, SR.: They all know.
6
7 FRANK, JR.: Oh, okay.
8
9 CALABRESE, SR.: Oh, they know.
10
11 FRANK, JR.: But just, Johnny don't know because
12 he's...
13
14 CALABRESE, SR.: Right.
15
16 FRANK, JR.: ...Poker, that's what, that's good then,
17 because that's I says. I says he's
18 probably got his ear...
19
20 CALABRESE, SR.: Yeah.
21
22 FRANK, JR.: ...you know.
23
24 CALABRESE, SR.: So we're waiting to see. And if
25 anything happens to Johnny then, uh, no
26 matter what position he is, it ain't
27 gonna make no fuckin' difference then.
28 But the thing is, we're not lookin' to
29 stir up anything.
30
31 FRANK, JR.: Right.
32
33 CALABRESE, SR.: And, uh, eh, sometimes if you let a
34 problem hang, that person's gonna hang
35 themselves. First of all, he can't put
36 me there because he wasn't there.
37
38 FRANK, JR.: Right.
39
40 CALABRESE, SR.: He don't know the details. It's only a
41 hearsay of what he heard.
42
43 FRANK, JR.: Right.
44
45 CALABRESE, SR.: And if he heard, who's to hearsay?
46 Bring it forward. Okay?
47

1 FRANK, JR.: But, can't he put you--oh, but he's
2 involved. I was gonna say, he could put
3 you with that other one with the
4 innocent...
5
6 CALABRESE, SR.: Put me...
7
8 FRANK, JR.: ...guy...
9
10 CALABRESE, SR.: ...with a few. But I was, I was always
11 drivin'.
12
13 FRANK, JR.: Okay.
14
15 CALABRESE, SR.: I was never near the car. I was always
16 watching.
17
18 FRANK, JR.: Oh, okay. So, so the one in Cicero
19 then, he, he actually did with Uncle
20 Nick. So you were drivin', so he can't
21 say nothin' there because he'd get in
22 more trouble than you.
23
24 CALABRESE, SR.: Right. Because they, he was the one and
25 Uncle Nicky were the ones that got outta
26 the car.
27
28 FRANK, JR.: And they...
29
30 CALABRESE, SR.: I was the one talkin' to them. Alright
31 guys, here's what you gotta do here.
32 Okay, now, out. Out. Out. Get out.
33 (LAUGHS)
34
35 FRANK, JR.: And they wouldn't get out?
36
37 CALABRESE, SR.: Yeah. They were like hesitant for a
38 minute, you know. Out. Now, now, now.
39 That's the one in Cicero where...
40
41 FRANK, JR.: Right.
42
43 CALABRESE, SR.: ...Yeah.
44
45 FRANK, JR.: You said where the innocent...
46
47 CALABRESE, SR.: Yeah, they...
48

1 FRANK, JR.: ...a Polish guy or somethin'.
2
3 CALABRESE, SR.: Yeah. And, uh, I said, take your time
4 now. Don't rush. Walk up to that car.
5
6 FRANK, JR.: And did they know that the guy in the
7 passenger--or the other guy was innocent
8 or no?
9
10 CALABRESE, SR.: They knew...
11
12 FRANK, JR.: Just.
13
14 CALABRESE, SR.: ...he was innocent, but Frankie, he
15 happened to be at the, eh...
16
17 FRANK, JR.: Wrong place at the wrong...
18
19 CALABRESE, SR.: We worked on that guy for nine months.
20
21 FRANK, JR.: Really?
22
23 CALABRESE, SR.: We had the guy one time by his house.
24 Poker chickened out. (UI).
25
26 FRANK, JR.: Oh, that's, oh, okay. That's when he
27 chickened out when...
28
29 CALABRESE, SR.: That's when I told Nicky, I says, why
30 the fuck didn't you leave him there
31 after--get the other guy first then
32 leave him too.
33
34 FRANK, JR.: That's not the dope dealer guy was it?
35
36 CALABRESE, SR.: Huh?
37
38 FRANK, JR.: That you told me about that time?
39 'Cause I remember you tellin' me about
40 that when you...
41
42 CALABRESE, SR.: Yeah.
43
44 FRANK, JR.: ...came home. I was young. That was a
45 long time about wasn't it?
46
47 CALABRESE, SR.: He was a dope dealer and he was, uh, he
48 was, he was lendin' money out on his

1 own. He, he belonged to Johnny at one
2 time. He was...
3
4 FRANK, JR.: He was Mexican.
5
6 CALABRESE, SR.: ...Mexican.
7
8 FRANK, JR.: I remember you tellin' me when we lived
9 in the apartment...
10
11 CALABRESE, SR.: Yeah.
12
13 FRANK, JR.: ...I remember, you told me and I was
14 just like, it was the first time...
15
16 CALABRESE, SR.: We used...
17
18 FRANK, JR.: ...you told me, I was...
19
20 CALABRESE, SR.: ...we used...
21
22 FRANK, JR.: ...kinda shocked.
23
24 CALABRESE, SR.: ...to call 'em half and half, because he
25 was half Mexican and half somethin'
26 else.
27
28 FRANK, JR.: Oh, okay.
29
30 CALABRESE, SR.: And, uh, where he got it, his friends
31 were sittin' right across the street.
32
33 FRANK, JR.: Oh really?
34
35 CALABRESE, SR.: His friends were sittin' on a bench
36 across the street. They couldn't even
37 describe the car. Because you see how
38 confusing things are when people...
39
40 FRANK, JR.: Oh, yeah.
41
42 CALABRESE, SR.: ...get scared?
43
44 FRANK, JR.: Yeah. Sure. I remem...
45
46 CALABRESE, SR.: And he, the guy, they were pullin' over
47 to park to go across the street.
48

1 FRANK, JR.: Oh, okay.
2
3 CALABRESE, SR.: Alright? As they pulled, I pulled with
4 'em.
5
6 FRANK, JR.: Diagonal?
7
8 CALABRESE, SR.: Yeah. Diagonal, like this. But I left
9 room...
10
11 FRANK, JR.: Like, like on, on...
12
13 CALABRESE, SR.: ...I left room...
14
15 FRANK, JR.: ...Twenty-second...
16
17 CALABRESE, SR.: ...for me to...
18
19 FRANK, JR.: ...where you...
20
21 CALABRESE, SR.: ...get out.
22
23 FRANK, JR.: ...pull on an angle or...
24
25 CALABRESE, SR.: Yeah. Right off of Laramie there you
26 could park like this on, on Twenty-
27 second.
28
29 FRANK, JR.: Right. Okay.
30
31 CALABRESE, SR.: So when I let--when I got out, I made
32 sure, when they got out, I made sure
33 that I didn't have to back out, that you
34 turn right out...
35
36 FRANK, JR.: Oh, okay. I understand what you're
37 sayin'.
38
39 CALABRESE, SR.: So I'm...
40
41 FRANK, JR.: So like, you were like the last space.
42
43 CALABRESE, SR.: No. No.
44
45 FRANK, JR.: Oh, there was nobody.
46
47 CALABRESE, SR.: No. I'm takin', there's nobody next to
48 me.

1
2 FRANK, JR.: Okay.
3
4 CALABRESE, SR.: This was done in a matter of seconds.
5 I'm shielding them from the street so
6 nobody could see what they're doin'.
7 Here's them. Here's us. See this?
8 Just like this...
9
10 FRANK, JR.: Right.
11
12 CALABRESE, SR.: ...Now I'm shielding them. See?
13
14 FRANK, JR.: Right.
15
16 CALABRESE, SR.: From the street. So they're here and
17 this is like, I'm almost like this to
18 their car. Alright? So when they got
19 out, they only had like (PAUSE) from
20 here...
21
22 FRANK, JR.: So they both got out on the same.
23
24 CALABRESE, SR.: ...to that Pole.
25
26 FRANK, JR.: Oh, okay. They both got out on the same
27 side then. Okay. You know both...
28
29 CALABRESE, SR.: Both one in the, one in the front...
30
31 FRANK, JR.: I see.
32
33 CALABRESE, SR.: ...one in the back.
34
35 FRANK, JR.: I see. So the car was on the right.
36
37 CALABRESE, SR.: Yeah.
38
39 FRANK, JR.: So (UI)...
40
41 CALABRESE, SR.: (UI) the car was on the right side.
42 They, one got outta the back. But when
43 I, when I pulled up, I pulled up right
44 before, hit the door, so they couldn't
45 see them gettin' out.
46
47 FRANK, JR.: Okay.
48

1 CALABRESE, SR.: So when they got out they were facin',
2 when he got out, here's the way they
3 were facin', like this. Okay?
4
5 FRANK, JR.: Okay. The car was.
6
7 CALABRESE, SR.: No. They were facin'...
8
9 FRANK, JR.: The people in the car.
10
11 CALABRESE, SR.: Because the doors were here. They were
12 opening the doors like this.
13
14 FRANK, JR.: Okay.
15
16 CALABRESE, SR.: So I didn't wanna put, put in the car.
17
18 FRANK, JR.: Like this...
19
20 CALABRESE, SR.: Because then they would, that would,
21 that would alert them a little bit.
22
23 FRANK, JR.: Passenger, right?
24
25 CALABRESE, SR.: Yeah. So, passenger side, both of them
26 got out.
27
28 FRANK, JR.: Right.
29
30 CALABRESE, SR.: So, uh, by doin' that, they're, they're
31 already to the back of the door, not the
32 front of the door. You know what I
33 mean? 'Cause I didn't want them, I
34 didn't want them to be blocked. All
35 that's gotta be thought of.
36
37 FRANK, JR.: Sure.
38
39 CALABRESE, SR.: Because if a guy gets out over here,
40 he's gotta walk around the door. See by
41 not, by putting the car in that angle,
42 they're walkin' out, like here's the
43 door this way, you're walkin' this way.
44
45 FRANK, JR.: Right, there's no door.
46
47 CALABRESE, SR.: And that's what they did. And, uh, one
48 from back window, one from the front

1 window. Side window. Both sides.
2 Angle. But what happened was, this one,
3 which was Joy, from this window wound up
4 hittin' the other one too.
5
6 FRANK, JR.: Oh, okay.
7
8 CALABRESE, SR.: See now his was this way. Poker's was
9 this way. Okay? Here. Here's (UI)...
10
11 FRANK, JR.: (UI) do you...
12
13 CALABRESE, SR.: ...over here.
14
15 FRANK, JR.: Here's a what?
16
17 CALABRESE, SR.: Here.
18
19 FRANK, JR.: Okay.
20
21 CALABRESE, SR.: That's there. And he is like this.
22
23 FRANK, JR.: Oh, so, oh, okay. So, Joy was like,
24 okay...
25
26 CALABRESE, SR.: Yeah...
27
28 FRANK, JR.: ...'cause he was...
29
30 CALABRESE, SR.: ...Across both of them.
31
32 FRANK, JR.: ...(UI). Across, so went across and
33 got...
34
35 CALABRESE, SR.: Yeah, they emptied out. They, I made
36 sure.
37
38 FRANK, JR.: They were (UI)...
39
40 CALABRESE, SR.: (UI) empty. No, they were automatics.
41
42 FRANK, JR.: Oh, they were shotguns?
43
44 CALABRESE, SR.: Yeah. But they were...
45
46 FRANK, JR.: Oh. Automatics...
47
48 CALABRESE, SR.: ...automatics.

1
2 FRANK, JR.: ...Okay.
3
4 CALABRESE, SR.: Yeah. 'Cause after they inject, we
5 through 'em away.
6
7 FRANK, JR.: Oh, okay.
8
9 CALABRESE, SR.: Yeah. In fact, that's the first thing
10 that's done.
11
12 FRANK, JR.: I--I know, I didn't--never thought you
13 like aut--I thought you always liked
14 pump. I thought...
15
16 CALABRESE, SR.: Yeah. But these were...
17
18 FRANK, JR.: ...but you didn't have a choice.
19
20 CALABRESE, SR.: ...these were given to us.
21
22 FRANK, JR.: Oh. (UI).
23
24 CALABRESE, SR.: And they worked, because we went and
25 tried 'em. Anytime you use somethin',
26 you make sure you try it. We took on,
27 on, on, uh, on, we took 'em both on, uh,
28 (PAUSE) two different nights. On, uh,
29 County Line Road up in DuPage County.
30
31 FRANK, JR.: I know what you're talkin' about.
32
33 CALABRESE, SR.: It's dead.
34
35 FRANK, JR.: It's by the forest prese--I mean by that
36 cemetery.
37
38 CALABRESE, SR.: Forest. No, the forest preserve up
39 there. On the other side of, uh, of,
40 uh, Hinsdale.
41
42 FRANK, JR.: Okay.
43
44 CALABRESE, SR.: That's, that's, that's, that's where
45 that son, uh, that camp, that farm that,
46 uh, Chucky's talkin' about was up in
47 that way. The farm. Santa Fe Ranch.
48

1 FRANK, JR.: Santa Fe Ranch...
2
3 CALABRESE, SR.: Uh, Santa...
4
5 FRANK, JR.: I can't...
6
7 CALABRESE, SR.: ...Fe mar--uh, Saddle Club.
8
9 FRANK, JR.: Santa Fe Saddle Club. That was
10 somebody's? Or that was...
11
12 CALABRESE, SR.: It was FeFe's.
13
14 FRANK, JR.: Oh, okay.
15
16 CALABRESE, SR.: So we knew that road real good. We knew
17 it. In fact, if you ever drove down
18 there, you'd see the slow sign. All the
19 signs were shot up.
20
21 FRANK, JR.: (LAUGHING) Oh, okay.
22
23 CALABRESE, SR.: We used to do that to check the guns.
24
25 FRANK, JR.: Okay.
26
27 CALABRESE, SR.: So we went over there and we tried the
28 shotguns. They both worked. We did one
29 one night, one another night, in case we
30 had to throw it. We had it, we had
31 gloves and everything on. Okay? So we
32 tried 'em, they worked. They worked
33 perfect. They didn't jam up or
34 anything. So that's what they used.
35 They had, uh, I think four a piece, or
36 five a piece. They had one in there and
37 four in the chamber.
38
39 FRANK, JR.: Mmm-hmm. That's (UI)...
40
41 CALABRESE, SR.: And they used 'em all. And they were
42 double-aughts, Frank.
43
44 FRANK, JR.: That means what? Extra...
45
46 CALABRESE, SR.: Bigger ones.
47
48 FRANK, JR.: Oh, okay.

1
2 CALABRESE, SR.: Big, big bearings. So them, them will
3 fuckin' tear half your body apart.
4
5 FRANK, JR.: So they musta tore them up pretty good
6 then.
7
8 CALABRESE, SR.: Oh, yeah. Tore 'em up bad. Them'll
9 tear your body up. They're called
10 double-aughts. And you want me to tell
11 you somethin'? The Polish guy that was
12 with 'em was a nice guy. Okay? But he
13 happened to be at the wrong place. You
14 know the--eh--uh, they were, it was said
15 no matter who's with 'em, want it done.
16 Now if you back away and you have that
17 opportunity and you don't, then you'd
18 look like a fuckin' asshole.
19
20 FRANK, JR.: Then they'd put you in that place maybe.
21
22 CALABRESE, SR.: So they can, they can, they can say,
23 well you don't wanna do it. Then what,
24 are you losin' your fuckin' nerve?
25 Okay, you start putting thoughts in
26 people's minds.
27
28 FRANK, JR.: I un--I understand...
29
30 CALABRESE, SR.: So...
31
32 FRANK, JR.: ...what you're sayin'.
33
34 CALABRESE, SR.: ...the poor guy was at the wrong place
35 at the wrong time. We were hopin' that
36 he was gonna be alone. But then when we
37 called and told 'em there's another one,
38 go ahead. We said, there's two, uh,
39 there's two--how did we put it? Wait a
40 minute.
41
42 FRANK, JR.: Oh, so you had to get the okay then.
43
44 CALABRESE, SR.: Oh, yeah. We got...
45
46 FRANK, JR.: For...
47

1 CALABRESE, SR.: ...it. We said, there's two, there's
2 two--oh, it's two security guards in
3 that yard. That's alright. Wait. Oh,
4 it's okay. Go ahead. Go ahead. You
5 can enter. You know who started all
6 that rigga--ma--talk--talk? I did.
7 They never talked like that. They
8 didn't know about talkin' like that.
9 Ronny, Joy, all them guys never knew
10 about talkin' like that. We used to
11 talk about yards, because there's
12 nothing but a bunch of yards around
13 there.
14
15 FRANK, JR.: Yeah.
16
17 CALABRESE, SR.: Pull in here, pull out there. Listen,
18 uh, I'm backin' this truck into the
19 dock, meanin' the guy's pulling in.
20 Okay? He's pullin' his truck into the
21 dock, uh, we're gonna over, approach him
22 to see, to see if we could see his bill
23 of lading. That meant we're going.
24

2 CALABRESE, SR.: Right. And he was as much as, he was as
3 much, you want me to tell you somethin'?

8 That I couldn't, I mean I--ah--that, I
9 don't know where (UI).
10
11 CALABRESE, SR.: The only thing I got goin' for me now is
12 I have, I would, first of all, I would
13 subpoena Junior and show how much hatred
14 he had for me, that he set me up because
15 he didn't like me. Because he'd made
16 all the mistakes. He was runnin' the
17 whole show. And, and him and brother
18 Jimmy had told me to go away. And go on
19 trip--to get away. I had nothin' to do
20 with nothin' anymore.
21
22 FRANK, JR.: Alright.
23
24 CALABRESE, SR.: Okay? So I had nothin' to do with
25 anything from the eighties. Now the
26 hatred that he showed to every--to
27 people out there, I would subpoena these
28 people.
29
30 FRANK, JR.: Right. No, it's not hard to find 'em
31 'cause they're all over the place.
32
33 CALABRESE, SR.: Right. I would subpoena 'em.
34
35 FRANK, JR.: You know.
36
37 CALABRESE, SR.: And then have them say what he told
38 them. Now with that, because of him
39 opening his big mouth, could help me.
40 Alright? I don't want that to happen.
41 I pray that nobody has a problem.
42 Because, Frankie, he'll kill himself.
43 He'll commit suicide.
44
45 FRANK, JR.: Yeah.
46

1 CALABRESE, SR.: And I wouldn't wanna see that. He, he,
2 he wouldn't know what to do. He would,
3 he would die of, of, uh, a heart attack
4 or somethin', because he is so scared
5 right now it's pathetic. You gotta hear
6 Junior tell the story of how, uh, how he
7 tells the story that he had nothin' to
8 do with nobody. He never made a penny
9 from nobody. Never made a penny from
10 nobody. And, uh, he worked all his
11 life. He never did anything wrong.
12
13 FRANK, JR.: Did he tell 'em he was made or anything?
14 Or he didn't...
15
16 CALABRESE, SR.: You're not supposed to talk about shit
17 like that...
18
19 FRANK, JR.: No. I know. But knowin' him that's why
20 I'm askin'. Knowin' him...
21
22 CALABRESE, SR.: You're not...
23
24 FRANK, JR.: ...fuck.
25
26 CALABRESE, SR.: ...supposed to talk about shit like
27 that. This asshole over here did that
28 with Ju--with Sonny and then I, when I
29 told him, I says, what are you
30 introduc'in' me for? You're not even...
31
32 FRANK, JR.: (LAUGHS)
33
34 CALABRESE, SR.: I said, what are you doin' here?..
35
36 FRANK, JR.: (UI)...
37
38 CALABRESE, SR.: ...Don't do that...
39
40 FRANK, JR.: ...Short...
41
42 CALABRESE, SR.: ...and don't fuckin' introduce me to
43 nobody. And I told Sonny, I don't wanna
44 be introduced to nobody else that is.
45 The only one that's Sonny introduced me
46 to is Raymond. Okay? 'Cause he was.
47
48 FRANK, JR.: Right.

1
2 CALABRESE, SR.: I says, I don't know who these fuckin'
3 people are.
4
5 FRANK, JR.: No. And Shorty. (LAUGHS)
6
7 CALABRESE, SR.: Yeah. He says, he, when I first came in
8 (UI), right? Out in front there. He
9 said, he said it the way you're supposed
10 to say it. And...
11
12 FRANK, JR.: Shorty said it the way you're supposed
13 to...
14
15 CALABRESE, SR.: Yeah.
16
17 FRANK, JR.: So how did he know?
18
19 CALABRESE, SR.: Well he knows from hearin' it.
20
21 FRANK, JR.: Oh.
22
23 CALABRESE, SR.: From, from the hand me downs, okay? And
24 then I looked at Shorty and then we left
25 Sonny. I says, wait a minute. You're
26 not made.
27
28 FRANK, JR.: (LAUGHS)
29
30 CALABRESE, SR.: No. I said, what the fuck you
31 introduc'in' me to that guy like you were
32 made guy for. That man thinks you're
33 made, doesn't he? Well he says, he
34 remembers me goin' and seein' Angelo.
35 I--Shorty, don't you fuckin' introduce
36 me to nobody again. Nobody. Then after
37 Sonny introduced me to, to Ray, I told
38 Sonny, I don't wanna be introduced to
39 nobody else. I don't.
40
41 FRANK, JR.: No. Fuck that. You don't know who they
42 are.
43
44 (PAUSE)
45
46 CALABRESE, SR.: Frank, I, I am not, but lookin' like I
47 need to shine--uh--uh, put a, put a, a
48 star on my head that I'm different than

1 anybody else. Okay? That isn't what,
2 that's not my M.O. I have never been
3 that way in my whole life. Shorty
4 loves that image. See?
5
6 FRANK, JR.: Oh yeah.
7
8 CALABRESE, SR.: Twan can't stand Shorty.
9
10 FRANK, JR.: Boy, I thought you said he loved him.
11
12 CALABRESE, SR.: Huh?
13
14 FRANK, JR.: I thought you said he liked him a lot.
15
16 CALABRESE, SR.: No. Jimmy likes him. Jimmy Diforti
17 likes Shorty.
18
19 FRANK, JR.: Oh.
20
21 CALABRESE, SR.: Twan was tellin' me that they're good
22 friends.
23
24 FRANK, JR.: Oh, sure, because Shorty probably kisses
25 Jimmy's ass.
26
27 CALABRESE, SR.: Well, no. Uh, Shor--eh, uh, Jimmy and,
28 uh, Shorty because he started hangin'
29 around with Toots, then he met Shorty.
30 Eh--see, Shorty's an impressionable type
31 of guy, if you...
32
33 FRANK, JR.: I know.
34
35 CALABRESE, SR.: ...don't know him.
36
37 FRANK, JR.: Sure. (LAUGHS)
38
39 CALABRESE, SR.: Okay?...
40
41 FRANK, JR.: Oh, yeah.
42
43 CALABRESE, SR.: ...And peop--people believe everything
44 he's saying. One time he brought
45 sandwiches to us. We were gonna have a
46 party. Okay? And the Bull brought him
47 and brought him in and he's seen and he

1 got fuckin' scared. He thought the
2 party was for him.
3
4 FRANK, JR.: (LAUGHS)
5
6 CALABRESE, SR.: And, uh, the Bull says, put the
7 sandwiches over there and he said, do
8 you see all these guys here? He says,
9 they're all men. You go wait in the
10 car.
11
12 FRANK, JR.: (LAUGHS)
13
14 CALABRESE, SR.: Okay. This is how he goes, okay.
15
16 FRANK, JR.: He didn't need the cane to get out, huh?
17
18 CALABRESE, SR.: He couldn't wait to get outta there.
19
20 FRANK, JR.: (UI).
21
22 CALABRESE, SR.: You shoulda seen him. He didn't even
23 wanna look at us. We were sittin', we
24 were all, we were ready. We were all
25 dressed up, uh, ready to, uh, dance.
26
27 FRANK, JR.: (LAUGHS)
28
29 CALABRESE, SR.: Okay? We were just waitin' for somebody
30 to, uh, to, uh, bring the hostess there.
31 But, anyway, uh, (PAUSE) I don't think
32 he's moved one stone in his life, but if
33 you hear him, he tells you he's done
34 this and he's done that.
