4 FRANK, JR.: Well, tell, you know the big thing too like  
5 you says is tell him with Captain D I don't  
6 think there's no problem.  
7  
8 RICCI: Yeah.  
9  
10 FRANK, JR.: But wi, with ah Michael and, and Curly I, you  
11 know...  
12  
13 RICCI: He know, he, he knows that Michael's been a  
14 shaky item for a while. You know Michael has  
15 not been a strong item. He is very, it's  
16 been a very shaky situation with Michael.  
17 And he knows that.

19 FRANK, JR.: Well here's another thing you gotta tell him  
20 too, that I heard through my aunts. The G  
21 went up to see my uncle Thursday, last  
22 Thursday.  
23  
24 RICCI: Yeah.  
25  
26 FRANK, JR.: Not this past Thursday, the Thursday before I  
27 think it was.

5

7 I don't know why, I'm waiting to hear from my  
8 aunt why or anything that he's been locked  
9 down. I don't know if he's still locked down  
10 or what and I don't know why.

12 RICCI: Now when you say your aunt you're talking  
13 about...

15 FRANK, JR.: Noreen.  
16  
17 RICCI: ...Noreen, right.  
18  
19 FRANK, JR.: Yeah.  
20  
21 RICCI: Yeah.  
22  
23 FRANK, JR.: Yeah. So...  
24  
25 RICCI: Alright, I mean she's friendly and....  
26  
27 FRANK, JR.: ...And I didn't talk to her directly.

29 RICCI: Yeah.

31 FRANK, JR.: Okay this is through the family I got it. So  
32 uhm, you know so I'm concerned about that  
33 too. Because I don't know, do you know why  
34 they would do that if they go see 'em one day  
35 and then they lock the both of them down the  
36 next. Well it's, it's weird. It's all weird.  
37 And Michael goes and sees my uncle a lot so

4 and said Jesus said we're trying to work on

3 RICCI: (UI).
