36 representing...(UI) turn a couple, just at, you
37 know, (UI) uh, just for, uh, that guy that's in

3 Vangel Heard, uh, I heard they DNA'd him.

9 Marcello ...huh? What'd you hear so far, that they

12 Vangel Just him. That's all. I mean, I know, see I'm
13 not...

15 Marcello Oh, I meant the other guy too.

17 Vangel The, this guy?
18
19 Marcello No. Rocky's brother.

21 Vangel Yeah.
22
23 Marcello They caught up with 'em.
24
25 Vangel Yeah. Yeah.

27 Marcello (UI) They caught up with Greek's partner.

29 Vangel Hmm?
30
31 Marcello They caught up with him the same day they caught
32 up with the Greek's partner?

34 Vangel Well, he took off.
35
36 Marcello Yeah. But he come back. (Pause)
37
38 Vangel (UI) would've believed this. The other guy, I
39 says, has he spokin' to his wife and he said no.
40 I can't believe that, that he hasn't spoken to his
41 wife.

43 Marcello That's what I heard, too.

45 Vangel Since October? August? Last time she saw him was
46 August or September, right?

1 Marcello It was August, the end of August. The last time
2 she talked to him on the phone, it was October.

4 Vangel October, Nov...Let's see, November, December,
5 January, February, March. I woulda thought...

7 Marcello I heard, I don't know how true it is, but I heard
8 she told him, take a walk.

10 Vangel Yeah, that's what I heard, too.
11
12 Marcello All I'm goin' by is what I hear. You know what I
13 mean?

15 Vangel Nothing else has been said. I imagine. Did you
16 hear of anybody that's gone to the Grand Jury?

18 Marcello (Shakes his head no.)
19
20 Vangel (UI) I didn't either. Just that one
21 guy. Fact is, I mean to tell ya the
22 truth, I was almost hopin' he'd a gone
23 to find out what they were gonna ask
24 him.

26 Marcello See I knew, I know who he talks to. I found out.
27 The guy's initials is PW. You know who the guy
28 is. He's a retired FBI guy.

30 Vangel The, the, the...
31
32 Marcello His first name is Peter.

34 Vangel Yeah.

36 Marcello That's who he talks to, this guy. The guy
37 downtown. The guy you talked to yesterday.
38 That's who he talked to. He's real close to him.
