28
29 Michael (Leans in and whispers something unintelligible in
30 James's ear.)

32 James Mmm hmm.
33
34 Michael And they found that thing in the park. By the guy's
35 house.

37 James (Shakes his head.) What happened with, uh, the friend,
38 Chops?
39
40 Michael (Shakes his head.) Alex called him up, told him, he
41 said with this (makes a hand motion out of view). He
42 never heard nothing no more.

44 James (Raises his hands up.) That kid where my son works, he
45 was supposed to go down there and they postponed it.

47 Michael Yeah but Jim, there was no subpoena.

3 Michael That's...No, no. I talked to him.

15 Michael Matter of fact, they refer to him in there. You'll see
16 how he...She brings up the thing with the trunk music.
17 Remember with his case?

19 James Oh okay.
20
21 Michael She brings that up but she don't mention his name.

23 James Mmm hmm.

25 Michael (UI)
26
27 James Just that other guy's name, right?
28
29 Michael Uh..
30
31 James The clown?
32
33 Michael Yeah.
34
35 James Pagliacci? Nothing about this guy, huh (rubs his
36 nose)?
37
38 Michael Nuh uh.
39
40 James Told you.
41
42 Michael You know, they can't put that, them things together
43 with him. Fuck, the other stuff's gone. It's too
44 late.
45
46 James I'm saying. This is what they got. (Makes a zero sign
47 with this left hand.) But somebody said something and
48 they try to make...You know. You ain't heard nothing

1 about, uh, the drywall guy's friend, huh?
2
3 Michael (Shakes his head no.) Mmm hmm.
4
5 James Something about moulieri with him or...?
6
7 Michael No.
8
9 James Or anything?
10
11 Michael Nothing.
12
13 James Remember you said last time you said...
14
15 Michael Supposed to, but he didn't come. He didn't come when,
16 when he said he was gonna come. Now he supposed to
17 come again. So the guy is gonna, see what he, see if
18 anything happens there. You know, in that direction.
19
20 James Mmm hmm.
21
22 Michael 'Cause the guy would be there. You know.
23

35 James Mmm hmm.

37 Michael And took?
38
39 James (Nods his head yes.) Called him in. These guys
40 (touches his chin) called him in. And he took this
41 (raises five fingers). The fifth (raises five
42 fingers).
43
44 Michael I don't know nothing about that.
45
46 James That's what I heard.
47
48 Michael I don't know. (UI) Mutt and Jeff, approached 'em and

1 that didn't come up. As far as I know. I'll find out.
2
3 James Know nothing about that, about uh, uh, Krause and uh,
4 Krause's brother and all of that. Krause's brother
5 must of said something.
6
7 Michael Oh, okay.
8
9 James Follow me? Oh, no.
10
11 Michael Not about that situation?
12
13 James About a different...You know.
14
15 Michael Oh, okay.
16
17 James With, uh...Wasn't sure. But, you know the guy says I
18 don't know what you're talking about.
19
20 Michael Now they're suppose to come a couple more things in
21 that direction. Pieces of paper, go down there, grand
22 jury.
23
24 James Uh huh.
25
26 Michael That direction, down east and up north. A couple in
27 each spot.
28
29 James Uh huh.
30
31 Michael A couple of guys in each spot. We'll see.
32
33 James So he's back, huh?
34
35 Michael Who?
36
37 James Pagliacci.
38
39 Michael Yeah.
40
41 James Everything going okay with the drywall guy?
42
43 Michael Yeah.
44
45 James I mean with this (makes a hand gesture). No problem?
46 I mean uh, when he goes. Everything's okay and...?
47
48 Michael (Nods his head yes.) She still claims the same thing.

1 (UI) You know.
2
3 James She still says niende, huh?
4
5 Michael Yeah.
6
7 (NON-PERTINENT CONVERSATION)

3 Michael No, he called me the other day. He was going out of
4 town to Texas for something. He's got a case down
5 there.
6
7 James He had a case down there, yeah.
8
9 Michael Then he was coming back. Supposed to get a hold of me.
10 Does this guy still want to use him or what?
11
12 James He hasn't said he didn't.
13
14 Michael Okay, 'cause I know he's looking for some stuff.
15
16 James (UI) He's looking for stuff (UI).
17
18 Michael He wants to get going on his stuff, doing...He wants to
19 do different things. I gotta see what he wants. You
20 know. I won't give him nothing 'till I see you again.
21 I'll tell you.
22
23 James Did he ever say he talked to the US Attorney or...?
24
25 Michael Yeah. They wouldn't give 'em much information. You
26 know. They got more from him (points to the other side
27 of the room) than he did from...

29 James Did they bring up my name to him? Did he ever tell you
30 anything?
31
32 Michael No.
33
34 James This guy (tilts his head toward the other side of the
35 room) told me that he told him that my name was
36 mentioned. Things they want to do in the future. I
37 know it was never mentioned to you. It was never said
38 to you. You know.

40 Michael No.
41
42 James Uh, I don't think he'd tell him (puts his arm out
43 towards the other side of the room) something without
44 telling you, right?
45
46 Michael No.
47
48 James This was a couple of months ago.

1 Michael Yeah. No, he didn't say nothing. I'll, I'll ask him.
2 I'll probably see him over, over the week-end or
3 something.
4
5 James Yeah. That's the only time I ever heard my name come
6 up.
7
8 Michael Yeah.
9
10 James Was through that, through him. Otherwise, I never
11 heard nothing. You know what I mean?

15 pretty strong with him, huh?

17 Michael Yeah. That's all you hear is that like...You know.
18 Now that's the way it's, that direction now. You
19 know.
20
21 James You haven't heard nothing from nobody else (UI)?
22
23 Michael (Shakes his head no.) No.
24

3 James Everything else okay buddy?
4
5 Michael (Shrugs his shoulders.) Yeah. You know.

7 James This guy's kid (motions with one finger on the palm of

17
18 James No, I'm not talking about that. I know that, yeah.
19
20 Michael We got another...This'll be, got fifteen of them
21 forties.

23 James Mmm hmm.
24
25 Michael (UI) six. Uh, what else is there? Six. Let me think
26 what else.
27
28 James In my own, in my own personal stuff. How much you got?
29
30 Michael Like where? (UI)
31
32 James (UI)
33
34 Michael (UI) stuff.
35
36 James (UI)
37
38 Michael Oh, it's about one-ninety something, one-ninety now.
39 Once I give Jimmy the money the last time.
40
41 James (Nods his head affirmatively.)
42
43 Michael Now, I got, I got nothing at home. If I gotta do
44 something, I gotta go back there. I'll count it up.
45 Let you know.
46
47 James Well, I know it's gotta be...

1 Michael It's gotta be like...
2
3 James Around this (motions with his hands).
4
5 Michael Yeah. One ninety-five, two.
6
7 James Yeah.
8
9 Michael Something like that.
10
11 James Just get the other stuff in there. What the kid gives
12 you. Just put it with that. You know what I mean?
13
14 Michael (Nods his head affirmatively.) (UI) We haven't done
15 nothing yet with the, building you're talking about?
16
17 James Yeah. How's he going with the routes out there? What
18 does he say when you talk to him?
19
20 Michael He says, uh, he comes up with...Like when this is done,

30 Michael He and the other guy both told him. You find anything,
31 you, you know, like a nice bookstore or a joint or
32 something. You know with the broads and all that...

34 James (Nods his head affirmatively.)

36 Michael Oh man, he goes I'm used to that other guy all he did
37 was go this way. Zoo. Him and uh Goggles. You know.
38 Nobody offered, uh, to do something. Put up stuff.
39 You know. Well, if you's find something, you know, let
40 us know.

42 James We should try to get this joint open. The joint where
43 Goggles...

45 Michael Yeah.
46
47 James Should try to open it up again.

1 Michael Well, that's what I'm gonna, that's what I'm gonna try
2 to do and then if I can't, uh, then...I don't see why
3 we can't.
4
5 James That's bullshit. That, you know, down the street, him,
6 that's bullshit. That's on the main drag there and
7 everything. You know what I mean, Mick? Across the
8 street (UI) over there is the restaurant. I mean,
9 that's bullshit.

11 Michael The only thing that's close to houses is behind that.
12
13 James (UI)
14
15 Michael That's the only one, the spot.
16
17 James That joint'll go. That joint'll go right away. You
18 watch. (UI)
19
20 Michael Oh, yeah. No it will.
21
22 James It'll pop, boom. The other joint, fuck it. You know.
23 I'd like to get 'em both going.
