24 driving him all over the city. Showed  
25 'em the (UI). (UI)

27 James: Huh?  
28  
29 Michael: Supposed to have (UI).  
30  
31 James: Yeah Mick, I heard you.  
32  
33 Michael: By, uh, where, where the knee (places  
34 his hand on his knee) was.  
35  
36 James: Yeah.  
37  
38 Michael: Supposed to be five things underneath  
39 there or something? That's what he told  
40 'em. You know.

1 James: Mmm hmm.  
2  
3 Michael: He took 'em there, down east by  
4 Pagliacci, that way. That's what he  
5 says. Now this is, this is from like  
6 yesterday.  
7  
8 James: Mmm hmm. Mmm hmm.  
9  
10 Michael: Oh, the Moulieri...  
11  
12 James: Mmm hmm.  
13  
14 Michael: Three times (puts his hand to his head).  
15  
16 James: Sure.  
17  
18 Michael: He dialed the phone number himself, the  
19 kid. He said the kid dialed the phone  
20 number.  
21  
22 James: What did we say? But that's okay.  
23  
24 Michael: Found that out too, for sure. While  
25 that was going on.  
26  
27 James: Sure. Nothing wrong with that.  
28  
29 Michael: And, uh, but he says nothing in this  
30 direction (appears to point towards  
31 himself and James).  
32  
33 James: Mmm hmm.  
34  
35 Michael: 'Cause he knows what we're looking for.  
36  
37 James: (Nods his head.)  
38  
39 Michael: (Rubs his nose) With that, with, uh,  
40 Zhivago.

42 James: Mmm hmm.  
43  
44 Michael: But then the other stuff is all like,  
45 over there, where, where, where they  
46 were at. You know.  
47  
48 James: Mmm hmm. Over here (makes a motion,

1 possibly pointing to his foot which is  
2 out of view of the camera)? Right?  
3  
4 Michael: That's what he said so far.  
5  
6 James: I believe it.  
7  
8 Michael: This was just yesterday.  
9  
10 James: I told you. That (makes a motion out of  
11 view of the camera) was the best  
12 investment (makes a circular motion with  
13 his arm)...Believe me.  
14  
15 Michael: I hope so. I hope it works out that  
16 way, buddy.  
17  
18 James: Look, Mick...  
19  
20 Michael: You know, I, I mean I hope you're right.  
21 I, I... Listen, if it is, it is. Fine.  
22 Keep it going and let it go. That's  
23 all.

25 James: Right.  
26  
27 Michael: But, I just hope he don't turn around  
28 and...

30 James: Listen, you know, like I said...

32 Michael: 'Cause you know they're trying to push  
33 him to do it. You can fucking bet on  
34 that.
