FACTUAL BASIS

If this case were to proceed to trial, the government would prove the defendant **RONALD A. GREENUP a/k/a Anthony Greenup a/k/a Ron Greenup**, guilty beyond a reasonable doubt of an one count Indictment, which charges **GREENUP** with a violation of the Federal Gun Control Act under 18 U.S.C. §§ 922 (g)(1) and 924 (a)(2). The government would establish through credible and competent witnesses and evidence the following facts:

On Friday, August 10, 2007, around 5:30 p.m., Officer Dylen Pazon and Karriem Jefferson were patrolling in an unmarked unit in the area of 300 N. Robertson Street when they observed Ronald Greenup on a bicycle. Greenup was observed almost striking a vehicle with his bicycle as he approached the intersection of N. Robertson and Conti Street. The officers activated their lights

and siren in an attempt to conduct an investigative stop of Greenup. Once Greenup observed the officers, he sped up on his bicycle. When Greenup approached the intersection of N.Robertson and St. Louis Street, he attempted to get off his bicycle. At that time, officers observed the handle of a blue steel handgun in his waistband area.

RONALD A. GREENUP KNOWINGLY POSSESSED A FIREARM

The officers exited their vehicle and handcuffed Greenup for officer safety. They advised Greenup of his Miranda rights and conducted a search of his waistband. During the search they found a fully loaded Glock model 30, .45 caliber semi-automatic pistol bearing serial number HRZ816.

**PRIOR TO THE POSSESSION OF THE FIREARM RONALD A. GREENUP
HAD A PRIOR CONVICTION FOR A CRIME PUNISHABLE BY
IMPRISONMENT EXCEEDING ONE YEAR**

The officers conducted a name check of Greenup and learned he was convicted of forcible rape in 1986 where he served thirteen years. Orleans Parish Criminal District Court records confirmed that **GREENUP** was convicted of forcible rape in criminal case number 313-298 "B".

**THE FIREARM POSSESSED BY RONALD A. GREENUP TRAVELED IN OR
AFFECTED INTERSTATE COMMERCE**

The Bureau of Alcohol, Tobacco, Firearms and Explosives (ATF) has determined that the firearm **GREENUP** possessed was not manufactured in the State of Louisiana and therefore by virtue of the Glock model 30, .45 caliber semi-automatic pistol bearing serial number HRZ816 being found in Louisiana on August 10, 2007, it had to have crossed state lines and affected interstate commerce.

ATF also determined that the firearm met the legal definition of a firearm as defined in Title 18,
U.S.C. Section 921(a)(3).
