obtained the express consent of the Secretary of the Department of Homeland Security to reapply for admission to the United States; all in violation of Title 8, United States Code Section 1326(a).

NOTICE OF SENTENCING ENHANCEMENT

Now comes the United States of America, by and through Jim Letten, the United States Attorney for the Eastern District of Louisiana, to give notice that on or about February 4, 2002, in the 23rd District Court of Brezoria County, Texas, Cause number 40,670, the defendant, **FLORENTINO ELGUERA-ROSENDO**, a/k/a Florentino Elguera, a/k/a Florentino Rosendo Elguera, a/k/a Florentino Helguera-Rocendo, a/k/a Roman Gonzalez-Sandoval, was convicted of an aggravated felony; to wit: robbery . Because of this conviction, if the defendant is convicted for a violation of Title 8, United States Code, Section 1326(a), the defendant's sentence will be subject to a maximum sentence of imprisonment for not more than 20 years. Title 8, United States Code, Section 1326(b)(2).
