Pakistan - Cyclone

BACKGROUND AND KEY DEVELOPMENTS

- On June 23, 2007, Tropical Cyclone Yemyin intensified near the coastal areas of Sindh and Balochistan provinces in southern Pakistan, resulting in high winds, heavy rains, and flash flooding. According to the U.N. Office for the Coordination of Humanitarian Affairs (OCHA), the cyclone and floods have killed 242 people, although unofficial reports indicate approximately 500 people dead and missing. As of July 5, approximately 150,000 people—of a total estimated 250,000 displaced at the height of the cyclone—remain displaced.
- On July 1, 2007, U.S. Chargé d'Affaires Anne W. Patterson requested that USAID/OFDA provide humanitarian assistance on behalf of the U.S. Government (USG) to those affected by the cyclone in Pakistan. In response, USAID/OFDA is providing more than \$390,000 to support affected populations. USAID/OFDA, USAID/Pakistan, and the U.S. Department of State will continue to monitor the situation.

FY 2007 USAID HUMANITARIAN FUNDING PROVIDED TO DATE

CURRENT SITUATION

- According to OCHA, the cyclone and subsequent rains and floods have affected approximately 1.65 million people in
 two provinces in southern Pakistan. In the districts of Gwadar, Jhal Magsi, Kech, Kharan, Khuzdar, and Jaffarabad,
 Balochistan Province, the humanitarian situation remains critical. Floods have also affected the districts of Dadu,
 Jacobabad, Larkana, Shahdadkot, and Thatta, Sindh Province, according to the International Federation of Red Cross
 and Red Crescent Societies (IFRC). In the coastal district of Karachi, Sindh Province, flood waters have severely
 disrupted commercial and port activities, according to the U.S. Embassy in Islamabad.
- Staff at the U.S. Embassy in Islamabad report widespread damage to cotton and cash crops in Sindh Province, extensive loss of livestock, and infrastructure and livelihood losses to the fisheries industry. OCHA reports substantial impact to livelihoods in Kharan District, Balochistan Province.

Shelter

- According to OCHA, flooding has damaged or destroyed 300,000 to 400,000 houses in affected areas. Flood
 waters destroyed an estimated 50 percent of houses in Kharan District, Balochistan Province, and additional houses
 in Qambar District, Sindh Province. Flooding has also resulted in substantial loss of houses in Kech District,
 Balochistan Province, according to the Pakistan Humanitarian Forum (PHF), a network of international nongovernmental organizations.
- The Government of Pakistan's (GOP) National Disaster Management Authority has set up several internally displaced persons (IDP) camps, including two in Jhal Magsi District, Balochistan Province, according to OCHA.

Health

- According to the PHF, affected populations are suffering from skin and gastrointestinal diseases due to lack of shelter and access to clean water.
- PHF members, including Oxfam Great Britain, Save the Children/UK, Concern Worldwide, Church World Service–Pakistan/Afghanistan, and Catholic Relief Services, are providing temporary shelter, according to OCHA. Other humanitarian organizations are providing medical and water purification supplies. The GOP's Ministry of Health is mobilizing medical teams to the cyclone-affected areas.

Humanitarian Coordination

• The U.N. Resident Coordinator in Pakistan has reinstated the cluster approach to respond to humanitarian needs in Balochistan and Sindh provinces.

USG HUMANITARIAN ASSISTANCE

- On July 1, 2007, U.S. Chargé d'Affaires Anne W. Patterson requested that USAID/OFDA provide humanitarian assistance on behalf of the USG to those affected by the cyclone in Pakistan. USAID/OFDA is providing \$390,621 to Mercy Corps to procure and distribute emergency relief commodities to 90,000 people in affected areas. The contribution includes \$50,000 under the Ambassador's Authority.
- USAID/OFDA, USAID/Pakistan, and the U.S. Department of State will continue to monitor the situation.
