#### **CURRENT HUMANITARIAN SITUATION**

USG Assistance

- Between May 4 and 5, two USAID/OFDA flights carrying a total of 1,260 rolls of plastic sheeting, valued at \$468,000 including transportation, arrived in El Fasher. This contribution of plastic sheeting will provide shelter for approximately 63,000 beneficiaries. Between May 7 and 8, two additional USAID/OFDA shipments are scheduled to arrive in Darfur, carrying a total of 1,260 rolls of plastic sheeting valued at \$468,000 including transportation.
- In Kass, South Darfur, USAID/OFDA partner International Rescue Committee (IRC) implements water and sanitation programs in three sites hosting internally displaced persons (IDPs): the veterinary school, south primary school, and Al Hamaira camp. IRC is responsible for managing solid waste collection, which is done daily at all IDP sites in Kass and taken to two landfill sites outside the area. IRC has camp cleanup campaigns three times a week with a weekly contest for the cleanest camp. OXFAM, IRC, and Médecins sans Frontières (MSF) manage water and sanitation interventions at the IDP sites in Kass. According to the USAID Disaster Assistance Response Team (USAID/DART), community latrines are in use, hand washing facilities with soap are located outside latrines, water supplies are chlorinated, and lines at water sites are short.

Humanitarian Access

- According to the U.N., on April 26, the Minister of Humanitarian Affairs announced new Government of Sudan (GOS) procedures for humanitarian work to improve assistance for refugees, IDPs, and returnees. The Minister indicated that the measures mainly deal with the registration of relief organizations, facilitation of tax procedures, facilitation of movement to Darfur, and the issuance of cards to humanitarian workers in Darfur.
- The USAID/DART reported that the area of East Jebel Mara has not received humanitarian assistance since the relief agency serving the area ceased activities as a result of an incident in which the organization's convoy was fired upon. While the organization is considering returning to the area once there are clear indications that the situation has calmed down, non-governmental organizations (NGOs) report that the area remains tense.

Security

The USAID/DART reported increased tensions between IDP populations and GOS police in North Darfur. On May 4, following allegations about the rape of two women near Zamzam camp, an

estimated 2,000 to 2,500 IDPs gathered to protest, blocking the road from the camp to El Fasher. According to the U.N., GOS police dispersed the crowd with rounds of tear gas and reportedly fired into the crowd; one injury has been confirmed. NGOs ceased operations in the camp on the same day and the road is closed until the U.N. conducts a security assessment.

## Protection

- According to the USAID/DART, the African Union (AU) will begin to patrol the area around the Sisi IDP camp, West Darfur, and escort women during firewood collections. In Zalingei, similar AU patrols have dramatically decreased the reported incidents of sexual violence.
- The AU civilian police are now permanently located in Kalma camp, South Darfur. The humanitarian community has long awaited this action as a means of improving security and providing protection in Kalma.

### Health

According to the U.N. World Health Organization (WHO), three cases of the W135 strain of
meningitis have recently been reported in three different areas of West Darfur—Riyad, Ardamat, and
Abu Sarooj. WHO is waiting for the results of two additional samples of suspected meningitis cases
in Abu Sarooj and is in a heightened state of alert. A working group comprised of the Ministry of
Health, NGOs, and WHO is prepared to respond to a possible outbreak and has the necessary
vaccination stock.

## Food Assistance

- In preparation for launching large-scale food commodity shipments to Darfur though the Libyan corridor, WFP conducted a trial shipment to assess the process of transporting grain from Chad into Darfur. On April 25, WFP shipped 400 metric tons (MT) of sorghum from Abeche to Geneina without incident. WFP officials in Khartoum report that the governments of Libya, Chad, and Sudan have granted all approvals necessary for the operation.
- On April 28, WFP, the International Organization for Migration (IOM), and cooperating partners postponed the population re-registration exercise in Geneina town and the surrounding area. According to the USAID/DART, the exercise was cancelled due to the local sheiks unwillingness to assist with the process and WFP's realization that a broader information campaign would help to allay IDPs' concerns about the re-registration process. To address these concerns, WFP has increased information dissemination to camps, including personal visits by the WFP Head of Office and radio announcements clarifying the process. Re-registration continued during the week in other communities in West Darfur, and WFP expects to complete the exercise within the next few weeks. *Water and Sanitation*
- According to the USAID/DART, water drilling plans in West Darfur are progressing as scheduled. Although the U.N. Children's Fund (UNICEF) planned to support the drilling of 75 boreholes in the January-June timeframe in West Darfur, the organization has increased the estimates to 150 by the end of June. Including all partners in the region, UNICEF expects that up to 240 boreholes will be dug prior to the beginning of the rainy season in May/June.

## IDP Relocations

- According to the U.N., on April 29, the GOS transported 78 families, comprising 233 people, from Otash and Kalma camps in South Darfur to Garsilla in West Darfur. The relocation was not done with verification from IOM, and no assistance was available for the IDPs upon arrival. Reportedly, 102 IDPs immediately departed Garsilla, 82 returning to Nyala and the remainder going to villages surrounding Garsilla. Those who remained in Garsilla are living in a school with no food or water assistance, and a limited amount of emergency relief supplies.
- IOM and OCHA have determined that the Hashaba camp is appropriate for the relocation of IDPs from the overcrowded Kalma camp. The next steps will be to identify families willing to voluntarily move to Hashaba and to prepare the site. The humanitarian community remains committed to facilitating the relocations in advance of the rainy season.
