## **CURRENT HUMANITARIAN SITUATION**

Security

- On September 1, groups of unidentified armed men attacked two international nongovernmental organization (NGO) convoys in separate incidents in West Darfur. At the September 5 U.N. Donors Meeting in Khartoum, the U.N. Department of Safety and Security (UNDSS) reported that armed men ambushed a 7-vehicle convoy carrying 21 relief workers from Beida to Geneina via Masteri. Approximately 15 to 20 armed men separated the women and men NGO staff members, severely beat both groups, and forced the women to disrobe. The armed men then stole money, personal belongings, communications equipment, and other supplies. Seventeen staff members reported injuries, including broken bones and cuts. UNDSS reported an additional September 1 attack on three NGO vehicles traveling from Mornei to Geneina. Nine armed men stole personal belongings and communications equipment from the passengers.
- On September 5, Manuel Da Silva, U.N. deputy special representative of the Secretary General and humanitarian coordinator for Sudan, met with representatives of the Government of Sudan (GOS), humanitarian community, and African Union Mission in Sudan (AMIS) to discuss ways to reduce violence targeting relief agencies in West Darfur. AMIS has pledged to increase patrols along main transportation routes in the region.
- On September 6, approximately 10 km outside of Geneina, unidentified armed men ambushed an ambulance transporting the payroll of a relief organization to Mornei. The attackers stole a briefcase carrying 900,000 Sudanese Dinars (SD), or approximately USD 3,600, and escaped. The UNDSS has restricted travel to essential missions with armed AMIS escorts along all southbound roads out of Geneina.

Returns

• At the September 5 U.N. Donors Meeting, OCHA stated that the humanitarian community needs to begin planning for likely IDP returns in 2006. OCHA believes that if a Darfur peace agreement is reached by the end of 2005, approximately 30 percent of IDPs will spontaneously return to villages of origin in the spring of 2006 to cultivate farms before the rainy season. OCHA also expects an additional 40 percent of IDPs to slowly return to rural areas during 2006 and the remaining 30 percent of IDPs to stay in towns and camps of displacement as new

residents, if a peace agreement is brokered.

• Following a request from Dinka leaders, the South Darfur Return Working Group plans to form a task force focused on Dinka IDPs who fled to South Darfur during the conflict in Southern Sudan. The International Organization for Migration (IOM) recently informed the USAID/Disaster Assistance Response Team (USAID/DART) that Dinka leaders have sought IOM's assistance in facilitating the return of approximately 25,000 Dinka IDPs to Southern Sudan. The task force's initial objectives will likely include pooling existing data on the group, identifying information gaps, seeking partners in areas of return, and clarifying information on the Dinka caseload.

#### Health

- According to a U.N. World Health Organization (WHO) representative, a Hepatitis E outbreak is occurring in Mukjar camp, West Darfur. WHO reported 69 cases of Hepatitis E during the week of August 28 to September 3, following 49 reported cases during the week of August 21 to 27. According to the U.N. Mission in Sudan (UNMIS), a recent assessment found that most Mukjar camp residents do not have access to safe drinking water, as rainfall has left water sources polluted. Health and water and sanitation teams have responded by increasing water chlorination activities and promoting hygiene among residents.
- WHO recently reported that more than 600,000 children in South Darfur received measles vaccinations during a state-wide campaign in late August. The figure represents 98 percent of the campaign's targeted population. Measles vaccinations are expected to be carried out in North and West Darfur after the rainy season ends and road conditions improve.

#### Protection

• On September 7, the Special Advisor to the U.N. Secretary General on Gender Issues and Advancement of Women, Rachel Mayanja, met with representatives of relief agencies in Nyala, South Darfur, and encouraged the humanitarian community to offer constructive suggestions to the GOS' recently released strategy for combating sexual violence. NGO representatives noted that recent GOS progress on the issue is the direct result of international pressure. Mayanja also met with IDP women in Otash camp, near Nyala. The meetings followed Mayanja's September 6 discussions with IDP women in Abu Shouk camp near El Fasher, North Darfur, which focused in part on sexual violence.

### Food Security

• On September 6, the USAID/DART field officer for South Darfur attended a U.N. Food and Agriculture Organization (FAO) meeting to discuss the FAO 2006 Work Plan with partners. Representatives from more than 20 NGOs attended. FAO officials stated that program ideas for 2006 included water harvesting to benefit nomads, agricultural extension services, crop diversification, local seed production, and production of fodder crops by pastoralists. The group also suggested goat and donkey restocking activities, construction of local hatcheries for poultry, and reforestation projects for areas surrounding IDP camps.

#### Food Distributions

• In a September 5 report, WFP stated that despite heavy rains, insecurity, and jet fuel shortages, WFP was able to meet August food requirements using pre-positioned stocks. As of August 30, WFP had dispatched 38,644 metric tons (MT) of food for distribution to beneficiaries in Darfur. WFP also reported delivering 4,923 MT of food to Darfur via airlifts and airdrops between August 1 and 28, representing 53 percent of the plan for August.
