Sudan – Complex Emergency

Situation Report #12, Fiscal Year (FY) 2007

March 9, 2007

Note: The last situation report was dated February 23, 2007.

BACKGROUND

In 2007, Sudan continues to cope with the effects of conflict, displacement, and insecurity countrywide. During more than two decades of conflict between the former Government of Sudan (GOS) and the southern-based Sudan People's Liberation Movement/Army (SPLM/A), fighting, famine, and disease killed more than 2 million people, forced an estimated 600,000 people to seek refuge in neighboring countries, and displaced 4 million people within Sudan—the largest internally displaced person (IDP) population in the world. The former GOS and the SPLM signed the Comprehensive Peace Agreement (CPA) and formed the joint Government of National Unity (GNU) in 2005, officially ending the North-South conflict. The U.N. estimated that hundreds of thousands of displaced persons returned to Southern Sudan during 2005 and 2006, taxing scarce resources and weak infrastructure.

Conflict in the western region of Darfur has entered its fourth year, despite a peace agreement between the GNU and one faction of the Sudan Liberation Army (SLA), signed in May 2006. Fighting among armed opposition group factions, Sudanese Armed Forces (SAF), and militias persisted throughout 2006, displacing hundreds of thousands of civilians. The complex emergency in Darfur is affecting approximately 4 million people in Sudan and eastern Chad.

The U.S. Government (USG) is the leading international donor to Sudan and has contributed more than \$2 billion for humanitarian programs in Sudan and eastern Chad since FY 2004. The U.S. Mission in Sudan has declared disasters due to the complex emergency on an annual basis since 1987. On October 16, 2006, U.S. Chargé d'Affaires Cameron R. Hume renewed the Sudan disaster declaration for FY 2007. The USG continues to lead the international effort to support implementation of the CPA, while providing for the humanitarian needs of conflict-affected populations throughout the country.

CURRENT SITUATION IN DARFUR

On March 3, the Director of USAID/FFP concluded a nine-day visit to Sudan. The USAID/FFP Director and other USAID staff visited several locations in Southern Sudan and Darfur to observe relief and recovery activities that USAID/FFP supports with P.L. 480 Title II emergency food commodities.

Security and Humanitarian Access

In South Darfur, banditry and escalating violence involving armed militias, SLA factions, and Sudanese

government security officers have recently impacted humanitarian access in the areas of Kass, Ed Daein, Kalma IDP camp, Gereida, and Muhajeria. In late February, U.N. security officials assessed Kabkabiya, Saraf Omra, and Misteriya towns in North Darfur and Jebel Marra in West Darfur and reported that the towns were safe for humanitarian travel. On February 25, USAID staff participated in an interagency assessment of Korma, Kafod, Kobe, and Keyla towns in North Darfur, which are reportedly safe for humanitarian

organizations to resume activities. Aid agencies have not been able to access the Korma and Kabkabiya areas of North Darfur regularly since August 2006, when fighting between SAF and armed opposition groups erupted.

The U.N. reported that on March 5, two African Union Mission in Sudan (AMIS) personnel were killed in Gereida, South Darfur, bringing the total number of AMIS casualties in Darfur to 11 since 2004.

Displacement

In late December, fighting erupted between two Arab groups, the Tarjem–Rizegat and Maharia, in areas south of Kass, South Darfur, causing approximately 6,000 people to move from affected areas to Kass town in recent weeks. The U.N. World Food Program (WFP) reports that 4,300 of the newly displaced people have received food and relief commodities, but shelter remains a significant problem as the displaced are currently living in the streets.

On March 7, World Vision reported a total of 10,682 IDPs in Al Salam camp near Nyala, South Darfur, an increase from the 3,569 reported in November 2006. On March 1, WFP distributed a 10-day food ration to new arrivals. Humedica International is regularly distributing relief items, and CHF International is providing shelter kits. According to World Vision, the majority of the displaced are coming from Buram locality, while others are arriving from Sanam al Naga, approximately 30 km south of Nyala. OCHA reported that in mid-February people began to flee from fighting over land in Sanam al Naga that Dinka IDPs had recently vacated when they returned to Southern Sudan.

The week of February 25, the U.N. and Médecins Sans Frontières (MSF) assessed Eastern Jebel Marra, South Darfur, and reported that IDPs lack sufficient water and health services, particularly in the eastern corridor of the area. Samaritan's Purse reported that more than 48,000 IDPs are located in Feina, Dulda, Terentonga, Kulubri, and Golombine, with the majority concentrated in Dulda. In mid-December, SAF bombing in the Deribat area of South Darfur caused communities to flee to other locations in Eastern Jebel Marra. The recent Samaritan's Purse headcount was the first time agencies were able to verify IDP numbers in the area. Despite unpredictable accessibility, Samaritan's Purse is continuing to distribute food in Eastern Jebel Marra. Additionally, non-governmental organizations (NGOs) are planning to increase health services and drill additional water points.

Health

Due to the new arrivals in Kass, the International Rescue Committee (IRC) clinic now serves approximately 400 patients a day, an increase from the 100 patients a day treated prior to the latest influx of IDPs. OCHA is reviewing the health sector in Kass to

identify gaps, and several NGOs have expressed interest in launching new health services in the area.

Reports of acute jaundice syndrome (hepatitis E) cases continue to decline in South Darfur. According to the U.N. World Health Organization (WHO), the outbreak, which affected nearly 181 people during the week of February 5, is now under control.

The week of March 5, WHO reported two probable cases of meningitis in Kalma IDP camp, South Darfur. An NGO has collected biological samples, which are in Khartoum awaiting laboratory testing. In response, agencies have pre-positioned vaccines, and clinics are conducting daily disease surveillance activities in Kalma camp. In January and February, Southern Sudan experienced an outbreak of meningitis that affected nearly 2,000 people, including 190 deaths.

Nutrition

On March 1, USAID staff visited the therapeutic feeding center (TFC) run by USAID partner Action Contre la Faim (ACF) in Nyala town, South Darfur. The center was hosting 25 children with severe malnutrition, in addition to nine siblings of the patients. The outpatient therapeutic program (OTP) had 80 registered children. Since December, ACF has managed seven OTP stations concentrated near Otash, Dereig, and Al Intifada areas. Patients receive food for one month, at which time they either graduate from the program or are referred to a TFC.

Protection

The week of March 5, USAID staff met with organizations engaged in Darfur protection activities in IDP camps. The protection agencies identified domestic violence, sexual abuse, and child soldier recruitment as the most pressing protection issues. In IDP camps, the agencies have observed an increase in reported cases of domestic violence, including incest.

Eastern Chad

Violence and insecurity in eastern Chad continue to limit aid agencies' access, including to Guereda. As of January, approximately 28,000 refugees and nearly 2,000 IDPs were residing near Guereda town, according to UNHCR. The week of March 5, a USAID staff member arrived in eastern Chad to follow up with partners on the recommendations of the recent USAID Assessment Team and monitor the ongoing humanitarian emergency.

CURRENT SITUATION IN NON-DARFUR SUDAN

Security and Humanitarian Access

The U.N. has reported that Lord's Resistance Army (LRA) combatants are operating between Western Equatoria State and the Central African Republic—Sudan border. On March 1, an LRA attack on the town of Yuba, located 22 km south of Tambura, resulted in

an exchange of gunfire with GNU Joint Integrated Units forces and the deaths of two civilians. To date, the U.N. has reported eight LRA attacks in Western Equatoria State in March and has raised the security level to Phase IV in the region, limiting aid staff to essential personnel.

Returns

Displaced Sudanese continue to return to Southern Sudan from other regions of Sudan and neighboring countries. USAID's food aid partners—WFP, Catholic Relief Services, and Norwegian People's Aid—continue to provide returnees with food rations. To improve community infrastructure in anticipation of an influx of returning IDPs, the Juba Civil Authority and USAID completed renovation of an abattoir in Juba, Central Equatoria State, on February 28.

Food Security

On March 2, the U.N. Food and Agriculture Organization (FAO) reported that desert locusts are hatching on the Red Sea coast of Sudan, near the Eritrea-Sudan border. According to FAO, the infestations are concentrated in a 7 km by 15 km area of green vegetation on the coastal planes. FAO reported that aerial and ground control operations are underway in Sudan and will continue to monitor the situation as long as breeding conditions remain favorable.

Water, Sanitation, and Hygiene

In February, USAID staff assessed USAID-funded water, sanitation, and hygiene interventions in Southern Sudan. The team reported that USAID interventions have increased access to water, but that maintenance of some water projects, such as hand pumps and solar pump systems, remains a challenge.
