CONTRACT INFORMATION BULLETIN 99-1

The purpose of this Contract Information Bulletin (CIB) is to summarize the CIB system and provide a current listing of CIBs. A listing of CIBs being dropped is also attached for your information. This supersedes CIB 98-1.

CIBs provide information of interest to contracting personnel including (but not limited to) advance notification of changes in acquisition or assistance regulations, reminders, procedures, and general information. Also, at times CIBs are used to implement new requirements temporarily, pending formal amendment of acquisition or assistance regulations.

CIBs are issued under the Procurement Executive's signature and are normally prepared by M/OP/P, but CIBs can be written by other offices if the subject is in their area of expertise or special interest. M/OP/P maintains the log of CIBs and assigns all CIB numbers.

CIBs are serially numbered on a calendar year basis (98-1, 98-2, etc.) Normally, the first CIB of the year will provide the current listing.

The index of the current CIBs is attached. Copies of the listed CIBs can be obtained from M/OP/P. They are also located on the OP Home Page on the Agency Intranet.
