### **CURRENT HUMANITARIAN SITUATION**

USG Delegation

• From August 17 to 20, U.S. Representative Chris Smith (R-NJ) led a delegation to Sudan to assess the humanitarian situation. After meeting with senior Government of Sudan (GOS) officials in Khartoum, the delegation traveled to South Darfur for additional discussions with the *Wali* and state ministers, U.N. representatives, African Union Mission in Sudan (AMIS) officials, and USAID/OFDA non-governmental organization (NGO) partners. In addition, the delegation visited Mukjar camp, West Darfur, and Kalma camp, South Darfur, to view USAID-funded programs and meet with IDPs.

#### Logistics

- In an August 22 meeting in Khartoum, WFP and the International Committee of the Red Cross (ICRC) reported that a cargo truck shortage has hindered the agencies' ability to transport food and emergency relief supplies from Port Sudan to Khartoum. Poor road conditions during the rainy season have also hampered deliveries. As a result, WFP reported that stockpiles in Khartoum and El Obeid have dwindled. Pre-positioned food is available in Geneina, West Darfur, and El Fasher, North Darfur, but severely limited in Nyala, South Darfur.
- Jet fuel shortages that are expected to continue into September have restricted cargo and passenger flights between Khartoum and Darfur in recent weeks. WFP reported the cancellation of 40 percent of cargo flights between August 17 and 23 due to the shortages.
- The U.N. Joint Logistics Center (UNJLC) plans to resume flights as soon as possible and has prioritized cargo in the following order: medical supplies, communication and computer equipment, and emergency supplies, including shelter materials and water and sanitation equipment. At an August 25 meeting in Khartoum, UNJLC reported dispatching 35,000 mosquito nets by road to El Fasher and Nyala on August 21. UNJLC will dispatch 15,000 nets to Geneina pending a decision on whether to use ground transport or to await fuel for air shipment.

#### Humanitarian Access

 Relief agencies continue to report looting and violence targeting humanitarian and commercial vehicles, particularly in South and West Darfur. WFP reported that in separate incidents on August 15 and 18, armed men looted trucks destined for Labado, South Darfur.

- The U.N. Department of Safety and Security (UNDSS) has suspended U.N. travel along the Habilah–Mornie road in West Darfur after bandits robbed passengers of two NGO vehicles on August 21. GOS police are investigating the attack.
- On August 22, representatives of WFP and OCHA traveled to Al Daein, South Darfur, to meet with local Sudan Liberation Movement/Army (SLM/A) leaders and discuss food distributions to IDPs and vulnerable populations in the area. The SLM/A previously had demanded that food be distributed to all people in need, rather than solely to IDPs formally registered with WFP. As a result of the meeting, SLM/A leaders agreed to allow safe passage of WFP food trucks in SLM/A-controlled areas of South Darfur. In addition, SLM/A will provide WFP with a list of approximately 9,000 vulnerable people in the area who will receive one WFP food ration. After this initial distribution, WFP plans to conduct a full assessment of food vulnerability in the area and add eligible people to the caseload.

### Kalma Camp

• The Norwegian Refugee Council (NRC) and the GOS Humanitarian Aid Commission (HAC) have not reached an agreement to renew NRC's camp coordination role, which expired on August 22. NRC has suspended operations in Kalma camp pending a formal agreement with the HAC. Representatives of the HAC, OCHA, and the U.N. Mission in Sudan (UNMIS) are currently negotiating the terms of a renewed agreement with NRC.

# Food Distributions and Registrations

- Relief agencies continued food distributions this week in several IDP camps in Geneina, following WFP deliveries of more than 1,800 metric tons (MT) of food for beneficiaries in area camps and host communities. The USAID Disaster Assistance Response Team (USAID/DART) reported delays at some distribution sites due to a lack of scoops. WFP plans to airdrop pulses to some areas where rations without pulses were delivered. The Geneina IDP re-registration is expected to begin after this round of distributions.
- On August 24, CARE reportedly registered more than 80 percent of eligible beneficiaries in Kass camp, South Darfur. Approximately 200 GOS police patrolled outside the camp's perimeter during the process, while AMIS civilian police and protection forces were present outside and inside the camp.
- On August 24, USAID/DART members observed food distributions for more than 2,100 newly arrived beneficiaries in Al Salam camp, South Darfur. In addition to the food ration, beneficiaries received soap, plastic sheeting, and water containers.

#### Rains

- Humanitarian agencies in Ardamata camp, West Darfur, continue to carry out relief activities
  after heavy rains and flooding in early August left shelters and latrines collapsed.
  USAID/OFDA partner Catholic Relief Services (CRS) quickly responded by providing
  materials for shelter reconstruction. Although the camp water supply remains contaminated,
  soap distributions, vector control activities, and latrine repairs have already occurred.
  Additional latrine construction and hygiene promotion activities are expected to occur in the
  coming weeks.
- Following flooding and population displacement in early August, agencies working in Abu Shouk camp, North Darfur, plan to build a dam to protect the area where the water flow is heaviest, UNMIS reported. The agencies also plan to construct barriers directing water flow away from the settlements. GOS authorities will provide engineers and machinery, but have requested support for labor and operational costs. Across the river, in Al Salam camp, 159 families affected by flooding have been identified to receive food assistance and relief supplies.
