## **Small Business Profile: INDIANA**

Entrepreneurs, innovators, and small businesses are key players in the economy of Indiana. They make up most of the employer firms in the state, and their contribution is indispensable. Their diverse composition and the spectrum of opportunities they offer are captured in this Small Business Profile, using the most current federal data available.

Number of Businesses. The state had an estimated total of 473,500 small businesses based on the most recent data.1 Firms with employees numbered 125,532 in 2005, of which an estimated 97.6 percent or 122,519 were small firms (fewer than 500 employees). Self-employment (including incorporated) decreased by 4.4 percent, from 267,017 in 2004 to 255,386 in 2005.2 In 2004, non-employer firms increased by 3.1 percent and numbered 350,962. Women-Owned Firms. Firms owned by women increased 11 percent between 1997 and 2002, from 107,082 to 118,857; they represented 27.4 percent of the state's total businesses in 2002. These firms (with and without paid employees) generated \$16.5 billion in revenues in 2002. Of the total number of women-owned firms, 13.6 percent or 16,218 firms were employer firms. In 2005, self-employed women totaled 75,972, a decrease of 26.6 percent from 2004, and they represented 29.7 percent of self-employed persons in the state. Minority-Owned Firms.<sup>3</sup> In 2002, Asian-owned firms totaled 6,077 and generated \$2.6 billion in receipts; Blackowned firms numbered 14,068 and generated \$1.7 billion in receipts; and Hispanic-owned businesses totaled 5,481 and created \$787 million in receipts. American Indian- and Alaska Native-owned firms numbered 1,957, and they generated \$260 million in receipts; the number of Native Hawaiian- and other Pacific Islander-owned firms was 114, and they generated \$77 million in receipts in 2002. Business Turnover. New employer businesses in 2005 were estimated at 14,545, which is 4.6 percent more than the previous year. Business bankruptcies increased by 44.7 percent, to 758 in 2005, while business terminations increased by 8.0 percent, to 16,504 during the same period. Employment. There were 113,687 employer firms with fewer than 500 employees in 2003;4 they provided 1,264,992 jobs in the state. These firms represented 97.6 percent of the employer businesses in the state and employed 49.8 percent of the state's non-farm private sector workforce (Table 1). Between 2002 and 2003, total small business net new jobs amounted to 38,853 (Table 2). (Source: U.S. Dept. of Commerce, Census Bureau, Statistics of U.S. Businesses.)

Small Business Income. Non-farm proprietors' income, which is a partial measure of small business income, increased by 7.8 percent to \$13.8 billion in 2005. (Source: U.S. Dept. of Commerce.)

Finance.<sup>5</sup> Two important sources of small business financing are commercial banks and savings and loan institutions. which owners rely on for their financial needs. The total number of operating bank and savings bank branches in the state increased in 2005 (Table 3).
