## Small Business Profile: MINNESOTA

Entrepreneurs, innovators, and small businesses are key players in the economy of Minnesota. They make up most of the employer firms in the state, and their contribution is indispensable. Their diverse composition and the spectrum of opportunities they offer are captured in this Small Business Profile, using the most current federal data available.

Number of Businesses. The state had an estimated total of 491,700 small businesses based on the most recent data.1 Firms with employees numbered 133,288 in 2005, of which an estimated 98.0 percent or 130,622 were small firms (fewer than 500 employees). Self-employment (including incorporated) decreased by 9.3 percent, from 359,608 in 2004 to 326,062 in 2005.<sup>2</sup> In 2004, non-employer firms increased by 3.5 percent and numbered 361,080. Women-Owned Firms. Firms owned by women increased 14 percent between 1997 and 2002, from 108,417 to 123,905; they represented 27.5 percent of the state's total businesses in 2002. These firms (with and without paid employees) generated \$16.3 billion in revenues in 2002. Of the total number of women-owned firms, 13.5 percent or 16,737 firms were employer firms. In 2005, self-employed women totaled 113,332, a decrease of 13.9 percent from 2004, and they represented 34.8 percent of self-employed persons in the state. Minority-Owned Firms.<sup>3</sup> In 2002, Asian-owned firms totaled 7,700 and generated \$1.8 billion in receipts; Blackowned firms numbered 7,837 and generated \$682 million in receipts; and Hispanic-owned businesses totaled 3,984 and created \$463 million in receipts. American Indian- and Alaska Native-owned firms numbered 2,742, and they generated \$319 million in receipts; the number of Native Hawaiian- and other Pacific Islander-owned firms was 119, and they generated \$11 million in receipts in 2002. Business Turnover. New employer businesses in 2005 were estimated at 12,555, which is 17.2 percent less than the previous year. Business bankruptcies increased by 25.3 percent, to 1,721 in 2005, while business terminations increased by 0.6 percent, to 15,302 during the same period. Employment. There were 118,363 employer firms with fewer than 500 employees in 2003;4 they provided 1,230,107 jobs in the state. These firms represented 98.0 percent of the employer businesses in the state and employed 51.6 percent of the state's non-farm private sector workforce (Table 1). Between 2002 and 2003, total small business net new jobs amounted to 36,664 (Table 2). (Source: U.S. Dept. of Commerce, Census Bureau, Statistics of U.S. Businesses.)

Small Business Income. Non-farm proprietors' income, which is a partial measure of small business income, increased by 7.2 percent to \$12.3 billion in 2005. (Source: U.S. Dept. of Commerce.)

Finance.<sup>5</sup> Two important sources of small business financing are commercial banks and savings and loan institutions. which owners rely on for their financial needs. The total number of operating bank and savings bank branches in the state increased in 2005 (Table 3).
