Small Business Profile: VERMONT

Entrepreneurs, innovators, and small businesses are key players in the economy of Vermont. They make up most of the employer firms in the state, and their contribution is indispensable. Their diverse composition and the spectrum of opportunities they offer are captured in this *Small Business Profile*, using the most current federal data available.

Number of Businesses. The state had an estimated total of 79,000 small businesses based on the most recent data. Firms with employees numbered 21,451 in 2005, of which an estimated 96.8 percent or 20,765 were small firms (fewer than 500 employees). Self-employment (including incorporated) increased by 8.4 percent, from 48,091 in 2004 to 52,112 in 2005. In 2004, non-employer firms increased by 3 percent and numbered 58,319. Women-Owned Firms. Firms owned by women increased 12 percent between 1997 and 2002, from 17,030 to 18,989; they represented 26.3 percent of the state's total businesses in 2002. These firms (with and without paid employees) generated \$1.5 billion in revenues in 2002. Of the total number of women-owned firms, 13 percent or 2,478 firms were employer firms. In 2005, self-employed women totaled 18,227, an increase of 18.6 percent from 2004, and they represented 35.0 percent of self-employed persons in the state. Minority-Owned Firms.³ In 2002, Asian-owned firms totaled 433 and generated \$67 million in receipts; Black-owned firms numbered 211 and generated \$21 million in receipts; and Hispanic-owned businesses totaled 452 and created \$38 million in receipts. American Indian- and Alaska Native-owned firms numbered 299, and they generated \$44 million in receipts; the number of Native Hawaiian- and other Pacific Islander-owned firms was 43, and they generated \$1million in receipts in 2002. ¹ The Office of Advocacy's estimated total of state small businesses is based on the percent of small businesses (2003 Census firm size data) multiplied by the state's total number of employer businesses in 2005 (Dept. of Labor). The 2004 number of non-employer firms is added to this total (Census Bureau).

Business Turnover. New employer businesses in 2005 were estimated at 1,911, which is 17.7 percent less than the previous year. Business bankruptcies decreased by 8.2 percent, to 78 in 2005, while business terminations decreased by 9.0 percent, to 2,346 during the same period. Employment. There were 18,602 employer firms with fewer than 500 employees in 2003;⁴ they provided 160,787 jobs in the state. These firms represented 96.8 percent of the employer businesses in the state and employed 62.7 percent of the state's non-farm private sector workforce (Table 1). Between 2002 and 2003, total small business net new jobs amounted to 1,474 (Table 2). (Source: U.S. Dept. of Commerce, Census Bureau, Statistics of U.S. Businesses.)

Small Business Income. Non-farm proprietors' income, which is a partial measure of small business income, increased by 8.1 percent to \$1.7 billion in 2005. (Source: U.S. Dept. of Commerce.)

Finance.⁵ Two important sources of small business financing are commercial banks and savings and loan institutions, which owners rely on for their financial needs. The total number of operating bank and savings bank branches in the state increased in 2005 (Table 3).
