Small Business Profile: ALASKA

Small businesses are the heart of Alaska's economy. Research by the Office of Advocacy shows that small businesses create most of the nation's net new jobs, and they bring dynamic ideas, innovative services, and new products to the marketplace. They account for almost all of the nation's employer firms and generate half of non-farm private output. New business creation is key to a state's ability to increase its gross state product, state personal income, and total state employment. This small business profile uses the most recent data available to demonstrate the valuable contributions that small businesses make to Alaska's economic health.

Number of Businesses. Alaska had an estimated total of 67,300 small businesses.² Employer firms totaled 17,100 in 2006, up 1.2 percent from the previous year. Of this total, an estimated 97.0 percent, or 16,600, were small. Self-employment (incorporated and unincorporated) totaled 44,600 in 2006, an increase from 44,000 in 2005. Non-employer firms totaled 50,900 in 2005, an increase of 1.6 percent since 2004. Women-owned Firms. In 2002, businesses owned by women numbered 16,300, represented 26.3 percent of the state's 62,100 businesses, and generated \$2.3 billion in revenues. Employer firms owned by women totaled 2,900, an increase of 4.4 percent since 1997. Women numbered 16,500 or 37.0 percent of the state's self-employed persons in 2006, a decrease of 2.8 percent from the previous year. Minority-owned Firms.³ In 2002, Asian-owned firms totaled 1,900, and 600 of them were employer firms; Black-owned firms numbered 900, and 100 were employer firms; Hispanic-owned firms totaled 1,200, and 300 were employer firms. American Indian and Alaska Native-owned firms numbered 5,200, and 700 of them were employer firms. Native Hawaiian

and other Pacific Islander-owned businesses numbered 150, and 30 were employer firms. (Source: U.S. Dept. of Commerce, Census Bureau.)

Business Turnover. An estimated 1,904 new employer firms were created in 2006, which is 3.9 percent less than the number created in 2005. Business bankruptcies totaled 45 in 2006, down from 83 the previous year, while business terminations decreased from 2,300 in 2005 to 2,200 in 2006. Employment. Small firms employed 59.5 percent of the state's non-farm private labor force in 2004, which was above the national average of 50.9 percent.⁴ These 16,000 firms accounted for 97.0 percent of the state's employer businesses, and they employed 132,700 people (Table 1). Small businesses added a total of 5,800 net new jobs between 2003 and 2004 (Table 2). (Source: U.S. Dept. of Commerce, Census Bureau, Statistics of U.S. Businesses.)

Small Business Income. Non-farm proprietors' income, which is a share of small business income, remained unchanged in 2005 and 2006 at \$2.4 billion.⁵ (Source: U.S. Dept. of Commerce.)

Finance. Commercial banks and savings institutions continued to be important sources of small business financing. The number of lending institution branches in the state decreased in 2006 (Table 3). ² This estimate is based on the percent that small businesses are of the state's total businesses (see Table 1, 2004 firm size data). This percentage is multiplied by the total number of employer businesses in 2006 (Dept. of Labor). The 2005 number of non-employer firms is added to this total (Census Bureau).

³ The groups should not be added together or double counting will result, since owners may belong to more than one minority group.
