Small Business Profile: ARIZONA

Small businesses are the heart of Arizona's economy. Research by the Office of Advocacy shows that small businesses create most of the nation's net new jobs, and they bring dynamic ideas, innovative services, and new products to the marketplace. They account for almost all of the nation's employer firms and generate half of non-farm private output. New business creation is key to a state's ability to increase its gross state product, state personal income, and total state employment. This small business profile uses the most recent data available to demonstrate the valuable contributions that small businesses make to Arizona's economic health.

Number of Businesses. Arizona had an estimated total of 473,000 small businesses.² Employer firms totaled 128,800 in 2006, up 9.0 percent from the previous year. Of this total, an estimated 97.3 percent, or 125,300 were small. Self-employment (incorporated and unincorporated) totaled 280,400 in 2006, a decrease from 301,000 in 2005. Non-employer firms totaled 358,100 in 2005, an increase of 7.0 percent since 2004. Women-owned Firms. In 2002, businesses owned by women numbered 109,700, represented 28.8 percent of the state's 381,200 businesses, and generated \$15.8 billion in revenues. Employer firms owned by women totaled 15,700, an increase of 10.0 percent since 1997. Women numbered 97,500 or 34.8 percent of the state's self-employed persons in 2006, a decrease of 8.5 percent from the previous year. Minority-owned Firms.³ In 2002, Asian-owned firms totaled 10,200, and 3,200 of them were employer firms; Black-owned firms numbered 6,300, and 600 were employer firms; Hispanic-owned firms totaled 35,100, and 5,000 were employer firms. American Indian and Alaska Native-owned

firms numbered 6,500, and 500 of them were employer firms; while Native Hawaiian and other Pacific Islander-owned businesses numbered 350, and 100 were employer firms. (Source: U.S. Dept. of Commerce, Census Bureau.)

Business Turnover. An estimated 21,555 new employer firms were created in 2006, which is 1.0 percent more than the number created in 2005. Business bankruptcies totaled 261 in 2006, down from 525 the previous year, while business terminations increased from 18,200 in 2005 to 52,400 in 2006. Employment. Small firms employed 49.0 percent of the state's non-farm private labor force in 2004, which was below the national average of 50.9 percent.⁴ These 98,400 firms accounted for 97.3 percent of the state's employer businesses, and they employed 1.0 million people (Table 1). Small businesses added a total of 64,200 net new jobs between 2003 and 2004 (Table 2). (Source: U.S. Dept. of Commerce, Census Bureau, Statistics of U.S. Businesses.)

Small Business Income. Non-farm proprietors' income, which is a share of small business income, increased by 4.0 percent, from \$15.1 billion in 2005 to \$15.7 billion in 2006.⁵ (Source: U.S. Dept. of Commerce.)

Finance. Commercial banks and savings institutions continued to be important sources of small business financing. The number of lending institution branches in the state increased in 2006 (Table 3).
