Small Business Profile: WISCONSIN

Small businesses are the heart of Wisconsin's economy. Research by the Office of Advocacy shows that small businesses create most of the nation's net new jobs, and they bring dynamic ideas, innovative services, and new products to the marketplace. They account for almost all of the nation's employer firms and generate half of non-farm private output. New business creation is key to a state's ability to increase its gross state product, state personal income, and total state employment. This small business profile uses the most recent data available to demonstrate the valuable contributions that small businesses make to Wisconsin's economic health.

Number of Businesses. Wisconsin had an estimated total of 447,200 small businesses.² Employer firms totaled 130,000 in 2006, up 1.8 percent from the previous year. Of this total, an estimated 98.0 percent, or 127,400 were small. Self-employment (incorporated and unincorporated) totaled 339,100 in 2006, a decrease from 341,600 in 2005. Non-employer firms totaled 322,000 in 2005, an increase of 3.6 percent since 2004. Women-owned Firms. In 2002, businesses owned by women numbered 104,200, represented 26.5 percent of the state's 393,200 businesses, and generated \$17.6 billion in revenues. Employer firms owned by women totaled 16,900, an increase of 9.2 percent since 1997. Women numbered 117,900 or 34.8 percent of the state's self-employed persons in 2006, a decrease of 7.6 percent from the previous year. Minority-owned Firms.³ In 2002, Asian-owned firms totaled 5,000, and 1,800 of them were employer firms; Black-owned firms numbered 6,700, and 900 were employer firms; Hispanic-owned firms totaled 3,800, and 900 were employer firms. American Indian and Alaska Native-owned firms

numbered 2,500, and 400 of them were employer firms; while Native Hawaiian and other Pacific Islander-owned businesses numbered 100, and 10 were employer firms. (Source: U.S. Dept. of Commerce, Census Bureau.)

Business Turnover. An estimated 13,371 new employer firms were created in 2006, which is 2.1 percent less than the number created in 2005. Business bankruptcies totaled 307 in 2006, down from 820 the previous year, while business terminations decreased from 13,400 in 2005 to 13,100 in 2006. Employment. Small firms employed 53.9 percent of the state's non-farm private labor force in 2004, which was above the national average of 50.9 percent.⁴ These 115,300 firms accounted for 98.0 percent of the state's employer businesses, and they employed 1.3 million people (Table 1). Small businesses added a total of 36,400 net new jobs between 2003 and 2004 (Table 2). (Source: U.S. Dept. of Commerce, Census Bureau, Statistics of U.S. Businesses.)

Small Business Income. Non-farm proprietors' income, which is a share of small business income, increased by 3.4 percent, from \$11.7 billion in 2005 to \$12.1 billion in 2006.⁵ (Source: U.S. Dept. of Commerce.)

Finance. Commercial banks and savings institutions continued to be important sources of small business financing. The number of lending institution branches in the state increased in 2006 (Table 3).
