Advocacy: the voice of small business in government

Illinois

Illinois's 1.1 million small businesses provide economic opportunities to diverse groups of people and bring innovative products and services to the marketplace.* This profile from the Office of Advocacy compiles the latest facts and figures on the status and role of small business in the state. (Note that a small business is defined here as one with fewer than 500 employees.)

- Illinois had 258,096 small employers in 2005, representing 98.4% of the state's employers and 49.6% of its private-sector employment.
- The manufacturing industry was the state's largest small business employer in 2005; health care and social assistance was the largest overall employer (Table 1).
- Small businesses' net new jobs declined between 2004 and 2005 (Table 2).
- Illinois's real gross state product increased by 1.5% in 2007. By comparison, growth in the Great Lakes regon was 0.5% and the United States, 2.0%. (Source: U.S. Dept. of Commerce: Bureau of Economic Analysis)
