## U.S. Territories

Small businesses in the U.S. territories provide economic opportunities to diverse groups of people and bring innovative products and services to the marketplace. This profile from the Office of Advocacy compiles the latest facts and figures on the status and role of small business.\*

• Puerto Rico has the largest economy of the U.S. territories. Puerto Rico had more business establishments and employment than 14 states in 2006.

• The economies of the Virgin Islands and Guam fared better from 2006 to 2007 than Puerto Rico's, as employment rose and business bankruptcies declined in both.

• The number and value of small business loans in the Virgin Islands underwent a large increase in 2007, which has been attributed to the presence of a new lender in the market.

• American Samoa had 589 employer establishments in 2002. The number of small business loans went from 121 in 2006 to 129 in 2007, while the total dollar value decreased from \$3.87 million to \$3.78 million.

\*Due to limited firm size information, the number of business establishments is used as a proxy to represent the number of small businesses. In the United States in 2005, firms with fewer than 500 employees operated 86 percent of all establishments.
