

# Networx Transition Update

September 27, 2007 Bulletin Two

#### Introduction

This bulletin provides transition guidance information, transition progress and status of issues related to the transition of services to the General Services Administration's (GSA) Federal Acquisition Service (FAS) Integrated Technology Services (ITS) Networx contracts.

### NETWORX CONTRACTOR UPDATE

Agencies able to place orders off Universal contract - All Universal contractors--AT&T, Qwest, and Verizon--completed final Operations System Support (OSS) Validation Testing as of September 14, 2007. Satisfactorily completing the OSS Validation and C&A Testing is the achievement of a significant and important milestone. A special "Thank You" to IMC/TWG members, our Universal contractors and others who worked together to defined requirements and cooperatively achieve these test results.

Additionally, each Networx Universal contractor successfully passed GSA's Certification & Accreditation (C&A) Testing and therefore received GSA's "Authority to Operate" (ATO) on September 4, 2007. GSA conducted an initial C&A of the three Networx Universal OSS at a NIST "Moderate" impact level in order to provide maximum leverage to the broadest range of agency customers. As you may know, under FISMA, each agency is accountable for ensuring agency information processed or stored by an OSS is adequately safeguarded and residual risks to agency operations and assets are acceptable. If the agency deems appropriate, it may grant ATO based on acceptance of GSA's Certification Memo and ATO Memo. Agencies may reuse GSA's analysis to assist with their C&A, if more certification is required.

Consequently, once agencies have determined their own "Authority to Operate" and completed their fair opportunity decisions, they may order services off the contracts. In turn, Networx Universal contractors are authorized to fulfill these orders.

While target dates for making fair opportunity decisions vary by agency depending on complexity and agency mission requirements, we recommend that agencies target the completion of fair opportunity decisions to the extent possible for March 2008. We believe that if a large number of decisions are made after that date, agencies may not have sufficient time to complete transition for those services prior to the expiration of the FTS2001 Bridge/Crossover contracts.

### TRANSITION GUIDANCE PUBLICATIONS

Designated Agency Representative Guidelines – This document provides supplemental guidance in the establishment of titles, roles, and responsibilities of telecommunications services ordering officials. These guidelines apply to individuals who have been appointed as Designated Agency Representatives (DARs), who have been authorized, in accordance with agency regulations and policies, to place orders for telecommunications services under a Network Services contract. The Network Services contracts specify that the contractor may only accept orders from authorized personnel. Agencies may refine the provisions of this document for specific activities within their purview, as long as the provisions are in conformance with this document, the contract requirements, and any other applicable policies and laws. Taxonomy and Allocation of Transition Costs - This document describes the taxonomy and allocation of cost elements for the transition from existing legacy Federal Technology Services (FTS) long distance telecommunications contracts to successor Networx contracts as established

by our Interagency Management Council (IMC). The document specifies cost elements and cost allocations that will be borne by GSA and Government Agencies and the criteria an agency must meet to receive these cost allocations. ### **GSA GUIDANCE**

The General Accountability Office (GAO) has informed GSA it will gather information from agencies and GSA that relate to:

- To what extent are agencies ready for transition and are following "Best Practices?
- What challenges are agencies facing and to what extent are they being addressed?

GAO also advises GSA to identify measures to evaluate progress towards program goals. And GSA should ensure guidance addresses the establishment of measures of success to help agencies' managers assess progress toward the objectives stated in their plans.

Consistent with these recommendations, GSA asks agencies to provide an estimate of the number of fair opportunity decisions each agency plans to make and when these decisions will be made. Please send your response to <a href="mailto:networx.support@gsa.gov">networx.support@gsa.gov</a>.

GSA further advises agencies to have internal guidance that addresses the establishment of measures of success to help agency managers assess progress toward the objectives stated in their transition management plans.

# TRANSITION INVENTORY

TBI Validation - To assist Agencies' successful use of the TBI application, GSA has implemented an Inventory Assistance Team (IAT) at GSA's Fairfax office where TBI users can work on their inventory hand-in-hand with a TBI specialist.
