CURRENT SITUATION

Regional Update

- As of January 9, the U.N. World Health Organization (WHO) reports that health networks in affected countries remain vigilant, and although cases of some diseases are increasing, no outbreaks have been reported. Injuries sustained during the tsunami still account for many health care needs, and access to treatment remains critical to avoid deaths due to tetanus and to limit potential long term disability. WHO also emphasized the need to increase access to safe drinking water and prevent diseases caused by inadequate sewage and waste disposal.
- On January 9, the U.N. World Food Program (WFP) announced a new Humanitarian Air Hub at the Subang Air Base in Kuala Lumpur, Malaysia. The hub is dedicated to serving the U.N. and other relief agencies sending supplies to Indonesia and other affected countries. The air hub will be managed jointly by WFP, the Royal Malaysian Air Force, the U.N. Humanitarian Air Service (UNHAS), and the U.N. Joint Logistics Center (UNJLC). Indonesia Update

- On January 9, USAID/OFDA Director Ken Isaacs traveled with the USAID Disaster Assistance Response Team (USAID/DART) to Halim military airport in Jakarta to observe ongoing relief operations. The Director met with U.S. Air Force and New Zealand Air Force officials and discussed the present status of air operations from Jakarta
- On January 8, the USAID/DART in Banda Aceh conducted an assessment by helicopter in conjunction with the U.S. Navy. The assessment covered the coastal region between Banda Aceh to the village of Teunom on the west coast. The assessment team determined that approximately 50 percent of the roads in the area were intact and passable but that bridges appeared between 80 and 90 percent impassable. In addition, small inland waterways were blocked by debris that overflowed into adjacent rice fields. The USAID/DART concluded that the tsunami destroyed an estimated 13 large villages and 35 small villages in the region. During the mission, the assessment team delivered 200 boxes of noodles donated by Buddhist Relief and 23 five-gallon containers of water provided by USAID to the Acehpya village. Acehpya has a population of approximately 500 adults and 200 children and was not directly affected by the tsunami due to a natural ridge in the land that protected the village from the sea.
- On January 9, UNJLC reported that the Banda Aceh Airport needs additional storage tents and equipment to offload emergency relief supplies. UNJLC noted that the road between Banda Aceh and Meulaboh is inaccessible due to severe damage from the December 26 earthquake and aftershocks.

Sri Lanka Update

On January 9, the Asia-Pacific Centre for Emergency and Development Information (APCEDI) reported that a tropical cyclone has formed off the southeast coast of Sri Lanka. Although this is considered a minimal strength

cyclone, APCEDI warns that there is a high risk of heavy rain that could possibly result in coastal and inland flooding. APCEDI has warned that the storm could also pose a threat to Tamil Nadu and Kerala states in India. *India Update*

- According to the USAID/DART, from December 26 to January 9, there have been 126 earthquakes of a 5 point magnitude or higher in the Andaman and Nicobar Islands.
- Relief commodities for the affected island populations are currently sent from Port Blair by ship, according to the USAID/DART. Larger aircraft, such as an IL-76, are unable to land in the Nicobar Islands. The government has announced plans to prepare the runway in Car Nicobar for heavy transport flights in the next two weeks.
- On January 8, Prime Minister Manmohan Singh visited the Andaman Islands and announced a \$45 million relief package for the Andaman and Nicobar Government for implementing immediate rehabilitation measures. The government has yet to make any formal announcement regarding the provision of humanitarian assistance in the Andaman and Nicobar Islands by local or foreign non-governmental organizations (NGOs).
- On January 8, the USAID/DART traveled to Pushpavallam, approximately a one hour drive south of Nagapattinam in Tamil Nadu. Farmers in the village reported that the rice crop has been destroyed and voiced concern that the soil may not be arable next season. Food prices have increased in the village: the price for a kilogram of tomatoes has doubled. Residents are sleeping in relief camps at night and returning to the village during the day to clean up their properties. The residents reported to the USAID/DART that they had received a distribution of relief goods from the government, but it was stolen when they left the village overnight.
- The USAID/DART assessment team also traveled to Stauthur, Tamil Nadu, on January 8. The district government is distributing water to the town. However, according to the USAID/DART, many homes also have a hand pump in the yard, and these pumps need to be assessed and possibly repaired.
- In Nagapattinam, Tamil Nadu, the USAID/DART reports that the district government has abandoned one of the major municipal wells after a mass grave site was dug next to it. The district had disinfected all local wells as a precautionary measure even though none of them were reported to be contaminated.

Maldives Update

• On January 9, OCHA reported that all 120 households on the island of Kolufushi were severely affected: 80 houses require complete reconstruction while 40 need repairs. In addition, extensive cleaning is required due to the large amount of waste and debris.

USG ASSISTANCE

USAID Response

- To date, USAID has provided more than \$13.4 million to support region-wide emergency relief efforts. The USAID/DART and the U.S. military continue to conduct needs assessments and provide supplies and essential logistic support for the relief efforts in affected countries.
- On January 9, the eleventh USAID/OFDA airlift of emergency relief supplies arrived in Utapao, Thailand, to support regional response efforts. The commodities contained in this airlift include 580 rolls of plastic sheeting, 9,520 ten-liter water containers, and 6,624 hygiene kits. The total value of the shipment, excluding transport costs, is \$196,631. The rolls of plastic sheeting will serve 17,400 beneficiaries, the water containers will serve 23,800 beneficiaries, and the hygiene kits will serve 33,120 beneficiaries.

Indonesia

• To date, the USG has provided more than \$22.2 million to support emergency relief activities and the provision of food, water, and relief supplies for affected populations in Indonesia.

Sri Lanka

- To date, USAID has provided more than \$37.1 million in emergency relief assistance to Sri Lanka. *India*
- To date, USAID has provided more than \$3.1 million in emergency relief assistance to India. On January 9, through USAID/India, USAID/OFDA provided \$859,992 to World Vision International (WVI) and \$440,295 to Project Concern International (PCI). WVI will implement a cash-for-work program to provide materials and tools to build temporary shelters in Tamil Nadu. PCI activities in Tamil Nadu will include a cash-for-work program to construct temporary shelters, a livelihood revitalization program to assist fishermen in boat repairs, and educational and recreational services.

Maldives

- USAID's Office of Food for Peace (USAID/FFP) has provided 180 MT of food assistance, valued at \$151,200. Department of Defense (DOD) Humanitarian Assistance
- As of January 8, more than 16,465 U.S. military personnel are involved in providing relief support in the affected region. Of the 2,354 military personnel currently on the ground, 1,339 are in Thailand, 593 are in Sri Lanka, 190 are in Indonesia, and 160 are in Malaysia. With 20 ships and 95 aircraft, the U.S. military has provided a total of 2,146,514 lbs of relief supplies, including 16,455 gallons of water, 433,840 lbs of food, and 1,454,200 lbs of relief supplies to the governments of Indonesia, Sri Lanka, Thailand, and other affected nations as of January 8.

BACKGROUND

- A magnitude 9.0 earthquake on December 26, off the west coast of Northern Sumatra, Indonesia, triggered massive tsunamis that affected several countries throughout South and Southeast Asia, as well as Somalia, Tanzania, and Kenya in East Africa. Aftershocks from the December 26 earthquake continue to occur in the region.
- Based on initial findings of USG assessment teams and on the recommendation of Secretary of State Powell and
 USAID Administrator Natsios, on December 31, President Bush committed \$350 million toward earthquake and
 tsunami relief and recovery efforts. Dollar amounts in this Fact Sheet are part of the total pledge of \$350 million
 and refer to specific funding actions that have been committed and programmed. USAID/OFDA welcomes
 proposals from qualified humanitarian assistance organizations prepared to implement relief activities in response
 to the Indian Ocean Earthquake and Tsunami disaster. Details can be found at www.usaid.gov.
