CURRENT SITUATION

Numbers Affected

Estimates of the numbers of dead and affected continue to fluctuate. On January 11, the Government of Sri Lanka reported that the number of displaced had decreased from 545,492 to 491,008. According to the latest reports, more than 150,000 are reported dead in all affected countries.

Indonesia Update

- On January 11, the USAID Disaster Assistance Response Team (USAID/DART) and USAID/Indonesia staff attended the first meeting of the Joint Disaster Management Center (DMC), co-chaired by the U.N. and the Government of Indonesia's (GOI) Office of the Vice-President. The DMC aims to collect and analyze information from the GOI, the U.N., donors, non-governmental organizations (NGOs), and military and civil defense units.
- GOI officials have requested that countries send teams with medical expertise, mobile clinics, and/or ambulances, rather than additional field hospitals. The GOI has identified the following needs: disinfectant, antiseptics, and food for infants and young children. On January 9, the Australian Agency for International Development delivered the first batch of tetanus toxoid and immunoglobulin to Banda Aceh, a second delivery is scheduled for January 11.
- The U.N. has identified three priorities for Indonesia: to assist displaced persons in formal and informal camps: to support local authorities in establishing relocation centers according to Sphere standards²; and to assist vulnerable people, even in difficult to access areas. The U.N. High Commissioner for Refugees (UNHCR) has made available shelter materials for 100,000 people. The U.N. has emphasized a preference to settle people into temporary settlements while building long-term resettlement structures. The GOI has expressed concern that some of the locations identified are prone to flooding.

Sri Lanka Update

On January 7, the USAID/DART reported that most districts have their own coordinating systems and that water boards are engaged in relief activities. The U.N. Children's Fund (UNICEF) is currently the lead U.N. agency in the water and sanitation sector. The USAID/DART also reported that hygiene education was discussed and that camp managers were encouraged to promote hygiene education. In addition, the USAID/DART noted that the Ministry of Urban Development and Water Supply and the Ministry of Health (MOH) are charged with coordinating and promoting the same message. A working group that includes NGOs, UNICEF, and the MOH has been formed to develop a promotional message and distribute materials to all partners working in health and hygiene education.

- On January 8, the USAID/DART traveled to Galle District in southern Sri Lanka and reported that communities are
 rebuilding in nearly all villages between Galle and Colombo. The USAID/DART observed communities clearing
 sewer and drainage systems in Balapitiya, repairing roads and bridges in Ambalangoda, stripping buildings of
 damaged materials, and constructing new walls in Kosgoda. In the community of Beruwala, where the majority of
 the fishing fleet was grounded and/or destroyed, the USAID/DART observed cranes hauling boats from beaches
 and placing them on flatbed trucks for transport.
- On January 9, the USAID/DART visited camps for displaced persons operated by USAID/OFDA partners in Galle, southern Sri Lanka. Based on conversations with local officials, the USAID/DART reported that resettling displaced persons and restoring basic services are the primary concerns for the 28,000 people temporary housed in 100 camps in Galle. Displaced persons residing in schools are being moved to other locations, as schools are scheduled to restart by mid-January. Local officials told the USAID/DART that 1,000 tents would be distributed as shelter for people who are relocated. The USAID/DART also noted the Government of Sri Lanka (GOSL) is providing one male and one female latrine for every 25 people in camps and is building latrines with assistance from the Indian Army. The local government also reportedly plans to establish temporary camps and provide dry rations and kitchen utensils to displaced persons until they secure more permanent housing.
- On January 9, the USAID/DART conducted an assessment of a displaced persons camp operating out of Sri Pushparama Malwenna Temple, near Hikkaduwa north of Galle. The USAID/DART reported that 250 people reside at the camp, although many registered displaced persons living outside the camp also receive assistance from the camp. The USAID/DART reported that water was available at two water points and that the water tested by the USAID/DART was adequately chlorinated. However, the USAID/DART noted that only 2 out of 4 latrines were usable for all 250 residents, well below the Sphere standard minimum of 13 latrines for that number.
- Based upon the USAID/DART's observations in Galle and through discussions with various local authorities, water supply is not a critical need. However, sanitation, human waste, and solid waste removal are still concerns. The USAID/DART will continue to focus upon sanitation and the rehabilitation of existing solid waste systems, construction of new solid waste systems, and pumping of sewage facilities.

India Update

- From December 30 to January 9, the USAID/DART conducted assessments in Tamil Nadu State and reported that shelter, livelihoods, and psycho-social issues remain concerns. Water and sanitation remain an important issue, but state and district authorities are making repairs and disinfecting wells. The USAID/DART has discussed minor gaps, including the disinfection of private water sources and the provision of water and sanitation in camp settings, with local government officials and NGO partners and is confident these needs will be addressed.
- Given more than 250 NGOs are involved in relief efforts in Tamil Nadu, there is concern about possible duplication of activities. USAID/India and the USAID/DART have communicated to partners that all activities must be carefully coordinated with other NGOs and local government authorities.
- On January 9, the Government of India convened a meeting of all political parties to discuss relief, rehabilitation, and reconstruction efforts in tsunami-affected areas. The government announced plans to establish a National Disaster Management Authority. In addition, the Ministry of Science and Technology will begin investigating the establishment of a tsunami warning center. On January 10, the government pledged to transport donated materials at no cost if donors designate as consignees the Relief Commissioners or District Magistrates of the affected areas.
- On January 11, the USAID/DART and USAID/India met with the U.N. Development Program (UNDP) to discuss coordination of relief and recovery activities and the current status of the response. UNICEF has been leading the U.N.'s response during the relief phase, but this leadership role will shift to UNDP for recovery and rehabilitation operations. During the emergency and transition to recovery phase, UNDP is primarily focused on coordination and psycho-social concerns but will also look at shelter, livelihoods, and environmental needs. In addition, UNDP is examining trafficking in persons concerns with the International Organization for Migration (IOM).

USG ASSISTANCE

USAID Regional Response

• The USAID/DART and the U.S. military continue to conduct needs assessments and provide supplies and essential logistic support for the relief efforts in affected countries.

Indonesia

To date, the USG has provided more than \$30.9 million to support emergency relief activities and the provision of food, water, and relief supplies for affected populations in Indonesia. On January 11, as part of USAID/OFDA's contribution to UNHCR's regional appeal, USAID/OFDA designated \$2 million for emergency shelter programs in Indonesia.

Sri Lanka

• To date, USAID has provided more than \$38.1 million in emergency relief assistance to Sri Lanka. On January 11, as part of USAID/OFDA's contribution to UNHCR's regional appeal, USAID/OFDA designated \$1 million for emergency shelter programs in Sri Lanka.

India

- To date, USAID has provided more than \$3.1 million in emergency relief assistance to India. *Somalia*
- On January 11, as part of USAID/OFDA's contribution to UNHCR's regional appeal, USAID/OFDA provided \$200,000 for emergency shelter programs in Somalia.

Department of Defense (DOD) Humanitarian Assistance

• As of January 11, more than 15,156 U.S. military personnel are involved in providing relief support in the affected region. Of the 2,464 military personnel currently on the ground, 1,327 are in Thailand, 562 are in Sri Lanka, 362 are in Indonesia, and 213 are in Malaysia. With 26 ships and 94 aircraft, the U.S. military has delivered a total of 1,799,032 lbs of relief supplies to the governments of Indonesia, Sri Lanka, Thailand, and other affected nations, including 7,685 gallons of water, 73,780 lbs of food, and 108,915 lbs of relief supplies in the last 24 hours.

BACKGROUND

- A magnitude 9.0 earthquake on December 26, off the west coast of Northern Sumatra, Indonesia, triggered massive tsunamis that affected several countries throughout South and Southeast Asia, as well as Somalia, Tanzania, and Kenya in East Africa. Aftershocks from the December 26 earthquake continue to occur in the region.
- Based on initial findings of USG assessment teams and on the recommendation of Secretary of State Powell and
 USAID Administrator Natsios, on December 31, President Bush committed \$350 million toward earthquake and
 tsunami relief and recovery efforts. Dollar amounts in this Fact Sheet are part of the total pledge of \$350 million
 and refer to specific funding actions that have been committed and programmed. USAID/OFDA welcomes
 proposals from qualified humanitarian assistance organizations prepared to implement relief activities in response
 to the Indian Ocean Earthquake and Tsunami disaster. Details can be found at www.usaid.gov.
