Haiti - Storms

KEY DEVELOPMENTS

- On September 26, a third USAID/OFDA-chartered aircraft arrived in Port au Prince with 5,088 hygiene kits, 4,350 ten-liter water containers, and three 10,000-liter water bladders from the USAID/OFDA warehouse in Miami, Florida. Worth more than \$96,000, including transport, the additional contribution will benefit an estimated 30,000 people. The International Organization for Migration (IOM) is delivering the commodities to affected populations.
- On September 24, staff from the USAID Disaster Assistance Response Team (USAID/DART) and U.S. Centers for
 Disease Control and Prevention (CDC) traveled to Ennery and Saint Michel de L'Attalaye, Artibonite Department,
 to assess humanitarian conditions. On September 25, the USAID/DART conducted additional assessments in Anse
 Rouge and Terre Neuve, Artibonite Department. Results of the assessments will be available in the coming days.
- USAID/OFDA recently provided nearly \$160,000 to the Pan American Development Foundation (PADF) to support the provision of emergency shelter materials for 10,000 people as well as relief supplies including tools for debris cleaning, first aid kits, and kitchen utensils, benefiting 15,000 people. USAID/OFDA provided more than \$660,000 to the World Concern Development Organization to improve household food security and livelihoods for approximately 5,700 farmers affected by Hurricane Hanna.
- USAID/OFDA is committing nearly \$2 million to CHF to provide livelihood assistance and support the recovery of critical social infrastructure such as roads, canals, and schools in Gonaïves, Artibonite Department, and Port Goave, West Department. This program will benefit nearly 50,000 people, including 37,000 IDPs. In addition, USAID/OFDA has committed \$600,000 to Save the Children/U.S. (SC/US) to provide child friendly spaces in Artibonite, South East, and West Departments. The program will benefit 20,000 people, including 5,000 children.
- To date, the total value of U.S. Government (USG) humanitarian assistance in response to recent storms is more than \$30.4 million.

CURRENT SITUATION

- According to OCHA, emergency food assistance is reaching beneficiaries in areas of Artibonite Department that
 were previously inaccessible due to road and infrastructure damage.
- On September 24, USAID/DART and USAID/Haiti staff met with the director of the GOH Office of Civil
 Protection (DPC) to review USAID/OFDA humanitarian response efforts in Haiti. The DPC director expressed
 gratitude for USAID/OFDA's continued support and requested USAID/OFDA assistance in conducting a review of
 the damage assessment and needs analysis processes for the current response. The director also requested
 USAID/OFDA support in pre-positioning relief commodities for the remainder of the hurricane season.

Food Security

- On September 23, the GOH Ministry of Agriculture (MOA) reported that between 2.8 and 3.3 million people are moderately or extremely food insecure following the recent storms, a 15 percent increase from mid-August.
- According to OCHA, food commodity prices in Gonaïves have significantly increased following the series of storms and hurricanes that passed over the country from August 26 to September 7. The price of one kilogram of rice has increased by approximately 50 percent, while the cost of beans has increased by more than 40 percent. Relief agencies are concerned that increases in food commodity prices could cause further food insecurity in Haiti.
- According to the GOH MOA, flooding destroyed 63,000 hectares of crops. The anticipated crop loss is between 10 and 30 percent of the national annual production, given normal weather for the remainder of the year.
- In response to the need for emergency food assistance due to recent storms, USAID/FFP is providing a \$14 million contribution of P.L. 480 Title II emergency food assistance. The contribution will enable USAID/FFP to meet 40 percent of the food requirements as set out in the U.N. flash appeal launched on September 12.

Logistics and Relief Supplies

- As of September 26, the USG had transported 1,608.1 MT of emergency relief commodities provided by USAID/OFDA, the U.N. World Food Program (WFP), and multiple relief organizations on 126 missions to and within Haiti using a combination of DOD and DHS air and sea assets as well as three USAID/OFDA-chartered aircrafts. The USS Kearsarge is departing on September 26.
- As of September 24, WFP had distributed more than 2,263 MT of food assistance, potable water, and other relief commodities throughout Haiti to an estimated 449,854 beneficiaries countrywide, including an estimated 1,047 MT to approximately 274,066 beneficiaries in Gonaïves.
- The USAID/DART is working with implementing partner IOM to position relief commodities to respond to current humanitarian needs. The USAID/DART will continue to assess the need for additional relief commodities.
- On September 24, the Canadian vessel St. John departed Port au Prince on a fourth mission to deliver 122 MT of WFP food commodities. The shipment is scheduled to arrive in Belle Anse, Southeast Department for distribution to beneficiaries in coordination with local authorities.
- Two WFP-chartered helicopters have arrived in Haiti to assist with the transport of emergency relief supplies.

Shelter

- According to OCHA, recent storms have affected an estimated 26,000 people in Saint Michel de L'Attalaye,
 Artibonite Department. Approximately 750 IDPs are residing in two temporary shelters in the department. On
 September 24, OCHA reported that priority humanitarian needs in Saint Michel de L'Attalaye include nutrition and
 water, sanitation, and hygiene (WASH) interventions.
- In Ennery, Artibonite Department, 363 IDPs are residing in six temporary shelters and require WASH interventions, according to OCHA.

WASH

- At a U.N. Children's Fund (UNICEF) WASH meeting on September 23, participants stressed that sanitation remains a significant concern, particularly in Gonaïves. Oxfam reported that latrine installation has commenced in several shelters in Gonaïves and noted that other non-governmental organizations will begin latrine construction in the coming days. Participants at the September 23 meeting stressed the need for a thorough assessment of WASH needs in Chardonnieres and Tiburon, Grand Anse Department, and noted that the storms had destroyed all water system networks in the area between Tiburon and to Coteaux, Grand Anse Department.
- The Canadian Coast Guard has agreed to transport UNICEF, CARITAS, and Catholic Relief Services WASH
 commodities to Tiburon, Chardonnieres, and Port à Piment, Grand Anse Department, including 20,000 liters of
 potable water and 150,000 water purification tablets.

USG HUMANITARIAN ASSISTANCE SUMMARY Haiti

- On September 2, U.S. Ambassador Janet A. Sanderson issued a disaster declaration in response to Hurricane Gustav
 and resulting flooding throughout Haiti. In total, the USAID/DART is working to program \$10 million in funding
 from USAID/OFDA for programs to assist disaster-affected populations in Haiti.
- On September 4, a USAID/OFDA-chartered aircraft arrived in Port au Prince, delivering USAID/OFDA emergency relief supplies including 5,088 hygiene kits, 10,800 ten-liter water containers, and 500 rolls of plastic sheeting. Worth nearly \$335,000 including transport, the supplies were transported to affected areas with assistance from the U.S. Coast Guard and implementing partner IOM. On September 11, a second USAID/OFDA-chartered aircraft arrived with 10,200 ten-liter water containers, 5,088 hygiene kits, 700 rolls of plastic sheeting, and 2 water bladders, valued at more than \$410,000, including transport. On September 26, a third USAID/OFDA-chartered aircraft arrived with 5,088 hygiene kits, 4,350 water containers, and three water bladders, valued at more than \$96,000, including transport. The airlifts will benefit more than 200,000 people.
- USAID/OFDA provided \$500,000 to the Pan American Health Organization (PAHO) in response to PAHO's appeal for funding to support health activities for individuals affected by Hurricane Gustav and Tropical Storm Hanna. This funding will assist 10,000 people.
- USAID/OFDA committed \$2 million to WFP to augment logistical capacity for delivery of humanitarian aid to
 affected areas.
- USAID/OFDA has also committed \$750,000 to implementing partner World Vision to support the distribution of emergency relief supplies and WASH activities, benefiting nearly 70,000 people.
- USAID/OFDA is also contributing more than \$1.5 million to IOM. This assistance will support shelter and settlements projects as well as humanitarian coordination activities.
- USAID/OFDA is providing \$500,000 in funding to the American Red Cross for emergency relief supplies and logistical support. Programs supported by this funding will benefit 12,000 people in Haiti's Artibonite, Grand Anse, and South East departments.
- On September 7, USAID/OFDA authorized the deployment of a three-person Americas Support Team to Haiti to supplement the U.N. Disaster Assessment and Coordination team based in Gonaïves.
- USAID/Haiti is working to re-direct \$5 million in funds toward food and other assistance to meet critical needs related to the growing humanitarian crisis.
- USAID/FFP is providing an additional \$7 million in response to the U.N. flash appeal. The contribution will enable WFP and private volunteer organization (PVO) partners to respond to relief and recovery food aid needs in Haiti. To date, USAID/FFP has contributed a total of \$14 million for the U.N. flash appeal.
- As of September 25, DOD had provided support worth more than \$1.4 million in response to a USAID request for helicopter transport. The contribution does not include fuel cost for the USS Kearsarge.
