



# 2008 St. Marks National Wildlife Refuge Photo Contest



All entries must be **RECEIVED** by the St. Marks Refuge Association/Photo Club by: December 7, 2008  
Judges will pick winners in the following categories:

- Wildlife
- People: (working or enjoying the refuge (MUST HAVE A MODEL RELEASE)
- Landscape: (Beautiful scenery and stunning vistas
- Small Wonders: (wild flowers, insects, spiders and other small plants and animals.)
- Butterfly's

Each photo submitted must have been taken on or of the St. Marks National Wildlife Refuge in the past year by the person who enters it in the contest. Judges reserve the right to combine or subdivide categories, and judges will decide which category best suits each entry. Judges' decisions are final. Winners will be notified by mail or e-mail.

**FORMAT: Prints only. No frames please.** All entries must be prints 8" x 10" or 8 1/2" x 11". Prints must be mounted on 11" x 14" foam board or mat board with the entry form (and model release) attached to the back.

Young Nature Photographers – The same categories will be set up for young photographers 16 years old and younger. Format: All entries must be prints 4" x 6" or 5" x 7". Prints must be mounted on 8" x 10" Card Stock or mat board with the entry form (and model release) attached to the back.

To submit an entry into the contest, photographers must be 18 years of age or submit a release from a parent or guardian

You will be notified when to pick up your prints or you may wish to donate them to the Association. Donated prints will be up for sale or possible auction with proceeds going into the Association's general fund.

Mail entries to: 2008 Photo Contest, St. Marks NWR Photo Contest PO Box 368 St. Marks, FL 32355 or deliver photos to the Visitors Center at the Refuge. Do not send pictures by e-mail.

Entrant's signature constitutes a release to the St. Marks Refuge Association, St. Marks NWR Photo Club and/or U.S. Fish and Wildlife Service for the right to use, reproduce, publish, and/or display the photographs without further compensation. The original slide or negative may be requested. Scans of entries may be posted on the St. Marks website at low resolution.

**PRIZES** will be awarded in each category and will include gift certificates redeemable for merchandise at the gift shop located at the St. Marks Visitor Center. Best of Show photo will be selected for annual Entrance Pass. One prize per photographer in a single category.

*The Small Print:* Void where prohibited. Contest is open to legal residents of the United States and the District of Columbia. All federal, state, and local laws apply. Each entrant warrants the originality of each entry submitted by him/her and warrants that he/she owns all rights in each such entry. Submission of an entry form of photograph is evidence of entrant's agreement with and acceptance of these rules and regulations. Contestants will be responsible for obtaining and submitting to the St Marks Refuge Association releases of all identifiable persons appearing in photographs, if requested. The St. Marks Refuge Association is not responsible for lost or damaged entries.
