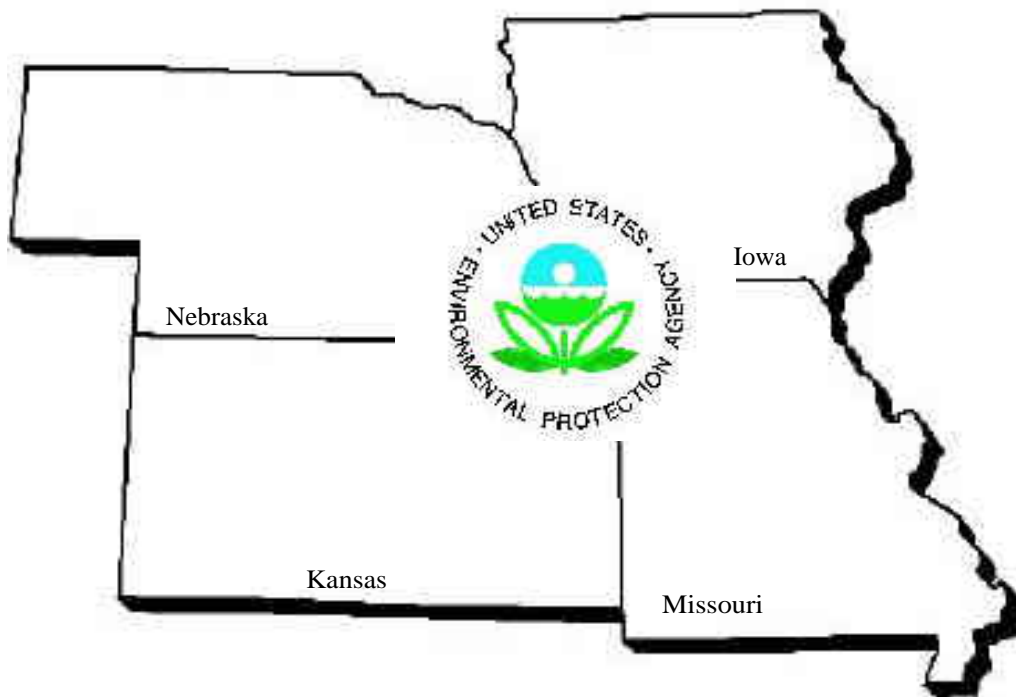


REGION 7 ORGANIZATION CHARTS

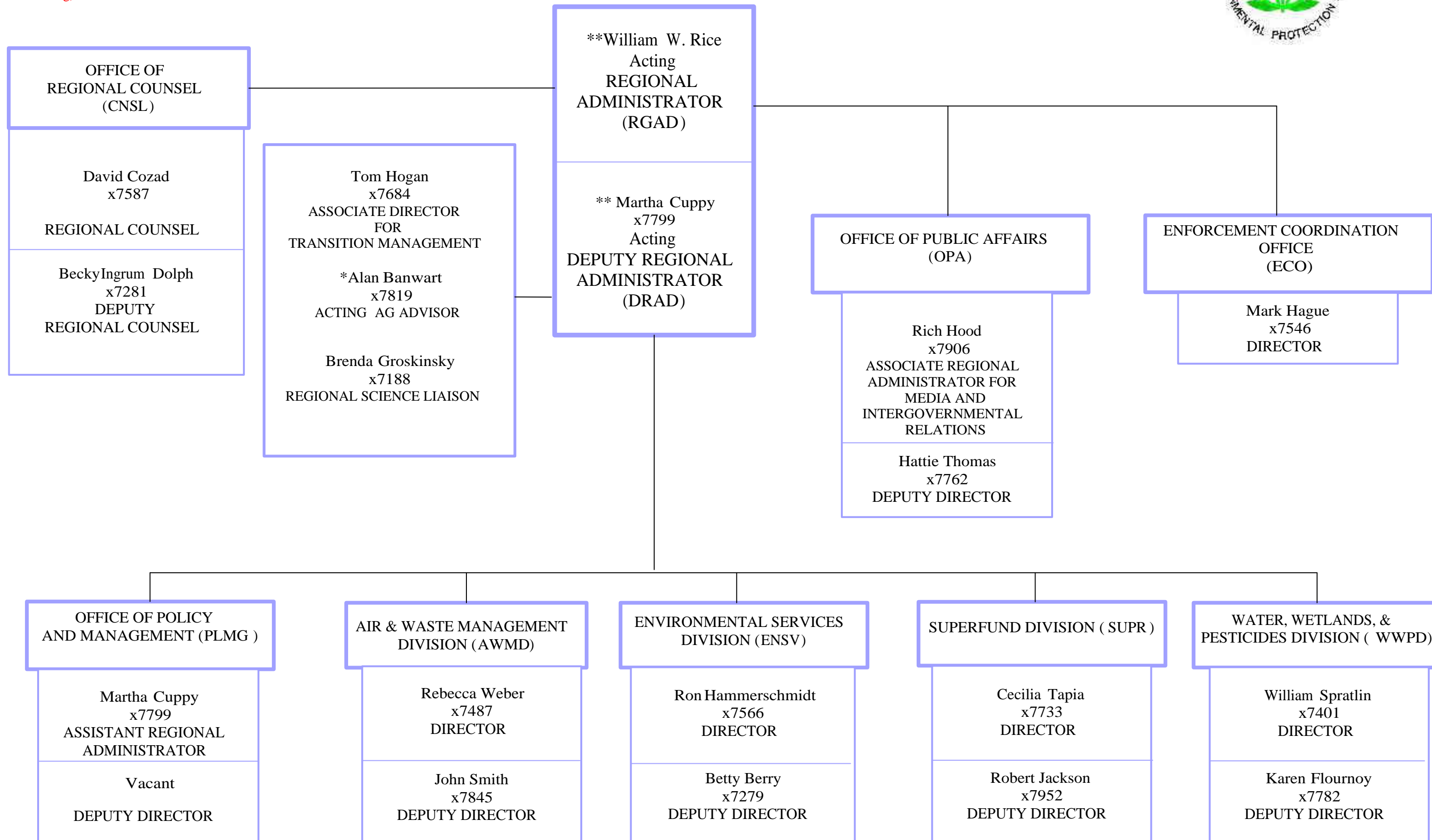

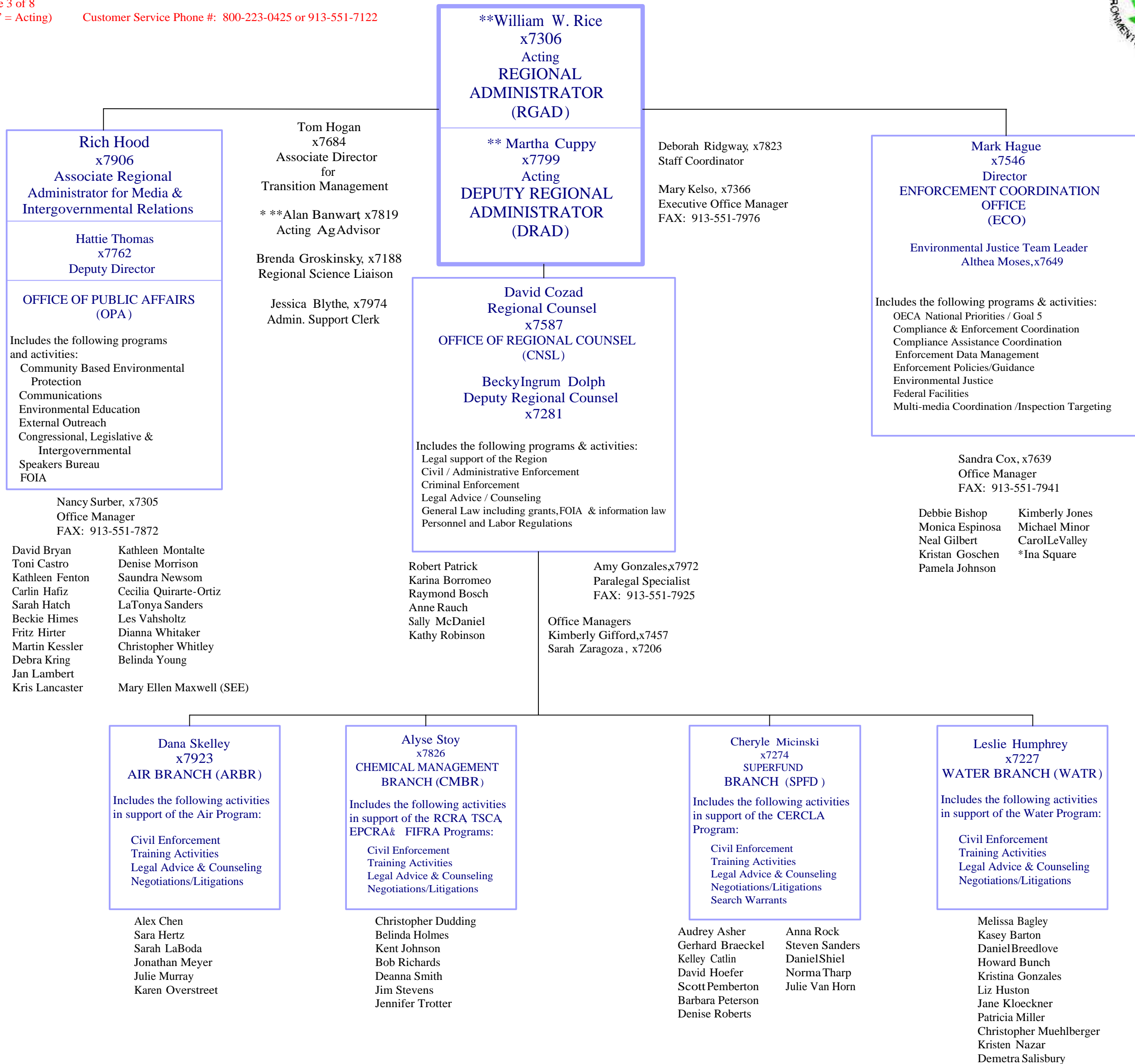
