DEFENDANTS' CONDITIONAL MOTION TO WITHDRAW MOTION TO STRIKE AND REQUEST FOR PROTECTIVE ORDER

On February 24, 2004, Defendants moved for an order striking Plaintiffs' "Motion for an Order to Show Cause Why the Department of Interior, Interior Secretary Gale Norton, Her Senior Managers and Counsel, Should Not Be Held in Civil and Criminal Contempt for Violating Court Orders, Including the Temporary Restraining Order and Preliminary Injunction Entered to Protect Trust Data and Assets" (January 13, 2004) ("Motion to Show Cause") as it pertains to government officials and employees in their individual capacity, and Plaintiffs' motions to treat as conceded Plaintiffs' motion to show cause ("Motions to Treat as Conceded") in its entirety. Plaintiffs' Motion to Withdraw, Defendants request that the Court, in turn, permit them to withdraw their Motion to Strike and Request for Protective Order. Plaintiffs' counsel have authorized Defendants to represent that they consent to this motion.
