Do You Need a Dredge or Fill Permit in Nebraska?

Planning to put dirt or other materials in a wetland, creek, or swampy area?

STOP! You may need a permit.

What Permit?

Section 404 of the Clean Water Act requires that anyone placing dredged or fill material into waters of the United States, including wetlands, must first obtain a permit from the U.S. Army Corps of Engineers.

What are Waters of the U.S.?

Waters of the U.S. are all waters that are or can be used in interstate commerce and may include lakes, streams, rivers, and wetlands.





Why Protect Streams and Rivers?

Our waterways provide water for:

- drinking, bathing, cooking, and cleaning
- crops and livestock
- recreational/tourist activities like fishing, canoeing, and birdwatching
- · fish and wildlife



What is a Wetland?

Wetlands are areas that are flooded or ponded for varying periods of time. Wetlands are defined by amount of water and time water is present, geographical location, and soil and vegetation types.

A large percentage of wetlands in Nebraska have been drained, filled and converted for agricultural production and urban development.

Some areas of Nebraska have lost as much as 90 percent of their wetlands. It is sometimes impossible to replace a wetland.

Why Protect Wetlands?

Wetlands act:

- like sponges to soak up floodwater, thereby reducing flood damage and bank erosion
- like kidneys that filter out sediment and pollutants to improve water quality
- as food for grazing livestock and animals
- as natural playgrounds for hiking, fishing, bird watching, hunting, and photography
- as homes for fish, amphibians, and other wildlife, especially many threatened and endangered species

The 404 program is jointly administered by the U.S. Army Corps of Engineers (Corps) and the U.S. Environmental Protection Agency (EPA). In partnership with other federal and state agencies, EPA and the Corps work together to protect our waters and wetlands in Nebraska.

If You Plan To:

- · Put fill into a stream or wetland
- Dam a stream
- · Move a stream or wetland
- · Remove material from a stream or wetland
- Construct fills or levees in floodplains
- Level or put fill into a wet spot in a field
