CURRENT HUMANITARIAN SITUATION

Security

- On August 1, riots broke out in Khartoum and parts of Southern Sudan following the announcement of the death of Sudanese Vice President Dr. John Garang in a helicopter crash. Following the incident, the Government of Sudan (GOS) imposed a curfew in Khartoum State from 1800 to 0600 hours—adjusted to 2300 to 0600 hours on August 3. According to the USAID Disaster Assistance Response Team (USAID/DART), sporadic violence continued August 2 and 3 in Khartoum but had subsided by August 4. The unrest resulted in the suspension of humanitarian coordination meetings with U.N. agencies in Khartoum.
- On August 4, the U.N. Department of Safety and Security (UNDSS) reported that the security situation in Darfur is currently calm but warned of the potential of spontaneous unrest. Due to continued banditry, UNDSS restricted road travel in West Darfur between Geneina and Habilah and recommended routing travel through Mornei.
- Following a July 24 attack on Shangil Tobayi IDP camp in North Darfur, Médecins Sans Frontières (MSF) temporarily evacuated staff from the site. According to MSF, a group of armed men in GOS military uniforms entered the camp, opened fire and burned shelters. Gunfire and grenade explosions lasted for approximately one hour, resulting in 5 fatalities, 14 people injured, and 50 houses burned. The USAID/DART reported that MSF resumed relief activities in the camp on July 31.

Logistics

• Unrest in Khartoum has limited the transport of relief supplies and personnel between Khartoum and Darfur. The USAID/DART reported that on August 2, WFP canceled flights into Khartoum with arrival times after curfew in order to prevent passengers and crew from traveling during curfew. On August 3, CARE reported that unrest had disrupted plans for surface transport from Khartoum to Darfur. CARE suspended loading activity after violence erupted in the vicinity of a loading facility near Sorba—10 km south of Khartoum—and will not resume loading until the security situation improves.

Access

• The USAID/DART reported on August 4 that joint patrols of GOS police and African Union (AU) civilian police remain suspended in Kalma camp in South Darfur despite continued

- discussions with sheiks and IDPs aimed at alleviating concerns about GOS police presence inside the camp. Non-governmental organizations (NGOs) report increasing difficulty and harassment when accessing the camp. The USAID/DART received reports from NGOs that identification cards issued by the GOS Humanitarian Aid Commission (HAC) were not sufficient to enter the camp and that NGO staff were asked to provide additional documentation, including travel documents and original vehicle registration papers.
- According to WFP, the Sudan Liberation Movement/Army (SLM/A) continues to deny access
 to the Sudanese Red Crescent (SRC) and other national NGOs to Zam Zam IDP camp in North
 Darfur. In response, WFP deployed a mobile team to complete food distributions to more than
 31,000 beneficiaries in Zam Zam. WFP reported that all non-essential activities have ceased
 and currently only food, water and health activities continue with the support of international
 NGOs, WFP and the U.N. Children's Fund (UNICEF).

Food Distribution

• The USAID/DART reported that general food distributions began on August 2 in Kalma camp and are expected to continue for approximately 10 days. Due to continuing challenges to the reregistration of IDPs in the camp, food distributions in Kalma were suspended in July. World Vision and the WFP continued discussions with IDPs and sheiks regarding the need for an accurate headcount of camp residents to ensure adequate relief assistance.

Locusts

• The U.N. Food and Agriculture Organization (FAO) warned of the risk of a locust outbreak in eastern Chad and Darfur if locusts present in Chad mature and lay eggs. FAO reported that favorable ecological conditions during July allowed hatching to occur in eastern Chad and breeding to continue in West and North Darfur. If current trends continue, small swarms may form in August and September. Poor road conditions and insecurity continue to obstruct monitoring and control activities in Chad and Darfur. In July, ground control teams treated approximately 1,320 hectares (ha) in Chad, 1,675 ha in West Darfur, and 51 ha in North Darfur. Similar operations will commence shortly in accessible areas of South Darfur.

Protection

• On July 29, the Office of the U.N. High Commissioner for Human Rights (OHCHR) released a report titled "Access to Justice for Victims of Sexual Violence." Between August 2004 and June 2005, U.N. human rights officers monitored and followed up on 86 incidents of rape, attempted rape, and physical assault involving a total of 230 victims in Darfur. The victims ranged in age from 5 to 60 years old and included women, girls and boys. According to the report, harassment and intimidation of victims by authorities, as well as humiliating reporting procedures at police stations often deterred victims from reporting incidents of sexual violence. The OHCHR urged the GOS to take concrete action to prevent further sexual violence in Sudan, including strengthening the judicial mechanisms to ensure thorough and impartial investigation and prosecution of incidents.

Health

• In an effort to implement effective prevention and response measures for cholera and other water-borne diseases, the West Darfur State Ministry of Health (MoH) and GOS Office of Water and Environmental Sanitation (WES) established the Health-WES Task Force (HWTF) in cooperation with UNICEF, the U.N. World Health Organization (WHO), and NGOs operating in West Darfur. The HWTF selected 12 IDP settlements in West Darfur considered most vulnerable to an outbreak and assigned focal agencies for health and WES to each site. The Task Force plans to establish a cholera and water-borne disease committee at each site that will be responsible for planning and implementing information and education campaigns in the camps.
