This bibliographic resources guide is the fourth in a series of pieces on partnership and institutional capacity building undertaken under the Global Partnership Initiative in spring/summer 2000. It serves as a companion piece to three papers:

- Partnership Conceptual Issues working paper circulated to CARE staff on May 29<sup>th</sup>;
- Promising Practices – A Case Study Review of Partnership Lessons and Issues circulated to CARE staff and external readers on June 30<sup>th</sup>; and
- Partnership Lessons: a Summary, to be circulated in October or November.

Information on partnering and capacity building is being generated at a rapid rate. Many organizations are looking at these issues and generating reports and papers. Some of these, we were able to collect. Others proved more difficult to identify and locate. This guide is a compilation of resources on partnering and capacity building collected from specialists in the field located at INGOs, LNGOs, universities, consulting firms, foundations, and bi- and multi-lateral donor organizations. It is an attempt to compile a wide variety of resources related to partnering and capacity building that we hope will be of use to CARE staff.

The document is divided into six sections—books/chapters in books; journals/periodicals; reports/working papers/case studies; conference papers and proceedings, miscellaneous articles; and web sites. Within each section the documents are listed alphabetically by author. To facilitate searching for documents from the list, we have developed eight categories:

- CB – Capacity Building
- CF – Conceptual Framework
- CS – Case Study
- DON – Donor
- ORG – Organizational
- POL – Policy
- PART – Participation
- PSHIP – Partnership

The categories are listed in brackets at the end of each entry. As many of the documents address more than one issue, most have several categories listed. For example, the following entry addresses capacity building, civil society, and partnership issues and as such all three are listed in brackets.
