All interested parties will have a chance to comment on the proposed rule, and USAID will consider those comments before finalizing our marking policy and changing our language in funding agreements.

To protect the integrity of this rulemaking process, USAID employees should not engage in a direct dialogue with implementing partners, but rather encourage interested parties to follow the instructions set forth in the Federal Register.

We are also proceeding to review and revise the current, internal USAID marking policy set forth at ADS 320. Stay tuned for an announcement concerning revisions to ADS 320.

In addition, we are finalizing our Agency Graphic Standards Manual. It will be available on our external Website before the end of the year, and in print by early next year. In the meantime, USAID employees and contractors should use the new Standard Graphic Identity on all new USAID public communications.
