### Why start an ethics program?

- National, local, and international scandals hurting public confidence in nonprofit organizations.
- Increased scrutiny from the media.
- Growth in the number of nonprofits.
- A public growing distrustful and confused about who to support.
- Gaps between expectations and performance.

Eighty-six percent (86%) of respondents indicated that a charity having a "seal of approval for ethical standards and accountability given by a reputable association of Maryland nonprofits" would be important to them in making giving decisions.

- Board Development (39%)
- Employee
   Orientation (39%)
- Internal Review of Legal, Regulatory Requirements (36%)

#### **Benefits of Certification**

- Recognition of accountability and honesty
- Symbol of trust for donors
- Safeguard against improper behavior
- Affirmation of good work
- Method of self-improvement (ie., in challenging areas, such program evaluation, planning, financial issues, fundraising
- Measures for appropriate behavior
- Framework for a sustainable organization



#### National Evaluation of the Standards for Excellence

- Based on logic model approach
- Pre-post test surveying
- Site Visits
- Quarterly data collection

#### **Early Evaluation Results**

- The Standards for Excellence Program is replicable, both as it exists and in amended formats.
  - –Few modifications to the code are requested and incorporated by partners
- The current model of replication is more resource intensive and slower than anticipated.
- The process of replicating the program is strengthening the participating replication partners
