## **Dominican Republic**

# 1. Highlights

- Planned, organized, and developed the "Diplomado en Epidemiologia Aplicada" (DDM) course in collaboration with the MOH and the Universidad Catolica.
- Selected thirty provincial and central epidemiologists to attend the first DDM course scheduled to begin in early April 2002.

# 2. IR2 – Increased Availability of Epidemiologists in the Region and Training of Other Level Health Workers by these Epidemiologists

Indicator: Successful completion of the FETP training

**Progress**:

• 1<sup>st</sup> and 2<sup>nd</sup> FETP Cohorts are conducting outbreak investigations, analyzing surveillance data, drafting research protocols, and preparing project reports.

#### Results:

# 1<sup>st</sup> Cohort

- Completed pending projects and prepared drafts of final project reports.
- Designed research protocols.

# 2<sup>nd</sup> Cohort

- Participated in outbreak investigations.
- Cleaned and validated a series of surveillance data as well as designed databases.
- Analyzed surveillance data of priority diseases.
- Prepared presentations of primary projects to be presented at the module in Honduras. 1<sup>st</sup> and 2<sup>nd</sup> Cohorts:
  - Submitted abstracts to the Second TEPHINET International Scientific Conference to be held in Madrid, Spain, this June. Two abstracts were accepted to the conference.
  - Participated in the development of the DDM course.
  - Participated in a surveillance training workshop targeted to primary care physicians.

## Haiti: Collaboration and support activities

- Participated in a meeting between representatives of DR and Haitian MOH. The goal of the meeting was to identify possible collaborative projects.
- Haitian FETP trainees were in DR for fifteen days as part of their field training.

#### **Future Activities:**

- Field training FETP trainees to investigate priority health issues under preceptor's guidance.
- Coordinate, monitor, and evaluate work of trainees.

- Formalize the inclusion of the monitoring and evaluation of the FETP activities in the competencies of the Teaching Technical Committee with the participation of the university.
- Identify national technical coordinator and tutors for the FETP activities in the Dominican Republic.

# **FETP Outputs**

During this quarter, FETP trainees initiated and continued developing their epidemiologic proficiency by working on the following priority health problems.

#### Public Health Research

- Evaluation of the operating capacity of the National Surveillance System at the provincial levels. Analysis completed. Final report in preparation. Principal results to be presented at the meeting in Honduras, April 2002.
- Participation in the review and preparation of the document to update the National Standards of Epidemiological Surveillance.
- Elaboration of epidemiological alert and technical guide for the strengthening of surveillance of Rabies in the Dominican Republic.
- Study of factors related to the underreporting of maternal mortality and presentation of preliminary results at the TEPHINET Conference in Spain.

#### Planned Epidemiologic Investigation

- Designed protocol: Research factors related to the high lethality of toxaemia in DR.
- Designed protocol: Survey of morbidity and the use of health services by tourists visiting DR.
- Study of drug prescription in a regional primary care setting: Preparation of proposal, work plan, and design of research protocol (project of Reform of the Health System, SESPAS-PROSISA/European Union).
- Evaluation of the intervention strategy for control of dengue with the participation of the community: data analysis and writing-up report.

#### Surveillance analysis

- Collect and validate a series of surveillance data on priority diseases in the Santiago and Azua provinces. Then, design and create databases for the data for future analysis.
- Analysis of Tb surveillance and registry data in the Azua province to describe Tb epidemiological situation and to evaluate Tb program activities.
- Validation and analysis of Dengue surveillance data in Santiago.
- Analysis of maternal mortality cases to identify factors related to the maternal mortality underreporting as well as factors related to the maternal quality of care.

#### Surveillance development

- Review and update National Standards for Epidemiological Surveillance.
- Collection and analysis of relative data to the tourism in RD for development of surveillance system in tourists.

- Identified and selected a university to assist in the implementation of the DDM course.
- Negotiated with the Ministry of Health and University for training of MOH public health staff in applied epidemiology.
- Negotiated CDC-university agreements
- Planned and prepared DDM activities.
- Started training trainers for the course.
