REVISIONS TO FEDERAL OPERATING PERMITS PROGRAM FEE PAYMENT DEADLINES FOR CALIFORNIA AGRICULTURAL FACILITIES

FACT SHEET

TODAY'S ACTION

- The Environmental Protection Agency (EPA) is today issuing a direct final rule and a parallel
 proposal to revise the deadline for fee payment by agricultural facilities in California that are
 subject to the Federal Operating Permits Program under the Clean Air Act.
- Today's direct final rule extends the due date for submitting operating permit fees to EPA until May 14, 2004, for agricultural facilities that are major sources of air pollution and that are located in 35 California districts.

• This action extends the deadline for submitting operating permit fees past the deadline for the permit application and allows the applications to be considered complete even though fees will be paid at a later time. The EPA will process the applications and issue permits while the Agency computes a fee amount based on the cost of administering the permits program for these sources.

• The EPA is also publishing a separate document that will serve as the proposal in the event that adverse comments are filed on this action.

BACKGROUND

- In 1990, Congress amended the Clean Air Act to require all States to develop operating permit programs to improve compliance with Federal air regulations by issuing a single operating permit to each major pollution source.
- The EPA approved the operating permits programs of the 35 California districts mentioned above. The approval of 34 districts was challenged by several environmental and community groups in part because the districts could not issue operating permits to major agricultural sources due to California law that exempted them from regulation. The EPA entered into a settlement on this litigation and partially withdrew approval of the operating permit programs for the 34 local air districts. The EPA began administering the Federal Operating Permits Program (established in 40 CFR part 71) for the State-exempt agricultural facilities located in the 34 districts on November 14, 2002.
- Subsequently, the interim approval of the Antelope Valley AQMD program expired and EPA began administering the Federal Operating Permits Program for agricultural facilities in that district.
- Most agricultural sources subject to the Federal Operating Permits Program in California must submit their permit applications by May 14, 2003.
- The EPA believes that the Federal Operating Permit Program's standard fee, which is based on costs of permitting industrial sources, may substantially exceed the cost of permitting the simpler agricultural sources. However, EPA does not have time before May 14, 2003, to develop an appropriate cost-based fee for permitting these sources. Extending the deadline for submitting operating permit fees to EPA until May 14, 2004, will allow EPA to compute a fee based on the costs of administering the program for agricultural facilities.
