CERTIFICATE OF COMPLETION OF THE ALLENDALE SCHOOL REMOVAL ACTION PERFORMED BY THE GENERAL ELECTRIC COMPANY AT THE GE-PITTSFIELD/HOUSATONIC RIVER SITE PITTSFIELD, MASSACHUSETTS

Pursuant to Paragraph 88.b of the Consent Decree for the GE-Pittsfield/Housatonic River Site, which was lodged in the U.S. District Court for the District of Massachusetts on October 7, 1999 ("Consent Decree"), EPA hereby certifies, based upon the Final Completion Report for the Allendale School Removal Action, dated February, 2000, and Addendum to the Final Completion Report, dated May 11, 2000, that the Allendale School Removal Action, as defined in the Consent Decree, excluding Post-Removal Site Control activities, has been performed in accordance with the Consent Decree and that the Performance Standards for the Allendale School Removal Action have been achieved. The Massachusetts Department of Environmental Protection has reviewed the Final Completion Report and Addendum and concurs with EPA that the Allendale School Removal Action, as defined in the Consent Decree, excluding Post-Removal Site Control activities, has been performed in accordance with the Consent Decree and that the Performance Standards for the Allendale School Removal Action have been achieved.

This certificate constitutes the Certificate of Completion for the Allendale School Removal Action (as defined in the Consent Decree) for purposes of the Consent Decree. This Certificate of Completion shall not discharge, limit, or affect any of the General Electric Company's remaining obligations under the Consent Decree. This certification shall constitute a finding by EPA that the work performed by the General Electric Company, as described in the above-referenced completion report, was consistent with the National Contingency Plan ("NCP").
