ADEO, EPA DECLARE HEIFER HEADQUARTERS SITE 'READY FOR REUSE'

Today, the Arkansas Department of Environmental Quality (ADEQ) and the U.S. Environmental Protection Agency (EPA) issued a "ready for reuse" certificate to Heifer Project International for the Little Rock site where the global non-profit help organization is building its world headquarters.

This is the first certificate issued in Arkansas to a non-profit agency and the first to a facility involved in a Brownfield program for cleanup of commercial, industrial or agricultural property contaminated with hazardous substances.

The state of Arkansas and EPA agree that Heifer Project has successfully completed its cleanup of the property. The "ready for reuse" determination verifies that the environmental conditions on this property are protective of human health and the environment based on its current use and anticipated future use as Heifer's headquarters and global village education complex.

"Turning contaminated and underused properties back into productive, valued parts of their communities is at the heart of EPA's land revitalization programs," EPA Region 6 Administrator Richard E. Greene said. "I am pleased to join the State of Arkansas in announcing the Region's first Brownfields 'ready for reuse' site. Turning the property into the headquarters of such a prestigious world humanitarian organization is the perfect conclusion to this process and Arkansas is leading the way."

A "ready for reuse" determination provides, in a straightforward manner, specific information about contamination, work performed at the site, and the status of each real estate parcel that has been cleaned up to meet state and federal requirements.

Marcus C. Devine, Arkansas Department of Environmental Quality Director, said, "These efforts show that we can accomplish great things when key players in the non-profit community and government agencies, both state and federal, work together."

The Heifer Project is building its global headquarters east of the River Market district in Little Rock next to the Clinton Presidential Center on a 28-acre tract, including land formerly owned by the Union Pacific Railroad and companies known as Superior Forwarding and Central Transport. Heifer, with the help of contractors and ADEQ staff, completed a cleanup of hazardous waste contamination at the rail yard and trucking terminal.
