LOCATION.--Lat 34°50'51", long 78°01'21", Hydrologic Unit 03030007, 1.5 mi north of Rose Hill at Rose Hill-Magnolia Elementary School, east of U.S. Highway 117 on Secondary Road 1911. Owner: DENR (North Carolina Department of Environment and Natural Resources).

AQUIFER.--Surficial aquifer of Late Cretaceous age.

WELL CHARACTERISTICS.--Drilled observation well, depth 14 ft, diameter 4 in., screened interval from 10 to 14 ft.

INSTRUMENTATION.--Water-level recorder collecting data at 60-minute intervals. Satellite telemetry at station.

DATUM.--Land-surface datum is 86 ft above NGVD of 1929 (from topographic map). Measuring point: Top of 4 in. casing collar, 1.48 ft above land-surface datum.

REMARKS.--Well is part of areal-effects network.

PERIOD OF RECORD.--October 2000 to current year.

EXTREMES FOR PERIOD OF RECORD.--Highest water level recorded, 1.38 ft below land-surface datum, Mar. 21, 2001; lowest water level recorded occurred during period when well was dry, Sept. 1 to Sept. 30, 2002.

REVISIONS.--Revised figures of water-levels for water year 2001, superseding those published in the report for 2001 are given below.
