Dear Senator Stabenow,

As a lifelong resident of Michigan, I am very worried about our Great Lakes. With all the problems we've had recently with the Great Lakes, like zebra mussels and declining water levels, I cannot believe some people would want to drill for oil and gas in the lakes.

First, what are we doing about zebra mussels and other fish that are not native to the Great Lakes? My brother is a commercial fisherman near Traverse City, and his business is about to go under if this is not addressed right away.
