Be sure to indicate the number of copies needed for all of the activities in your organization and include the OFR requisition number (**NARA08GPO-NF00002**), the correct **Billing Address Code** (**BAC**) for your bureau/office and the appropriate **GPO jacket numbers** (see enclosed list) on your requisitions. Individual SF-1's are required for each Jacket number and its correlating Title.

Please note that GPO will make every effort to include any orders (SF-1's) received after the October 17<sup>th</sup> deadline in the original printing at rider rate pricing. However, due to the CFR production processes and schedules, orders received late may be directed to the Superintendent of Documents for fulfillment at the higher post-production sales rates.
