

Federal information collections differ from conventional subject collections in a variety of ways, and these differences produce numerous challenges when attempting to assess Federal depository collections. This presentation will discuss, step-by-step, how to assess an integrated Federal depository collection, a topic that has sparse coverage in the literature of Federal information librarianship.




Getting to the Doubletree Hotel
