Dear Mr. Utt:

The Committee on Oversight and Government Reform is conducting an investigation into various aspects of the work of government contractors in Iraq, including their role in Iraq reconstruction activities and troop support. As part of the investigation, the Committee plans to hold a hearing on Wednesday, February 7, 2007, and you have been invited to testify.

One aspect of the hearing will relate to information we have received indicating that Blackwater USA provided security services as a third-tier subcontractor under Halliburton's LOGCAP contract, which appears to contradict assertions by your company referenced in a July 14, 2006, letter from the Secretary of the Army to the Committee, that Blackwater did not perform such services. The Committee is interested in receiving information regarding the costs incurred, the amounts billed, and the payments received by the contractor or subcontractor at each tier of this arrangement.

In preparation for the Committee's February 7 hearing, we request that KBR² produce the following documents for the time period from January 1, 2003, to the present:

- 1. Contracts and subcontracts, invoices, and payment records, whether classified or unclassified, relating to business activities with the following companies or their subsidiaries or affiliated companies: (a) Blackwater³; (b) ESS Support Services Worldwide / Compass Group, PLC; or (c) Regency Hotel & Hospitality Company;
- 2. Correspondence with either the Department of Defense or any of the companies listed in (1) above, relating to subcontracts for security-related activities in Iraq;
- 3. Internal Halliburton or KBR correspondence relating to subcontracts for security-related activities in Iraq;
- 4. A list of all KBR employees or affiliated independent contractors, if any, who were involved with security-related contracts or subcontracts relating to Iraq with the following companies: (a) Blackwater; (b) ESS Support Services Worldwide / Compass Group, PLC; or (c) Regency Hotel & Hospitality Company. The list should contain for each employee or independent contractor (a) the individual's title or job description, and (b) the specific contracts or subcontracts on which the individual worked; and
- 5. For each employee or affiliated independent contractor identified in (4), above, all employment or contract agreements, payroll records, and work orders or assignment records relating to that individual.

In order to have the documents available for use at the February 7 hearing, we request that you produce the above-described documents on or before **January 26, 2007**. If you determine that you will be unable to make a complete production by this date, please contact Committee staff to discuss possible modifications to this schedule. To facilitate potential future document requests, we also request that KBR preserve all documents relating to KBR's activities in Iraq, its interactions with the companies listed in (1), above, or any of the employees identified in your response to (4), above.

In addition to this document request, we also request that you provide a briefing on all contracts and subcontracts involving any of the companies listed in (3), above. We request that you provide the briefing on or before **Monday**, **January 29**, **2007**.
