Continued funding for operating support and making enhancements is necessary to meet continuing Coast Guard missions as well as evolving Homeland Security missions and new legislative requirements. For example, recent enhancements have been made to support the Maritime Transportation Security Act (MTSA) and Security and Accountability for Every Port (SAFE Port) Act. MISLE includes two citizen centric components. The Vessel Documentation System (VDS) allows the public to order Abstracts of Title via the internet. The Coast Guard Maritime Information Exchange (CGMIX) is collection of self-service internet web sites that provide information directly to the public on USCG approved equipment, incident investigations, MARPOL reception facilities and Coast Guard vessel actions.
