USDA RURAL DEVELOPMENT AWARDS ALMOST \$5 MILLION FOR PUBLIC TV DIGITAL TELEVISION GRANTS

Funding to Assist with Digital Television Conversion in Rural Communities

WASHINGTON, Aug. 19, 2008 - Agriculture Under Secretary for Rural Development Thomas C. Dorr today announced nearly \$5 million in public television digital transition grants to fund 19 projects in 18 states.

“Public television stations are a vital link to rural communities, providing local news, emergency and educational programming,” Dorr said. “The funding announced today will ensure that rural citizens continue to receive essential public broadcasting.”

Redwood Empire Public Television, Inc. (KEET) in Eureka, Calif., has been selected to receive a \$389,000 grant to finance analog-to-digital conversion of the station’s master control facility. This will allow KEET to add high-definition programming and additional channels that will be used in distance learning, training and emergency information. KEET provides the only public television signal to California’s northern coast and the five largest indigenous tribes within the state: Karuk, Jupa, Yorok, Wiyot and Tolowa.

In Mt. Pleasant, Mich., Central Michigan University has been selected to receive \$750,000 to finance the replacement of obsolete and failing analog equipment with digital production equipment, including cameras, editing, mixing and storage equipment. The project will complete the outfitting of a satellite uplink truck into a self-contained mobile production studio.

Funding awarded through the Digital Public Television grant program also may be used for engineering and environmental studies associated with the transition to digital television. The following is a complete list of groups selected to receive grant awards. Funding of individual recipients is contingent upon their meeting the conditions of the grant agreement.
