Roadless Public Comment Meeting Set for 9 a.m., June 10th, UNC-A Owen Conference Center

The National Forests in North Carolina will hold a public comment meeting Saturday June 10th on a USDA Forest Service proposal to prohibit road construction or reconstruction in national forest roadless areas across the country. The meeting will be from 9 a.m. to noon on Saturday, June 10th, at Owen Conference Center, UNC-Asheville. Individuals will be given up to three minutes each to make statements about the proposed rule. A court reporter will record all comments. For those wishing to make statements, signup will begin at 8:30 a.m. Saturday at Owens Conference Center.

Of the 1.2 million acres of national forest land in North Carolina, approximately 144,800 acres are classified as roadless and included in the proposed nationwide road ban. Most of these NC roadless areas occur in the Pisgah and Nantahala national forests and, under local forest plan direction, are already being managed to maintain their roadless character.

The USDA Forest Service released the Proposed Roadless Area Conservation Policy and Draft Environmental Impact Statement on May 9th. The public comment period runs through July 17th. The agency is encouraging people to submit their comments in writing, but is also holding public meetings on each national forest for those who prefer to provide oral statements.

The Proposed Rule and Summary of the Draft Environmental Impact Statement, as well as a Two Volume Draft Environmental Impact Statement, are available on paper, compact disc (CD) and the Internet. Those with Internet access may obtain a copy of the summary, the DEIS, individual state maps, and additional supporting information through the Roadless Project website (*roadless.fs.fed.us*).

A limited number of copies of the Roadless Proposal and DEIS are also available at U.S. Forest Service offices in North Carolina, including the Forest Supervisor's Office at 160A Zillicoa Street, Asheville. Copies will also be available Saturday at the public comment meeting at Owen Conference Center, UNC-Asheville. The Forest Service will also have information tables set up with maps of the North Carolina roadless areas, and comment cards will be available for those who wish to submit their comments in writing.
