

# Faith-Based and Community Initiatives

President George W. Bush created offices for Faith-Based and Community Initiatives within the White House and 10 Federal agencies to leverage the essential work of faith-based and community organizations in a "determined attack on need."

President Bush established the Office of Faith-Based and Community Initiatives at the U.S. Department of Agriculture (USDA) by executive order on December 12, 2002. USDA has a long history of working with faith-based and community organizations to help those in need. For example, USDA works with faith-based and community groups to provide vital assistance through our domestic food and nutrition programs, rural development opportunities, natural resources and conservation programs, and international food aid programs.

As part of the President's Faith-Based and Community Initiative, USDA is strengthening its existing partnerships with faith-based and community organizations while creating new ones to reach even more people in need. The Initiative is ensuring that these groups are allowed to compete on an equal footing for Federal dollars, educating them on grant opportunities, and encouraging greater private support for these organizations.

### **USDA'S** FOOD AND NUTRITION SERVICE (FNS) increases food security and reduces hunger in partnership with cooperating organizations. It does this by providing children and low-income people access to food, a healthful diet, and nutrition education in a manner that supports American agriculture and inspires public confidence.

Faith-based and community groups can partner with FNS to provide assistance to those in need through a number of programs, including the Summer Food Service Program, The Emergency Food Assistance Program, the Child and Adult Care Food Program, and the Food Stamp Program. ## USDA'S FOREIGN AGRICULTURAL SERVICE (FAS) works

with a variety of cooperating sponsors, including faith-based and community groups, to provide food aid around the world. Faith-based and community organizations have a long history of partnering with FAS to provide food to hungry people, humanitarian assistance to those in need, and agricultural development support to newly emerging democracies.
