## Javits-Wagner-O'Day Program Mission and Vision

The mission of the JWOD Program is to:

Provide employment opportunities for people who are blind or have other severe disabilities in the manufacture and delivery of products and services to the Federal Government.

The vision of the JWOD program is:

The JWOD program enables all people who are blind or have other severe disabilities to achieve their maximum employment potential.

This vision will be realized when:

- Every person who is blind or severely disabled and who wants to work is provided an opportunity to be employed productively.
- Every JWOD employee earns not only the Federal minimum wage (or higher applicable state minimum wage) but also a living wage and benefits package appropriate to his or her geographic locality.
- JWOD employees are provided the training and development they need to be successful in their current positions, and ultimately achieve their maximum employment potential.
- Every JWOD employee is provided the opportunity, with or without accommodations, to advance to his or her maximum employment potential, including internal or external competitive placement or management and administrative positions.
- All JWOD products and services provide best value to Federal customers, thus earning their continued support and loyalty.

## Chairperson's Message

Wherever Federal employees are, the Javits-Wagner-O'Day (JWOD) Program is there. Everyday, from headquarters buildings in Washington, D.C. to regional offices; from stateside military installations to the theater in Iraq or Afghanistan, the Javits-Wagner-O'Day Program is helping the Federal Government fulfill its commitment to the American public.

I am extremely pleased to present to you the Annual Report of the Committee for Purchase From People Who Are Blind or Severely Disabled for Fiscal Year 2004. This past year was a shining example of how the JWOD Program is meeting its mission: providing employment opportunities for people who are blind or have other severe disabilities in the manufacture and delivery of products and services to the Federal Government.

During this past Fiscal Year, the JWOD Program provided a record 45,303 Americans who are blind or have other severe disabilities with the opportunity to work on Federal product and service contracts nationwide. This growth over last year's numbers translates into more than 3,000 additional employment opportunities in local communities for a population that continues to experience an exceptionally high unemployment rate. In sharp contrast to the national unemployment rate of 5 percent, nearly 70 percent of people with disabilities are not employed. As the single largest source of employment for people who are blind or have other severe disabilities, the JWOD Program strives to help alleviate this inequity.

In addition to providing a record number of jobs, the JWOD Program reported a significant increase in the wages earned by JWOD employees, totaling more than \$325 million, and delivering an average hourly wage of \$8.98. The skills, experience and wages earned on JWOD work can enable employees with disabilities to move into employment opportunities outside the JWOD Program.

But the JWOD Program's positive effect extends far beyond the more than 45,000 individuals with severe disabilities it employs. JWOD employment helps thousands of families as it allows many people with severe disabilities to earn a living, purchase homes, and educate their children. Many of the more than 600 nonprofit agencies participating in the JWOD Program are able to provide more comprehensive services to individuals and their communities. Military and civilian customers rely on products and services provided by the JWOD Program to meet their critical missions. And, internationally, people in need rely on JWOD products included as part of U.S. relief programs.

Most notably, the JWOD Program is able to achieve this level of impact at a modest investment. Although we continue to experience growth in sales, job creation and wages paid to employees, JWOD Program sales to the Federal Government account for less than one percent of all Federal procurement dollars spent.

Looking toward the future, the Committee is excited to begin the implementation of its Strategic Plan for Fiscal Years 2005-2007. We believe that the members of the JWOD Program have laid a strong foundation during Fiscal Year 2004 that will enable it to expand the number of innovative, valuable jobs it provides for people with severe disabilities. Through increased collaboration between National Industries for the Blind (NIB) and NISH (serving people with a range of severe disabilities), the Committee, and the JWOD Program's Federal customers, we hope that increases in employment and

wages paid to people who are blind or have other severe disabilities through the JWOD Program in Fiscal Year 2005 exceed those reported herein.

Located at the end of this report is a listing by state of the community-based nonprofit agencies that currently employ people with severe disabilities under the JWOD Program. Members of Congress and their staff are invited to contact the Committee staff to make arrangements to visit with them and see their capabilities firsthand while in your local offices.

# **About the Committee for Purchase From People Who Are Blind or Severely Disabled**

The Committee for Purchase From People Who Are Blind or Severely Disabled is responsible for administering the Javits-Wagner-O'Day (JWOD) Program. In accordance with the legislative history of the JWOD Act (41 U.S.C. 46-48c), the Committee's mission is to provide employment opportunities for people who are blind or have other severe disabilities in the manufacture and delivery of products and services to the Federal Government. The Committee's primary means of achieving this objective is to direct the Government to procure products and services provided by nonprofit agencies employing such persons nationwide.

The Committee is comprised of 15 members appointed by the President, 11 of whom represent Governmental agencies (Departments of Agriculture, Air Force, Army, Commerce, Defense, Education, Justice, Labor, Navy and Veterans Affairs, and the General Services Administration). The remaining four members are private citizens knowledgeable about the employment problems of people who are blind or have other severe disabilities, including those employed by nonprofit agencies affiliated with the JWOD Program. Among its responsibilities, the Committee:

- Determines which products and services purchased by the Federal Government will be added to the Program Procurement List for provision from JWOD-participating nonprofit agencies;
- Establishes the fair market prices for these products and services, and revises the prices when appropriate;
- Ensures that nonprofit agencies comply with Committee rules and regulations (through on-site reviews of agency operations, annual certifications and other means); and

• Assists entities of the Federal Government in expanding their JWOD procurement.

The Committee has a fulltime staff located in Arlington, Virginia. The staff reviews proposed products and services to ensure that the Committee has adequate data to determine their suitability for addition to the Procurement List. Information compiled by the staff is submitted to Committee members for consideration in deciding whether to add the products and services to the Procurement List. Other responsibilities of the Committee staff include:

- Communicating to Federal customers the benefits of purchasing JWOD Program products and services;
- Identifying and researching issues of interest to the JWOD Program for review and discussion by the Committee;
- Reviewing and analyzing recommended fair market prices for current and proposed JWOD Program products and services;
- Assisting nonprofit agencies in complying with Committee rules and regulations and those of other Federal agencies; and
- Implementing technology infrastructures to facilitate communication and rapid access to information electronically among Committee members, Committee staff, Central Nonprofit Agencies, Nonprofit Agencies, and Federal customers.

Through its two designated Central Nonprofit Agencies, National Industries for the Blind and NISH (serving people with a range of disabilities), the Committee currently works with over 600 nonprofit agencies across the country, as well as in Puerto Rico and Guam. Federal customers' purchases of JWOD products and services provided by these participating agencies, and the people who are blind or have other severe disabilities they employ, help battle the high unemployment rate faced by this untapped labor resource, 70 percent of whom are not employed.

#### **About National Industries for the Blind and NISH**

The JWOD Act directs the Committee to designate "a central nonprofit agency or agencies to facilitate the distribution" of Government orders of Procurement List products and services among nonprofit agencies employing people who are blind or have other severe disabilities. The Committee has designated National Industries for the Blind (NIB) and NISH serving people with a range of disabilities) as the national nonprofit organizations that perform his and other functions that assist nonprofit agencies to participate n the JWOD Program.

NIB and NISH work closely with contracting activities and nonprofit agencies to match Government requirements with nonprofit agency capabilities. Each of the 627 community-based nonprofit agencies participating in the JWOD Program at the end of FY 2004 is associated with either NIB or NISH. Major functions carried out by NIB and NISH include:

- Allocating Government orders for JWOD items among nonprofit agencies.
- Assisting nonprofit agencies to develop new JWOD items for the Committee's consideration; calculate proposed JWOD contract prices; address production/service provision concerns; and comply with Committee regulations.
- Evaluating Federal customer needs and nonprofit agencies' capabilities to provide specific products and services, and facilitating distribution channels.
- Obtaining item procurement histories from Federal contracting activities and other information required by the Committee.

NIB and NISH also provide their associated agencies with many other services, including: legislative and regulatory assistance; communications and public relations materials; information technology support; engineering, financial and technical assistance; and, professional training programs.

NIB is headquartered in Alexandria, Virginia. In FY 2004, 74 NIB-affiliated agencies participated in the JWOD Program. NISH is headquartered in Vienna, Virginia, with regional offices in California, Washington, Georgia, Virginia, Texas and Illinois. In FY 2004, 553 nonprofit agencies participating in the JWOD Program were affiliated with NISH.

## JWOD Program Strategic Plan 2005-2007

One of the Committee's main accomplishments during FY 2004 was the completion of the strategic planning process it began in late FY 2003. This plan will shape the future direction of the Javits-Wagner-O'Day (JWOD) Program as it seeks to increase the benefits it generates for people who are blind or have other severe disabilities, and Federal customers.

#### Scope

The scope of this strategic plan is the JWOD Program, rather than any single organizational entity. The plan addresses the mission, vision, and goals for the Program for the next three to five years. The plan was developed and approved by the Committee, with input from the Committee staff, National Industries for the Blind (NIB) and NISH leadership, and the leadership of the National Association for Employment of People who are Blind (NAEPB) and the National Council of Work Centers (NCWC). Each organization affiliated with the JWOD Program should have its own strategic plan that is aligned with this plan, and that shows how the organization supports achievement of the JWOD Program goals.

This overview presents the goals, objectives and key performance measures for the JWOD Program. The complete version of the JWOD Program Strategic Plan, as well as this overview, can be viewed on the Committee's Web site at www.jwod.gov.

#### **Federal Management Context**

This strategic plan was developed in accordance with the Federal framework of:

• The Government Performance and Results Act (GPRA), which requires Federal agencies to develop strategic and annual plans, and to report performance against those plans

 The Program Assessment Rating Tool (PART), a tool developed by the Office of Management and Budget (OMB) for conducting comprehensive program assessments.
 OMB has integrated these assessments into the budget procedures, as part of implementing the Budget and Performance Integration element of the President's fivepoint Management Agenda.

Both GPRA and PART emphasize performance measures that focus on both outcomes and annual progress toward achieving long-term goals. PART emphasizes the importance of both Federal managers and program partners being held accountable for achieving measurable results. The expectation is that this strategic plan will cascade down to the organizations that implement the JWOD Program, with each organization committing to goals that align directly to achieving the results identified in this plan for the Program.

## Strategic Goals and Objectives

The JWOD Program has five high-level strategic goals for FY 2005 through FY 2007, with a number of specific objectives under each goal. Performance measures and target levels of performance for Fiscal Years 2005 through 2007 have been established for each goal and strategic objective.

## Goal 1. People Who Are Blind Or Have Other Severe Disabilities

Continue to expand employment opportunities for people who are blind or have other severe disabilities under the JWOD Program, including wage progression, benefits, upward mobility and personal job satisfaction.

## **Objective 1.a. Employment Opportunities**

Significantly increase the number of employment opportunities provided through the JWOD Program to people who are blind or have other severe disabilities.

#### **Objective 1.b.** Wages and Fringe Benefits

Provide equitable wages and fringe benefits to all employees who are blind or have other severe disabilities within the JWOD Program.

## Objective 1.c. Career Advancement and Upward Mobility

Provide career advancement and upward mobility opportunities to people who are blind or have other severe disabilities who are employed through the JWOD Program, either within or outside the JWOD Program.

#### **Objective 1.d. Employee Job Satisfaction**

Provide personally satisfying employment opportunities through the JWOD Program to people who are blind or have other severe disabilities.

#### **Objective 1.e. Fee Structure**

Ensure the JWOD fee structure incentivizes creation of employment opportunities.

#### **Goal 2. Customers**

Partner with Federal customers to increase customer satisfaction and loyalty, so the JWOD Program becomes their preferred source for products and services.

## **Objective 2.a. Customer Satisfaction**

Increase customer satisfaction with JWOD products and services. Customer satisfaction encompasses responsiveness, consistency, reliability, quality, timeliness, and price.

## Objective 2.b. Collaborative Plans

Establish collaborative plans with Federal agencies to support the JWOD Program.

#### **Goal 3. Process and Procedures**

Improve efficiency and effectiveness of the JWOD Program (the Committee, CNAs, and NPAs) by streamlining and automating processes and procedures, and improving communication, while continuing to ensure program integrity.

## Objective 3.a. Accessibility of Products and Services

Increase the accessibility of JWOD and NPA products and services to Federal customers.

#### **Objective 3.b. Socioeconomic Procurement Preference Programs**

Develop a mechanism to enable the JWOD Program and other socioeconomic procurement preference programs to cooperate in meeting their respective missions.

## **Objective 3.c. Distribution Processes**

Improve distribution processes to ensure effective, fair, and efficient distribution channels for JWOD products.

## **Objective 3.d. Processes and Information Technology**

Streamline processes and implement a technology infrastructure that facilitates collaboration, communication, and interoperability, and enables rapid flow of and access to information electronically among the Committee members, Committee staff, the CNAs, and the NPAs.

## **Goal 4. Communication and Information Sharing**

Expand support for the JWOD Program within the public, Congress, Federal agencies, the disability community, and other JWOD stakeholders through effective communication and information sharing.

#### Objective 4.a. Strategic Communications Plan

Create and implement a strategic communications plan that addresses all JWOD stakeholders.

## **Goal 5. Market Development**

Strategically develop new markets and expand existing markets in which the JWOD Program can provide best value products and services to Federal customers in order to expand employment opportunities that meet the needs of people who are blind or have other severe disabilities.

#### **Objective 5.a. Existing Markets**

Expand business in existing markets that results in the creation of employment opportunities that meet the needs of people who are blind or have other severe disabilities.

## Objective 5.b. New Products, Services, and Markets

Develop new products, services, and markets within the Federal Government that have potential to create employment opportunities that meet the needs of people who are blind or have other severe disabilities.

## **Objective 5.c. Underserved Populations**

Provide employment opportunities that meet the needs of people who are blind or severely disabled who are unemployed, underemployed, or who have not traditionally been employed in the JWOD Program.

#### **Objective 5.d. Subcontracting**

Develop policies and procedures to accommodate subcontracting portions of a project or adding a subcontract to the Procurement List.

## **JWOD Program Employment**

The broad range of employment opportunities available through the JWOD Program is as varied as the needs of the Federal customers the Program serves. The JWOD Program is a cost-effective way to help people who are blind or have other severe disabilities to achieve greater independence, as it enables many individuals to reduce dependence on Government support and join the ranks of taxpayers.

All JWOD employees are paid in accordance with Department of Labor rules, including the Fair Labor Standards Act and, where applicable, the Service Contract Act. Nonprofit agencies participating in the JWOD Program utilize adaptive technologies and extensive job training and support to help the Committee in meeting its goals of expanding employment opportunities available through the JWOD Program and of providing equitable wages, fringe benefits and career advancement to JWOD employees.

## **Expanding Business Lines to Create New Jobs**

The JWOD Program has focused on expanding its current business lines to create new, high-paying jobs for people who are blind or have other severe disabilities, and to meet the current and future needs of its Federal customers.

#### Fleet Management

Fleet management services include such functions as vehicle maintenance, operation, processing, decommissioning and disposal, and parts management. The largest JWOD contract in this area is a \$13 million Basewide Vehicle Maintenance contract being performed for the Army at Fort Lewis, Washington, by Skookum Educational Programs of Port Townsend, Washington. This contract enables 230 JWOD employees to earn an average wage of \$20.07 per hour while at work within a

**Department of Labor-approved journeyman training program.** In addition to good wages, this unique contract provides people with severe disabilities the opportunity to acquire advanced skills and become certified mechanics while maintaining approximately 3,000 vehicles for Fort Lewis. This four-year apprenticeship program provides an individual with 2,000 hours of on the job training and 144 hours of classroom training annually. JWOD employees who obtain certification will be able to use these marketable skills to obtain work in their communities outside of the JWOD Program, in either the commercial or government sectors.

## **Document Management Services**

JWOD-participating nonprofit agencies are quickly becoming leaders in the document management industry, providing such services as document conversion, file maintenance, distribution, and document destruction. These services are much in demand by Federal agencies as they seek to automate their records. Document management jobs also are also in demand by people who are blind or have other severe disabilities as they provide experience and skills essential for employment in today's technology-based economy. Contracts in this new area have created jobs for approximately 100 people who are blind or have other severe disabilities under the JWOD Program. These JWOD contracts allow JWOD employees to earn as much as \$9.50 per hour.

One of the JWOD Program's more noteworthy contracts in this area is to provide document destruction services for the **Internal Revenue Service**. This contract supports 85 IRS location sites across the western and mid-western United States and employs people with severe disabilities at 16 JWOD nonprofit agencies. The JWOD Program illustrated its capability to perform this work by learning best practices from industry experts and by leveraging the experience of two of its participating nonprofit agencies—**Northwest Center/American Data Guard of Seattle, Washington, and Opportunity Village in Las Vegas, Nevada**—already performing this work for the commercial sector.

For JWOD nonprofit agencies new to this line of business, the IRS contract also allows them to leverage their JWOD work in this area to obtain commercial contracts. This is occurring at a rapid rate—after 18 months of work on the IRS contract, **Adelante**Development Center of Albuquerque, New Mexico, now has more than 150 commercial customers and will provide employment to more than 15 individuals with severe disabilities on these contracts. TCH Enterprises of Tempe, Arizona, has more than 90 commercial contracts and provides jobs in document destruction to 25 individuals with severe disabilities.

All nonprofit agencies participating in the IRS contract are either currently certified, or are working toward certification, by the National Association for Information Destruction (NAID), the nonprofit trade association of the information destruction industry. The NAID Certification Program establishes minimum standards for employee hiring and screening, operations, the destruction process, and insurance as well as other security factors. Opportunity Village is now also certified under the Health Insurance Portability and Accountability Act, which is required for businesses seeking to destroy health-related

documents. These certifications ensure that customers are getting quality services, and that people with severe disabilities are getting hands-on job experience with industry-recognized providers.

During the 2004 fiscal year, **45,303** Americans who are blind or have other severe disabilities worked a total of **40,794,368** hours on Federal contracts obtained through the Javits-Wagner-O'Day (JWOD) Program. This represents an 8 percent increase over Fiscal Year 2003 in both the number of JWOD employees and the number of hours worked.

As a result of these employment opportunities, JWOD employees earned a total of **\$366,221,596** in wages, an increase of nearly 13 percent over Fiscal Year 2003.

These wages amount to an average hourly wage of \$8.98, which exceeds last fiscal year's average hourly wage by 4 percent, and surpasses the Federal minimum wage of \$5.15 an hour by 75 percent.

## **JWOD Program Annual Sales**

## JWOD and the Department of Defense

The JWOD Program is a critical part of the US military industrial base, providing support to the Warfighters wherever they go through the provision of necessary products and services. JWOD Program purchases by the Department of Defense (DoD) agencies (Defense, Air Force, Army, and Navy) represent 64 percent of total FY04 JWOD Program sales. In exchange for these opportunities to increase employment for people who are blind or have other severe disabilities, the JWOD Program provides DoD agencies with a wide array of services at military installations across the country and military-unique products that are used by military personnel around the world.

The JWOD Program provides numerous services to military personnel at installations across the United States as well as in Puerto Rico and Guam. Services currently provided by the JWOD Program to the military include grounds maintenance, vehicle maintenance services, call center services, commissary shelf stocking, mailroom services, and family housing maintenance. Some of the many products provided to the military by the JWOD Program include uniforms and cold weather apparel, first aid kits and bandages. Other services and products of note include:

#### Food Services at Great Lakes Naval Training Center

The military's largest food service contract is performed through the JWOD Program at the Great Lakes Naval Training Center in Great Lakes, Illinois. In Fiscal Year 2004, Goodwill Industries of Southeastern Wisconsin and Metropolitan Chicago, Inc. (Milwaukee, WI), prepared more than 9 million meals at Great Lakes, averaging 25,000 meals per day with nearly 31,000 meals per day served during peak periods. The Great Lakes contract provides employment to more than 750 JWOD employees.

## Warehousing and Distribution for the Defense Logistics Agency

Three JWOD-participating nonprofit agencies currently perform warehousing and distribution for the **Defense Logistics Agency** to provide lighting supplies, springs, insignia and uniforms to DLA customers. Over the past decade, **Industries for the Blind**, **Inc.** (**Greensboro**, **NC**), **Arizona Industries for the Blind** (**Phoenix**, **AZ**), and **Travis Association for the Blind** (**Austin**, **TX**), have been successful in reducing customer delivery time as well as cost per Material Release Order. These nonprofit agencies provide same day shipment of orders, error free, and at a reduced cost per Material Release Order through the use of a common Warehouse Management System (WMS) to control inventory and manage shipments. The WMS interfaces with DLA's computer system to share inventory and order data. The nonprofit agencies also use a radio frequency system called "Talkman" to communicate between the WMS and warehousing staff to ensure accuracy of inventory placement, order picking, and shipping information. This system relies on bar code verification, which allows individuals who are blind or visually impaired to pick orders with complete accuracy.

Joint Services Light Integrated Suit Technology (JSLIST) for the Defense Logistics Agency

The Joint Services Light Integrated Suit Technology (JSLIST) chemical protective garments shield Warfighters from biochemical weapons. During Fiscal Year 2004, four JWOD-participating nonprofit agencies produced 780,000 such garments, 86 percent of the Defense Logistic Agency's requirement. Nonprofit agencies producing this item include National Center for Employment of the Disabled (El Paso, TX), Southeastern Kentucky Rehabilitation Industries (Corbin, KY), Peckham Vocational Industries (Lansing, MI), and Group Home Foundation (Belfast, ME). Sharing the requirement between multiple nonprofit agencies has enabled the JWOD Program to meet the military's surge requirements for these mission-critical items. The JSLIST contract has also creating much-desired sewing and manufacturing jobs for 980 individuals in Kentucky, Maine, Michigan, and Texas.

Air Force Physical Training Uniform for the Defense Logistics Agency
During Fiscal Year 2004, the Defense Logistics Agency awarded a contract to seven
JWOD nonprofit agencies for the Air Force Physical Training Uniform (PTU).
The following nonprofit agencies provide DLA with 50 percent of its requirement for this
item: Association for the Blind and Visually Impaired (Rochester,
NY), Blind Industries and Services of Maryland (Baltimore, MD), El Paso
Lighthouse for the Blind (El Paso, TX), LC Industries (Louisville, KY), Lions
Services, Inc. (Charlotte, NC), New York City Industries for the Blind (Brooklyn,
NY), and Winston-Salem Industries for the Blind (Winston-Salem, SC). The
JWOD Program, drawing upon its experience in producing the Army Physical Fitness
Uniform (some of which are provided by the same nonprofit agencies performing on the
Air Force PTU contract) and industry best practices, was able to reduce production-cycle
time and increase efficiency, with the result of production of the PTU beginning in 6
months. This contract has created approximately 150 new jobs for individuals who are
blind.

#### JWOD and the General Services Administration

The General Services Administration is the JWOD Program's largest civilian agency customer and has been a valued partner in ensuring that Federal customers have access to the JWOD products and services they need. As a result of GSA's internal support for the JWOD Program, and its advocacy of the Program with its Federal customers, GSA has played an important role in increasing jobs for people who are blind or severely disabled under the JWOD Program.

#### Providing products to Federal Supply Service customers

GSA's Federal Supply Service (FSS) was the first distribution channel through which Federal customers obtained SKILCRAFT® and other JWOD products. Today, GSA's Global Supply remains one of the largest distributors of JWOD products to Federal customers worldwide. And, for those Federal customers who wish to obtain their JWOD products through the commercial marketplace, the GSA Schedules program enables them to do so from more than 300 small and large businesses. The JWOD

Program supports FSS in their efforts to meet the needs of its Federal customers with a wide variety of product lines, including: writing instruments; office supplies; business cards and other customized products; janitorial and cleaning supplies; mattresses and bedding; and, safety and personal care products. In total, FSS provides Federal customers with access to more than 3,000 JWOD products through its various supply chains. As a result of FSS's strong support, the JWOD Program provided Federal customers with nearly \$126 million in products during FY04.

Providing Building Support Services to Public Buildings Service Customers
The JWOD Program is also proud to support GSA's Public Buildings Service (PBS) in meeting its mission of providing a superior workplace for the federal worker and superior value to the American taxpayer. The JWOD Program currently provides PBS customers with janitorial and custodial services, grounds maintenance, mailroom services, central facility maintenance, administrative services, and mechanical maintenance at Federal buildings and offices nationwide. During FY04, the JWOD Program provided more than \$142 million in building maintenance-related services to Federal employees nationwide through PBS contracts. Under a collaborative agreement, the JWOD Program works closely with PBS to ensure customer satisfaction as well as to increase the number and diversity of employment opportunities for people who are blind or severely disabled. The collaborative agreement between PBS and the JWOD Program also recognizes PBS's responsibilities in achieving its other socioeconomic goals, and will not adversely impact small business.

In FY 2004, the JWOD Program provided \$2,048,326,986 in products and services to the Federal Government. Products were valued at \$1,016,665,420 and services at \$1,031,661,567. While the JWOD Program continued to experience growth in sales, job creation and wages paid to employees, JWOD Program sales to the Federal Government accounted for less than one percent of all Federal procurement dollars spent in FY 2003.

#### JWOD Nationwide Results

One of the unique assets the Javits-Wagner-O'Day (JWOD) Program brings to its Federal customers is a national network of nonprofit providers.

This national presence provides the JWOD Program with the ability to meet Federal customers' on-site needs anywhere in the continental United States, plus Puerto Rico and Guam. While many Federal agencies already turn to the JWOD Program to handle site-specific requirements across the nation, some agencies are now also leveraging the benefits of contracting with the JWOD Program to handle similar needs at multiple geographic locations.

Internal Revenue Service—Mailrooms and Secure Document Destruction
One of the highlights for the JWOD Program during FY 2004 was working with the
Internal Revenue Service (IRS) to provide a National Mail Centers operation
contract. This national contract will standardize mail operations at 34 IRS offices
located across the United States, and will employ approximately 100 individuals
who are blind or have other severe disabilities. The benefits of a national contract to
the IRS include standardized processes, minimized administrative costs, consistent
quality, and access to aggregated cost and usage data.

ServiceSource, Inc., a JWOD–participating nonprofit agency located in Alexandria, Virginia, acts as the prime contractor to the IRS, and oversees contract operations being carried out by 35 additional JWOD-participating nonprofit agencies located in 24 states. ServiceSource also operates its own Central Mail Facility, an 11,000-sq. ft. building where the IRS's incoming mail is examined by x-ray, sorted and sent to the satellite offices for distribution. The 27 on-site JWOD employees are also trained to detect hazardous substances. Through automated systems connecting the various JWOD nonprofits working on the contract, ServiceSource can provide the IRS with detailed information and cost saving suggestions.

The IRS also partnered with the JWOD Program to provide secure document destruction services at 85 IRS locations across the western and Midwestern United States. For more information about this contract, see page 8 of this report.

Air Force—Telephone Switchboard Operation National Industries for the Blind (NIB) holds a prime contract with the Air Force's Air Mobility Command to provide Telephone Switchboard Operation services at 12 locations, including Scott Air Force Base, Illinois; Travis Air Force Base, California; and Andrews Air Force Base, Maryland. These locations require telephone switchboard operations services 24 hours per day, 7 days per week. To meet this need, NIB subcontracts to 12 JWOD-participating agencies which employ more than 100 people who are blind or have other severe disabilities on this contract. This consolidated contract saves Air Force personnel time and administrative costs, and provides Air Force personnel and their families with consistent, quality service.

JWOD employees from the **Oklahoma League for the Blind** working at **Tinker Air Force Base, Oklahoma**, also play a key role in the "Heart-to-Heart" program, a Department of Defense effort to keep up the morale of deployed personnel. By calling Tinker Air Force Base, deployed personnel anywhere in the world can be patched through anytime, day or night, to a friend or loved one in the United States. And, also through Heart-to-Heart, family members in the United States are able to call their deployed relatives once a week. JWOD employees manage all of the switchboard services for this program, which positively benefits Americans across the country and around the world.
