- Vic Harwood is now working in Malheur County for Lifeways and providing services in Malheur, Morrow, Umatilla, Union, Wallowa and Wheeler counties.
- Thad Labhart is working for Harney Behavioral Health and providing services in Grant, Harney and Lake counties.
- Proposed expansion of GEAR program in Powder River, Snake River and Columbia River Correctional facilities. The Department of Corrections plans to add gambling questions to their central intake document.
- Jeff reviewed media stories on gambling from the last two months and reviewed proposed legislation this session. Few pieces of gambling legislation passed and most appear dead. One that has momentum is HB2671 which increases VLT terminals at race meet premises to 30.
- The casino planned for the Columbia Gorge has been delayed due to requirement that land be part of Warm Springs tribal land.

Manager's Update

Budget

The budget is looking good – the DHS "reshoot" indicates 9.3 m for problem gambling services. We reviewed the concepts discussed and supported by the advisory committee to utilize additional funds:

- Increase reimbursement rate to match MH rates, 7-8% increase.
- Increase flex funds by 30%
- Increase funding for Corrections GEAR program to expand into male prisons
- Double capacity for the crisis/respite program
- Increase frequency of quality improvement reports
- Increase funding for workforce development possibly outsource
- Expand treatment options to include inpatient care

Allotments are based on standardized projections; counties can request a change after we have a final budget and adjustments can be implemented.

OMHAS Problem Gambling unit plans to add additional staff this biennium, 2.0 new FTE. One new staff will focus on improved treatment oversight and on-site technical assistance and another new staff will focus on public health activities including prevention and improved collaboration with stakeholders.
